

## **Children and Young People's Strategic Partnership – Agreed Action and Key Messages**

### **Key Messages**

#### Children and Young People Voice Sub Group – Annual Updates

Consideration was given to a report by Clive Yates (Lincolnshire County Council), which provided the Partnership with an introduction to the update session aimed at celebrating and recognising the work programmes, activities and future plans of the Children and Young People Voice (CYPV) sub group.

The formal meeting was adjourned to enable Partnership Members to interact with representatives from the following groups: -

- Action for Young Carers;
- Lincolnshire Young Farmers;
- Lincolnshire Youth Cabinet;
- Voices for Choices (the Looked After Children Council).

#### National Citizen Service Lincolnshire Pilot 2011

Consideration was given to a report and presentation by Sarah Hastings and Elaine Lilley (of the Education Business Partnership), which provided the Partnership and CYPV with information on the opportunities that would be available to young people, adults and organisations in Lincolnshire, during Summer 2011, through the National Citizen Service.

#### Proposal for Children Services – Core Officer

Consideration was given to a report and presentation by Debbie Barnes (Lincolnshire County Council), which provided the Partnership and CYPV with an opportunity to be consulted and provide feedback on proposals relating to the children's services core offer.

Concerns were raised by the CYPV over the proposed changes to the transport provision for post-16 travel. Members were informed that transport for post-16 learners was not a statutory duty for the Council and this proposal was currently out for consultation.
