#### Update from the Lincolnshire Police

### <u>Take Over Day – 11 November 2011</u>

#### Children with Disabilities Strategy and Transitions DVD

The Partnership was also shown a Transition DVD which was created by the Shadow Transition Board, highlighting issues of the transition for young people with disabilities in Lincolnshire.
