Children's Centre Payment by Results Trial National Measures

This document sets out the **national measures** for the Children's Centre Payment by Results (PbR) trial. **Annex A** sets out the **definitions** of words and terms used within the measures.

Section 1 summarises data collection requirements for trial LAs in April 2012.

Section 2 sets out in detail the specific data requirements for each measure.

Data collection process:

In the **week commencing 9th April** we will send a **data collection template** to all trial areas with a **handbook** explaining how to complete the document. The template will be pre-populated with the details of children's centres in the local authority area.

The data collection template will need to be **returned to the department by Friday 4th May**. There will be a support desk function available should local colleagues have any problems completing and returning the template.

The purpose of collecting data from trial areas in April 2012 is to gather baseline data for new measures – sustained contact, parenting and early education for disadvantaged two and three year olds. We do not require any data from local authorities (LAs) on the breastfeeding prevalence or the Early Years Foundation Stage Profile measures.

We are aware that not all trial areas will be in a position to provide baseline data for the sustained contact and parenting measures as centres may not have collected this data in the past. If this is the case in your LA, you will need to use the PbR trial period to collect baseline data. We will ask for this data to be reported to the department at the end of the 2012-13 PbR trial year. Using the trial year to baseline data will provide trial areas and the department with valuable learning about the suitability of the children's centre level measures for a national scheme.

Reward payments:

In April, we will announce the size of the reward pot, how reward payments will be made and the level of performance required to attract a reward.

1) Breastfeeding Prevalence at 6 – 8 weeks

2) Reduction in EYFSP attainment gap for FSM children

	Please note – We are aware that trial areas use a range of factors to determine how funded places are managed locally and that LAs do not have access to local data on eligibility for FSM at a child or household level. We are also aware that the denominator is based on children living in the LA, but the numerator is based on take up of services in the LA area. We recognise the potential limitations of this measure but think the approach outlined here is valid for the purpose of exploring a PbR measure through the trials.

4) Sustained contact

	LAs will need to define their denominator population and provide this data to the department along with an explanation of the data source used e.g. 100 families identified in LA based on housing benefit data.
	During the course of the trials the department will work with HMRC colleagues to develop a national proxy measure for greatest need based on eligibility for free school meals.
	Please note – As with the two year old measure we know that the denominator is likely to reflect those living in the LA area and the numerator could include families who may live in another LA area taking up services. We would like to explore through the trials how we can best capture data where there are cross boarder issues.

Baseline data	As this is a new measure, we expect that trial areas will need to collect baseline data during the trial year covering the period 1 st April 2012 to 31 st March 2013.

6) Early education for disadvantaged 3 year olds

We do not currently have a way to identify the number of disadvantaged three year olds in each LA and therefore cannot provide a denominator for this measure. It may be possible in future to use HMRC data based on eligibility criteria for FSM, but this will not be available during the trials.

We would like to hear from any trial LAs that have identified a way to implement this measure, during the next round of regional learning sets.

Annex A - Definitions

This annex sets out the definitions of words used in the national measures and the descriptions of national measures set out in this document.

Contact	Family member participating in person (face to face) in children's centre services (see above). This includes activities/services delivered in the children's centre and through outreach.
