Progress of Orders Work from October 2006-

Subject: October 2010 and Considerations of Potential

Minor Amendments to Policy

Summary:

A report on the progress of Definitive Map Modification Order work since the inception of the current prioritisation policy and also including a review of the policy and consideration of potential minor amendments to policy wording.

Recommendation(s):

That the report is noted and that consideration is given to the proposed amendments to the current policy

1. Background

As Surveying Authority the County Council has a statutory duty to keep under continuous review the Definitive Rights of Way Map and Statement for Lincolnshire and to make orders to take account of events requiring the map to be modified. This is carried out by the processing of Definitive Map Modification Orders (DMMOs) which are either applied for by the public or initiated by the Authority on the discovery of evidence.

Highways & Traffic Guidance Note HAT33/2/09 sets out that such cases will be dealt with in order of receipt/initiation unless one or more of the eight "exception criteria" apply.

The criteria are as follows:

- 1. Where there is sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce.
- 2. Where there is a significant threat to the route, likely to cause a permanent obstruction (e.g. a building, but not, for example, a locked gate or residential fencing).

- 3. Where there is, or has been, a finding of maladministration by the Local Government Ombudsman on a particular case and that in processing the case the County Council will discharge its duty to the Ombudsman's decision.
- 4. Where legal proceedings against the County Council are instigated or are likely to be instigated <u>and</u> it is possible that the Authority has a liability.
- 5. Where there is a risk to children on County Council owned property and land or where the claimed route would provide for a safer alternative route to a school, play area or other amenity for children.
- 6. Where there is a significant financial saving to the County Council (and therefore taxpayers) through the processing of an Order.
- 7. Where a new application is received that relies on evidence of a case already received or, if the new application forms part of or is adjoining to an existing claim, the new claim will be dealt with at the same time as the older application.
- 8. Where the route will <u>significantly</u> assist in achieving a Countryside and Rights of Way Improvement Plan Objective or Statement of Action.

Initially the priority of a case is set by Officers however there is a right of appeal for applicants whereby a decision is made by the Definitive Map & Statement of Public Rights of Way Sub-Committee.

Appendices A, B and C to this report outline the progress that has been made over the last 4 years. It should be noted that the proposed timescales for completing cases has been affected by the long-term sickness of one of the Definitive Map Officers leading to a reallocation of their work. This reallocation is not reflected in the appendix which outlines the position from the start of the financial year.

Review of Policy

It has become apparent that it is possible that the eight exceptions might not extend wide enough across all eventualities and it is the recommendation of officers that a paragraph is inserted into the policy, worded as follows:

"The above numbered exception criteria do not cover every eventuality and it is recognised that in exceptional circumstances there may be other reasons why it would benefit the public for a case to be considered out of normal order. Officers will not prioritise any case under such circumstances and any appeal will only be considered by the Definitive Map & Statement of Public Rights of Way Sub-Committee."

It is also considered that the right of appeal ought to be widened beyond just the applicant to "any interested party". This will enable any other person such as a user

or landowner affected by the claimed route to appeal. It will also enable parish and town councils who are not applicants to appeal.

The final amendment is the removal of Appendix C of the current Policy as all existing applicants have now been made aware of the Countryside Access and Rights of Way Improvement Plan.

A draft version of the proposed altered policy is attached as Appendix D

2. Conclusion

That the proposed amendments to the existing policy will enable a more equitable scheme for appeals against the prioritisation of Definitive Map Modification Orders.

Appendix A - Schedule of Modification Order Cases Completed October 2006 to October 2010

- In total there have been a total of 59 outputs since the initiation of the current Prioritisation Policy equating to an average of 14.75 cases per annum.
- In the same time frame the council has received or initiated 32 new cases (4
 of which have since been resolved). This equates to a net decrease of 17
 cases over 4 years.
- In the previous four years to October 2006 the total number of case outputs
 was 30 whilst the number of new cases in that time frame was 74 of which 16
 have since been resolved. 44 of the new cases were claims for Byway Open
 to All Traffic (BOAT) status prior to the enactment of the Natural Environment
 & Rural Communities Act 2006 which had the effect of extinguishing any
 unrecorded motor vehicle rights.
- It would appear from these figures that the section has been twice as productive over the past four years in comparison to the previous four year period.

Appendix B - Progress of Modification Order Cases where Appeals to Prioritisation Have Been Made.

Since the inception of the current prioritisation policy the Definitive Map & Statement of Public Rights of Way Sub-Committee has heard appeals on a total of 11 cases. The following is a synopsis of the progress made on those specific cases.

1st March 2007

Horncastle - Claimed Public Footpath along Holt Lane to Banovallum Gardens

At the time of this sitting of the sub-committee this case was number 74 on the priority list. The sub-committee declined the appeal as it was felt that the case was likely to be dealt with in a short timescale

As the case had not been processed a further review of the decision was made at the sitting of the sub-committee on 30th June 2008 – see below.

<u>Mablethorpe and Sutton – Claimed Public Footpath from Queensway to King</u> George's Field

This case was number 142 on the priority list. The sub-committee allowed the appeal on the grounds that there was evidence that there was "Significant threat to the route and likely to cause a permanent obstruction with no means of resolving the problem by way of diversion".

The Statement of Reasons for this case was submitted to the Secretary of State on 27th April 2010. A public inquiry is due to be held on the 7th December 2010. The claimed route has now been obstructed by housing despite officer's advice to the developer.

4th June 2007

<u>Stamford – Claimed Public Footpath from Welland Mews to Lower Stamford</u> Meadows

This case was number 168 on the priority list. The sub-committee declined the appeal as it was felt that the submitted petition was not representative given the size of Stamford as a town.

Since this time a second appeal was made following the inclusion of the new exception criteria 8 in 2009. Officers accepted that the claimed route would have a significant impact on the implementation of the Countryside Access & Rights of Way Improvement Plan. The case is currently in its research phase prior to a decision as to whether the evidence supports the claimed route.

10th January 2010

<u>Eagle & Swinethorpe / Swinderby: Claimed Public Bridleway from Southern lane to Public Bridleway 12 (Morton Lane)</u>

This case was number 110 on the priority list. The sub-committee allowed the appeal on the grounds that there was "sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce".

Appendix B - Progress of Modification Order Cases where Appeals to Prioritisation Have Been Made.

Having conducted the relevant research the County Council felt that the evidence suggested that restricted byway rights, rather than public bridleway rights, existed. The consultation period for the subsequent order ended on 6th September 2010. The Order will be confirmed shortly.

Sleaford - Claimed Public Footpath from Millfield Terrace to Eastgate

This case had not been prioritised by officers at the time of the sitting of the subcommittee. The appeal was allowed on the grounds that there was "a risk to children on County Council owned property or where routes are likely to be used by children to provide safe access to schools, play areas or other local amenities".

Following the relevant research the County Council concluded that the submitted evidence did not show that any public right of way existed. The applicant exercised their right to appeal this decision to the Secretary of State in January 2009. The Planning Inspectorate have recently indicated that a decision on the appeal should be reached by November 2010.

30th June 2008

<u>Lea – Claimed Public Bridleway from Lea Park to new plantation off Willingham Road, (nr Gainsborough)</u>

This case was number 147 on the priority list. The sub-committee declined the appeal as it was felt that the arguments made by the appellant did not match any of the exception criteria.

Since this time a second appeal was made following the inclusion of the new exception criteria 8 in 2009. The sub-committee allowed this appeal at the sitting of 14th September 2009 on the grounds that the claimed route would have a significant impact on the implementation of the Countryside Access & Rights of Way Improvement Plan.

After conducting research and assessing the evidence the County Council made an order on 16th July 2010 with the objection period due to end on 7th October 2010. It is known that there is likely to be objections to the order however it may be possible to secure their withdrawal if a reasonable alternative route away from the adjacent properties could be negotiated.

Horncastle - Claimed Public Footpath along Holt Lane to Banovallum Gardens

See above.

The sub-committee prioritised the case on the grounds that new information suggested that there was "a risk to children on County Council owned property or where routes are likely to be used by children to provide safe access to schools, play areas or other local amenities".

The Statement of Reasons for this case has been completed and has now been passed to Legal Services Lincolnshire for final checking before submission to the Secretary of State.

Appendix B - Progress of Modification Order Cases where Appeals to Prioritisation Have Been Made.

19th January 2009

Burgh le Marsh – Claimed Public Footpath from Faulkners Lane to Orby Road.

This case was number 77 on the priority list. The sub-committee declined the appeal as it was felt that the arguments made by the appellant did not match any of the exception criteria.

No further progress has been made on this case.

<u>Dogdyke (Chapel Hill) – Claimed Public Footpath from The Crown Inn Public House</u> to the River Witham.

This case was number 94 on the priority list. The sub-committee allowed the appeal on the grounds that legal proceedings against the County Council were likely to be instigated and it is possible that the Authority has a liability.

Following the relevant investigations the County Council made an order on 1st June 2010 and, with no objections being made, the order was confirmed on 17th August 2010. The advertisement of the confirmation is currently being undertaken. At this stage objection can only be made on technical grounds.

29th June 2009

<u>Lincoln - Claimed Public Footpath from Dunkirk Road to Breedon Drive</u>

This case was number 141 on the priority list. The sub-committee declined the appeal as it was felt that the arguments made by the appellant did not match any of the exception criteria.

No further progress has been made on this case.

Mumby - Realignment of Public Footpath No. 59

This case was number 142 on the priority list. The sub-committee allowed the appeal on the grounds that legal proceedings against the County Council were likely to be instigated and it is possible that the Authority has a liability.

This case has now been allocated to an officer and the relevant investigations are being undertaken.

14th September 2009

See 30th June 2008 above

12th October 2009

Raithby & Hundleby – Claimed Byway Open to All Traffic (BOAT) & upgrade of Public Bridleway No 133 to BOAT

This case was number 155 on the priority list. The sub-committee declined the appeal as it was felt that the arguments made by the appellant did not match any of the exception criteria.

No further progress has been made on this case although it has been subject to protracted correspondence and a corporate complaint.

1. Introduction

- 1.1 As Surveying Authority the County Council has a statutory duty to keep under continuous review the Definitive Rights of Way Map and Statement for Lincolnshire and to make orders to take account of events requiring the map and/or Statement to be modified. This is carried out by the processing of Definitive Map Modification Orders (DMMOs) which are either applied for by the public or initiated by the Authority on the discovery of evidence
- 1.2 This Highways & Traffic Guidance Note indicates the processes required for the prioritisation of Definitive Map Modification Orders (DMMOs) ensuring that it is carried out within a transparent and consistently applied priority system.

2. Scope

- 2.1 This Highways & Traffic Guidance Note applies to all DMMOs, either following an application by a member of the public or initiation by Lincolnshire County Council following the discovery of evidence which may require a Modification Order to be made.
- 2.2 The revised priority system will come into force with immediate effect although officers will complete any outstanding cases currently being processed by them. These are the cases highlighted in Appendix 2.

3. Process

- 3.1 An application to modify the Definitive Map is made by a member of the public or alternatively evidence is discovered by Lincolnshire County Council which may require the making of a Modification Order.
- 3.2 The application/initiation ("the case") is dealt with on a date order of receipt basis unless it can be demonstrated that it ought to be considered at an earlier opportunity because it fulfils one or more of the following "exceptions" criteria.

- 3.2.1 Where there is sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce.
- 3.2.2 Where there is a significant threat to the route, likely to cause a <u>permanent</u> obstruction (e.g. a building, but not, for example, a locked gate or residential fencing).
- 3.2.3 Where there is, or has been, a finding of maladministration by the Local Government Ombudsman on a particular case and that in processing the case the County Council will discharge its duty to the Ombudsman's decision.
- 3.2.4 Where legal proceedings against the County Council are instigated or are likely to be instigated <u>and</u> it is possible that the Authority has a liability.
- 3.2.5 Where there is a risk to children on County Council owned property and land is where the claimed route would provide for a safer alternative route to a school, play area or other amenity for children.
- 3.2.6 Where there is a significant financial saving to the County Council (and therefore taxpayer) through the processing of an Order.
- 3.2.7 Where a new application is received that relies on evidence of a case already received or, if the new application forms part of or is adjoining to an existing claim, the new claim will be dealt with at the same time as the older application.
- 3.2.8 Where the route will <u>significantly</u> assist in achieving a Countryside and Rights of Way Improvement Plan Objective or Statement of Action.
- 3.3 The priority of the case will be set by the Principal Rights of Way Officer and/or the Senior Definitive Map Officer. The applicant will then be notified of the decision by letter. (Appendix X)
- 3.4 The applicant will be issued with a current list of outstanding cases indicating the level of priority (Appendix Y is a sample).
- 3.5 In the case of an appeal to the Authority by an applicant any interested party that their application has been prioritised incorrectly, adjudication upon any decision to re-prioritise will be made by the Definitive Map and Statement of Public Rights of Way Sub-Committee comprising of seven Councillors who are members of the Planning and Regulation Committee and who shall represent the political balance of the Council overall in terms of the Local Government and Housing Act 1989.

- 3.6 The above numbered exception criteria do not cover every eventuality and it is recognised that in exceptional circumstances there may be other reasons why it would benefit the public for a case to be considered out of normal order. Officers will not prioritise any case under such circumstances and any appeal will only be considered by the Definitive Map & Statement of Public Rights of Way Sub-Committee.
- 3.7 Once opened cases will be dealt with to completion within the constraints of staff resourcing and the legislative processes involved.

4. Review

4.1 This Priority System will require review as and when legislation regarding rights of way alters or comes into force.
