#### **Summary:**

A review of the Lincolnshire Countryside Access and Rights of Way Improvement Plan 2007-12.

#### Recommendation(s):

i) That the forum notes the contents of the report.

#### 1. Background

The Countryside and Rights of Way Act 2000 (CROW) placed a statutory duty on Highway Authorities to prepare and publish a Rights of Way Improvement Plan (ROWIP).

The first Lincolnshire Countryside Access and Rights of Way Improvement Plan was published in April 2007 and runs until 2012. The plan is a strategic document which sets out how the County Council intends to improve the management, provision and promotion of the County's public rights of way network.

The plan has been implemented under four themes, each with a strategic aim and supporting the wider social objectives of the County Council including the aims of the LTP2:

- Sustainable Transport Strategic Aim to increase the use of the network for sustainable transport and utility trips
- Health and Well-being Strategic Aim to make it easier for people to incorporate exercise into their daily lives and lead healthier lifestyles
- Rural Economy and Tourism Strategic Aim to support local businesses and tourism through access improvements
- Social Issues Strategic Aim to enable more people to enjoy walking and riding

The County Council has now started to prepare the second ROWIP. A great deal has changed since the publication of the first ROWIP and ROWIP2 will have to take account of significant changes in National policy and the current economic climate.

#### 2. Review of Statement of Action

Since the publication of the first ROWIP in 2007, we consider that we have implemented as much of the action plan as possible. Whilst it is a requirement to prepare and publish a ROWIP, there is no statutory requirement to implement the plan. Improvement works have been implemented by utilising existing internal budgets and, where possible, other external budgets have been used to translate the ROWIP in to actions on the ground.

The diverse range of statements of action has allowed us the flexibility in what we were able to deliver as it was not prescriptive, or reliant on funding for a few specific projects, instead it covered a wide range of actions which we were able to prioritise and act on when funding became available.

This section of the report explores the achievements of implementation against the ROWIP Statement of Action.

A full list of implementation works are displayed in Appendix A.

**2.1 Policy Development** – One of the main themes of the ROWIP has been the development and review of policies and this has enabled a more planned and strategic approach to be adopted in the management of the public rights of way network.

During the life of the plan 5 policies have been published;

- o Definitive Map Modification Order Priority Policy
- Public Path Order Policy
- Path Priority System Review
- Draft Enforcement Policy Manual
- Countryside Accessibility Guidance
- **2.2 Network Management -** A wide variety of improvements have been undertaken throughout the life of the plan which have mainly focussed on the existing network.

Path Infrastructure - Considerable progress has been made in the improvement of path infrastructure which has greatly improved the accessibility of the network.

- o 746 stiles provided or repaired,
- o 1378 new roadside signs,
- 1577 routes waymarked,
- o 433 gates provided or repaired,
- o 306 new bridges,

- 266 stiles replaced with kissing gates,
- o 215 stiles removed.

Figures reflect progress at 31 Dec 2011.

Vegetation Clearance - The annual programme of vegetation cutting increased steadily from years 1 to 4 to incorporate additional routes close to population centres and sections of newly promoted routes. Unfortunately the austerity measures in year 5 led to a reduction in the overall length of vegetation clearance as the frequency of cuts was reduced from three to two cuts per season.

Walking for Health Network - Strong links have continued with the Lincolnshire Walking for Health groups. The Lincolnshire Primary Care Trust provided £110,000 to enable the development of the walking for health network.

496 miles of walking for health routes were surveyed during the summer and autumn of 2008 and over 600 issues recorded. A programme of improvement works commenced in spring 2009 aimed at improving the accessibility of the health walking network. A variety of improvements have been undertaken including;

- o 52 stiles replaced with kissing gates,
- o 1km of surface improvement works undertaken,
- o 4 bridges replaced,
- o 3 bridges upgraded,
- o 2 boardwalks installed,
- Funding provided to the Boston Woods Trust to enable improved access to the Westgate Wood extension.

Surface Improvements - An extensive programme of surface improvement works has been undertaken on routes linking communities with schools, employment centres and local services and routes in the region of countryside heritage sites. A total of 5.4km of paths have been improved during the implementation period.

Road and Rail Crossings Audit - An audit over 400 busy road and rail crossings was undertaken in 2009. The road crossing locations considered to be the most hazardous were referred to the Lincolnshire Road Safety Partnership for further assessment. The remaining crossing locations affecting the A1 and the railway network were referred to the Highways Agency and Network Rail respectively for further consideration.

Unclassified County Roads (UCR) – The UCR network was identified during the ROWIP assessment as an important part of the countryside access network. An audit of 368 UCRs has been undertaken to record the condition of each green lane and identify any maintenance and enforcement issues. A final management plan is currently under preparation.

The ROWIP consultation also revealed that users often have difficulty identifying UCRs and are unsure who is able to use restricted byways. To address these issues the County Council has worked in conjunction with the Lincolnshire LAFs to produce UCR signage and restricted byway plaques to clarify the type of usage permitted on each type of route.

**2.3** Publicity and Promoted Routes - Promotion and publicity featured heavily in the first ROWIP and is considered to be the most successful area of implementation.

During the course of ROWIP implementation a wide variety of walking and cycling leaflets have been published including;

- 42 Lincolnshire Walks leaflets
- o 8 Lincolnshire Cycling leaflets
- o 4 Railway walks leaflets from Poacher Line stations
- o 6 Limewoods walks leaflets
- 2 Limewoods cycling leaflets

Walking for Health – Promotion and publicity has featured heavily during the implementation of the Health and Well Being theme. Walking and cycling information has been distributed to 18 health centres in the areas of highest health deprivation with publications also being offered to health centres in other areas of the County.

Assistance has been provided to the Boston leisure and health walks group to produce walk leaflets. In addition 6 advertisements and editorial articles have been published in various editions of the 'Lincolnshire New GP Community Health Care Magazine'.

Web based information - The Countryside Section of the Lincolnshire County Council website was redesigned in 2011. The revised microsite now contains a number of new features including a searchable walks database and interactive countryside access map.

Long Distance Trails - Support has been provided to partner organisations to enable the development of three new trails.

- The Spires and Steeple Trail is an arts and heritage trail for walkers extending from Lincoln to Sleaford.
- The Spa Trail is a multi user trail along a former disused railway from the Water Rail Way at Woodhall Spa to Horncastle.
- The Lindsey Trail is a 69 mile long distance multi user route through the Lincolnshire Wolds AONB. The trail, which will be one of the only circular long distance carriage driving routes in the country, has been funded by the County Council, East Lindsey District Council, Wolds Countryside Service, British Horse Society and the British Driving Society.

Infrastructure improvements have also been undertaken on the Macmillan Way at Boston and Surfleet and assistance has been provided in the initial development of the Save the Children Walk.

The English Coast Path - The first stretch of the English Coast Path at Weymouth Bay will open in time for the Olympic in July 2012 and progress is continuing on an additional 5 sections at Durham, Norfolk, Kent, Somerset and Cumbria.

Plans to roll out additional sections of coastal path were not included in the Government's Comprehensive Spending Review in October 2010 and it is unlikely that the Lincolnshire section of the trail will implemented in the foreseeable future.

Sustainable Transport - A number of walks have been developed which start and finish at bus routes and public transport information is now displayed on all Lincolnshire Walks leaflets. Walking details are also included in all new Lincolnshire County Council bus and train guides and Lincolnshire Walks information is displayed at selected bus stop locations. All bus stop locations are also included on the revised Countryside Access map.

*Tourism -* Improved access to the countryside can benefit tourism and the local economy. The ROWIP assessment recognised that the potential benefits to tourism from the rights of way network had not been fully exploited and that the marketing and promotion of Lincolnshire's countryside needed to be improved.

The Countryside Access Team has worked in partnership with a number of organisations including Lincolnshire Tourism to improve the promotion of the County's countryside.

15 Walking Discovery Packs have been produced as part of Lincolnshire Tourism's marketing campaign to promote Lincolnshire as a short break destination for walking and cycling. The packs have been made available to accommodation providers and distributed to tourist information centres in the East Midlands and South Yorkshire.

In addition efforts have been made to improve the maintenance and management of routes close to tourist attractions, providing additional information for tourists on the Countryside web page and encouraging new tourist attractions to include walking and cycling facilities.

Easy Access - The Countryside and Rights of Way Act requires local authorities to take into account the needs of people with visual impairment and mobility problems. It is well known that disabled people encounter a range of barriers and constraints and the Disability Discrimination Act 1995 places a duty on service providers to make 'reasonable adjustments' to the way in which services are delivered to those with a disability.

A disability access audit of all the routes included in the Lincolnshire walks series of leaflets was undertaken during undertaken years 4 and 5 of ROWIP implementation. The survey has been used to identify unnecessary stiles and barriers and improvements which would increase accessibility. All path infrastructure items are now shown on the Countryside access map which enables path users to make informed decisions about the suitability of a route whilst planning a journey.

A pack of Countryside for all routes was published in 2010 containing five routes at Bourne Woods, Chambers Farm Wood, Deeping Lakes, South Thoresby Warren and Whisby Nature Park. The leaflets provide detailed site information including

path surfaces, path gradients and cross slopes, as well as the location of seats, gates, parking and other on site facilities.

Promoting benefits to a wider range of potential users - Certain groups including people with disabilities and young people are underrepresented visitors in the countryside. Efforts have been made throughout the life of the plan to promote the use of the countryside to a wider range of potential users through various media including County News, local and national press, attendance at shows and the publication of a leaflet in association with stakeholder groups 'Walk more in Lincolnshire'.

An educational pack has also been produced in association with the Lincolnshire CC geography and outdoor education curriculum advisors. The pack entitled 'Countryside Access –getting to know your local public rights of way and beyond' has been distributed to all primary and secondary schools in the county and some youth groups.

**2.4 Community Involvement -** A full review of the Parish Partnerships Partnership (P3) scheme was undertaken in 2009 in conjunction with participating parish councils. 82% of the responding parishes considered the current scheme to be a success and offered suggestions for improvements including the publication of a P3 newsletter and the formation of community working groups.

Further amendments to the P3 scheme will be considered in 2012 as a part of the expansion of community involvement in public rights of way work. Additional developments will also include an adopt-a-leaflet scheme, the establishment of volunteer working groups and the continuation of volunteer involvement in the ease of use survey.

2.5 Access Land - The Countryside and Rights of way Act 2000 created a new right of access on foot to areas of countryside mapped as mountain, moor, heath, down and registered common land. As the access authority the County Council has worked with the affected landowners and those with an interest in land management and nature conservation issues to make sites accessible to the public.

Work has continued throughout the plan to develop the areas of designated open country. Access controls and signage were installed at Woodnook Valley, Grantham in 2009. Funds from Natural England's Access Management Grant Scheme have been utilised to produce interpretation panels and an interpretative leaflet for South and West Commons in Lincoln. The Access Land Management Plan was also reviewed during year 3 of implementation and an inspection regime introduced.

**2.6** Affect of Austerity Measures - On 13<sup>th</sup> December 2010 the Government announced that the main general revenue grant funding for Lincolnshire County

Council would be reduced by £26.7m, with a further reduction of £16.1m in the following year. The reduction equated to 18% over the two years.

The reduction in funding led to significant cuts in the PRoW and countryside access service and in particular the County Council's ability to implement the Countryside Access and Rights of Way Improvement Plan.

The following areas of ROWIP implementation were scaled back or discontinued altogether.
