Apologies for absence were received from County Councillor D C Hoyes MBE, Councillor I Colquhoun, Sandra Harrison, Alison Healey, Pete Skipworth and Irene Unsworth.

41 <u>MINUTES OF THE PREVIOUS MEETING OF THE FORUM HELD ON 21</u> JANUARY 2014

RESOLVED

That the minutes of the previous meeting of the Forum held on 21 January 2014, be agreed as a correct record and signed by the Chairman.

- 42 UPDATE ON ISSUES CONSIDERED AT THE PREVIOUS MEETING OF THE FORUM HELD ON 21 JANUARY 2014
- 43 <u>COUNTY FARMS OPPORTUNITIES TO IMPROVE ACCESS (MINUTE</u> 24)

The Chairman stated that he had spoken to John Law, a member of the South Lincolnshire Local Access Forum (SLAF) and co-ordinator of the working group set up by SLAF to examine opportunities to improve access on County Farms, and John Law had agreed to submit the working group's final report to the Mid Lincolnshire Local Access Forum, following the completion of their report. NOTED.

44 <u>LOCAL ACCESS FORUM'S NATIONAL CONFERENCE IN DURHAM</u> (MINUTE 27) (CHRIS PADLEY)

(Note: Councillor D McNally arrived in the meeting at 6.10pm)

MID-LINCOLNSHIRE LOCAL ACCESS FORUM 15 APRIL 2014

The Chairman gave a verbal report on the outcome of his attendance at the Local Access Forum's National Conference. He stated that amongst the many issues discussed was a presentation given by Network Rail on their programme of reducing the number of level crossings adding that an example was Ballast Hole, in Lincoln whose closure would cause inconvenience as it meant that the public would be required to take a diversion to another crossing further away and which was more inconvenient.

The Chairman stated that there had been a good discussion about dogs and that there was a consensus that many people did not understand animal psychology especially with regard to the presence of farm animals and dogs. The recent incident of a man being killed by a bull and the ensuing court case of an incident which had happened in South Nottinghamshire was given as example of law enforcement.

The Chairman stated that there had been a discussion about the Paths in the Community project. The Conference had noted that all the funding had been spent but concerns had been expressed about the project's limitations. Concerns had also been raised that problems had been caused by the restrictive nature of the funding from the EU and application funding process.

The Chairman referred to a recent meeting of the East Midland's LAFs Chairs, at which Natural England had made reference to the effects of reduced funding and staffing due to the reduction in public spending. Natural England had also referred to the funding of footpaths from other sources such as the Health and Wellbeing Boards which had access to funding from the NHS.

The Chairman suggested that in connection with the Health and Wellbeing Boards someone from public health should be invited to attend a meeting of the Forum to explain the role of public health. Andrew Savage stated that this was already in hand.

Comments by the Forum included attendance at a recent meeting of the Walking for Health group in Lincoln which was one of the best organised groups in the country with many Primary Care Trusts showing interest. Reference was also made to walkers in the south of the county wanting a similar event to the Wolds's Walking Festival. NOTED.

45 <u>TO CONSIDER THE WAY DISTRICT COUNCILS ARE CONSULTED ON</u> <u>RIGHTS OF WAY PLANNING MATTERS (MINUTE 28) (CHRIS PADLEY)</u>

The Chairman stated that he had spoken to Sandra Harrison (member of the Forum and also a member of East Lindsey District Council), about approaching East Lindsey District Council to see if they could speak to the Forum about strategic planning and the effect of planning applications on public footpaths. The outcome of his discussions was that no progress could be made with East Lindsey District Council. The Chairman stated that he would continue to investigate whether it was possible to involve another local authority. NOTED.

46 <u>"LOST WAYS" (MINUTE 29) (ANDREW SAVAGE)</u>

Andrew Savage stated that Sarah Bucks and Phil Wadey were unable to attend this meeting to explain "Lost Ways" and therefore this matter would have to be deferred to a future meeting of the Forum. The Forum was reminded that the presentation by Sarah and Phil had previously been circulated to members by email.

The Chairman referred to research which had been carried out in the early 1990s on Green Lanes and PROWs on the existence or otherwise of the natural environment. Funding for the research had been provided by Natural England. He stated that one of the reasons for the research was that because Lincolnshire was intensively farmed with little natural meadow and most of the natural environment existed along Green Lanes and PROWs. Although the research had been completed, a shortfall in funding had resulted in the report never being finalised and published.

Andrew Savage stated that the information collected from the research could be made available to anyone interested. NOTED.

47 <u>DENTON TO SKILLINGTON, THE DRIFT/VIKING WAY (MINUTE 32)</u> (CHRIS MILLER)

Andrew Savage read out a statement from Chris Miller, Countryside Access and Definitive Map Manager, in connection with the Denton to Skillington, The Drift/Viking Way as follows:-

"The "The Drift/Viking Way, Denton to Skillington, route had been recorded as highway maintainable at public expense although no legally defined status. A Traffic Regulation Order to prohibit motor vehicles had stopped up any motor vehicle rights that were presumed to have existed. A Definitive Map Modification Order would be required to legally define rights. The Natural Environment and Rural Communities Act 2006 would affect motor rights should they be proven to exist unless one of the relevant exception criteria applied".

A member stated that an article had appeared in "Wildlife Trust" stating that farm vehicles were prohibited from using this route except for access purposes. NOTED.

48 <u>LINCOLNSHIRE COUNTY COUNCIL PROGRESS OF DEFINITIVE MAP</u> <u>MODIFICATION ORDERS - SOUTH WILLINGHAM (MINUTE 36) (CHRIS</u> <u>MILLER)</u>

Andrew Savage read out a statement from Chris Miller stating that the County Council had taken the decision to progress the case that was outstanding at South Willingham in connection with a Definitive Map Modification Order regardless of the other three cases in the Parish that were still requiring work and that the Statement of Reasons had now been written in draft and would be submitted by Legal Service, Lincolnshire to the Planning Inspectorate in due course. NOTED.

49 <u>NORTH EAST LINCS COUNTRYSIDE ACCESS AND RIGHTS OF WAY</u> <u>IMPROVEMENT PLAN OBJECTIVES UPDATE (NICOLA HARDY)</u>

The Forum considered a report from Nicola Hardy in connection with an update of North East Lincolnshire's Countryside Access and Rights of Way Improvement Plan Objectives.

The Chairman took the opportunity to thank North East Lincolnshire Council for the work they had made to divert Bridleway No.91 (Ashby cum Fenby) along the side of a field because of safety issues despite the landowner not agreeing to the diversion. The Order had been objected to by the landowner and would be referred to the Planning Inspectorate shortly. Any matters of compensation would therefore arise upon confirmation of the Order. NOTED.

50 <u>THE DRAFT LINCOLNSHIRE RIGHTS OF WAY IMPROVEMENT PLAN</u> 2014- 2019 (ANDREW SAVAGE)

Andrew Savage presented a report in connection with the Draft Lincolnshire Rights of Way Improvement Plan 2014-2019, which was a legal requirement under Section 60 of the Countryside and Rights of Way Act 2000. He stated that Local Access Forums were required to provide input into the production of the Plans and the comments of the Forum were sought on the Plan.

Andrew Savage stated that since the publication of the first Plan a great deal had changed including significant changes in national policy, the current economic climate and the resultant reduction in the level of funding available for Public Rights of Way management.

Andrew Savage stated that there were three Themes in the Plan (Theme 1 – Network Improvement; Theme 2 – Improved Customer Service and Theme 3 – Social Inclusion).

Comments made by the Forum included:-

1. It was suggested the addition of the words "and creations" after the word "diversions" in paragraph 3, page 38, of the Plan.

2. It was suggested that the words "and convenience" after the word "safety" in paragraph 4, of the Plan.

3. It was noted that the outcome of the Planning Inquiry in connection with the Lincoln Eastern By-Pass was awaited and therefore it was too late to include any changes to the plans. The importance of pre-planning consultations to ensure access was incorporated was emphasised.

4. It was noted that Network Rail were investing a lot of money to improve access across level crossings in Lincolnshire and that this might provide an opportunity for local authorities to be more proactive in applying for funding from Network Rail to divert footpaths.

5. With regard to the paragraph in connection with Unclassified County Roads, page 42, of the Plan, it was noted that many unclassified county roads were not tarmacked and were not recorded as highways.

6. The Plan needed to include some reference to the potential of roadside verges, especially wide verges, for access purposes.

7. The need for reference to be made in the paragraph on "Planning Context" about the need for new development to provide separate and direct access for walkers and cyclists between housing areas, the local town centre and other local facilities. The differing needs for motor traffic sometimes resulted in access roads being over long and inconvenient for walking and cycling, which deterred these modes of travel.

8. The need to provide funding for signage for use by landowners to warn the public about conservation projects. It was suggested that reference should be made in the Plan to show the positive efforts made by landowners to conserve the countryside. Any signage used should set the "right tone and should be friendly".

9. The need to educate the public about dogs as there seemed to be an issue about the public's use of Right of Ways. There was also a need to educate the public about the dangers of dogs alarming animals, the potential disease dangers posed by dog faeces in the countryside.

10. The information in the Plan about the health benefits of walking and particularly the benefits of getting the public to include regular walking into their everyday lives was welcomed.

11. The "shape and tenor" of the document was welcomed.

12. An enquiry about the timetable for the approval of the Plan.

Andrew Savage thanked the Forum for their comments.

Chris Marsh stated that in connection with dogs, the County Council was able to provide Waymarks for landowners in connection with warning the public about the need to protect conservation projects and while noting the comments about the need to educate the public about control of dogs there was the issue of the proliferation of too much signage.

Andrew Savage accepted that there was perhaps a need to ensure developers were aware of access issues for new developments.

Andrew Savage explained the process of approving the Plan by the County Council, including the need for scrutiny, Executive Councillor approval and consultation with the public.

(a) That the comments made by the Forum on the Draft Lincolnshire Rights of Way Improvement Plan 2014-19, be forwarded to the Council.(b) That the Forum be informed when the final Plan is published.

56 PROPOSAL TO AUTHORISE MOTOR SPORT EVENTS ON PUBLIC ROADS (CONSULTATION PAPER FROM THE DEPARTMENT FOR CULTURE, MEDIA AND SPORT WHICH SEEKS VIEWS ON A PROPOSAL TO PERMIT MOTOR SPORTS EVENTS, INCLUDING TO STAGE RALLIES, HILL CLIMBS AND TRIALS OF SPEED, ON PUBLIC ROADS IN CERTAIN CIRCUMSTANCES (SHEILA BROOKS)

Sheila Brooks drew the Forum's attention to a consultation document issued by the Department for Culture, Media and Sport, in connection with a "Proposal to Authorise Motor Sport Events on Public Roads". She noted that the date for responses to the consultation had closed and expressed concerns about the effects of the proposals on the natural environment and PROWs.

Andrew Savage read out the County Council's response to the consultation and it was agreed that the response would be emailed to the Forum. (The response was:-"The role of the local highway authority is to approve the traffic management plan for the event, to process any traffic orders required and to work with a safety advisory group if the event triggers this action locally. Clarification is required on the

categories of "roads" as defined by the Road Traffic Act 1988 s.192 that will be affected (i.e. does the proposal extend to all forms of public highway inclusive of bridleways and footpaths?")

Comments made by the Forum included:-

1. An enquiry about the legal position.

2. The proposals were welcomed as it would attract tourism and help the local economy.

3. The event was only likely to be of a short duration and therefore any environmental impact was limited.

4. It was difficult to envisage where the speed limits would be suspended.

5. The proposals to transfer power to the local authorities were welcomed as it would be easier for the local authority to react quicker to concerns raised by local people.6. The potential for damaging the surface of soft highways should be taken into account and the cost of making good any that might occur.

7. The Forum would appreciate being given an opportunity to comment on consultations of this kind in advance of the closing date, in future.

RESOLVED

That the Chairman should draft a response to the Council, on behalf of the Forum, generally in support of the response already given by the Council, but adding the above comments and the Chairman would give Forum members an opportunity to comment on his wording before submitting it.

Summary:

A report providing a summary of the Lincolnshire Coastal Country Park Public Rights of Way Survey – February 2014.

Recommendation(s):

That the forum notes the contents of the report.

1. Background

Lincolnshire County Council is working with its partners to develop the Lincolnshire Coastal Country Park. The park is situated in an area between Sandilands and Chapel St. Leonards, covering approximately eight kilometres of coastline and 35 square kilometres of coastal hinterland.

The vision is to create a sustainable coastal environment providing high quality facilities for communities and visitors, improvements for wildlife and contributing to a healthy local economy.

The Coastal Country Park area contains an extensive network of public footpaths linking villages, nature reserves and the coastline. This network is considered essential in the development of the park and a number of improvements have already been implemented including the installation of bridges, kissing gates and over 70 timber fingerposts.

The public rights of way survey has been undertaken to provide a detailed assessment of the condition of the network and identify any potential improvements.

2. Summary

The Public Rights of Way Survey

Geographical Coverage - The coastal strip between Sandilands and Chapel Point and extending inland as far as Mumby, Hogsthorpe and Huttoft.

Routes surveyed – All public footpaths, permissive paths and unsurfaced unclassified county roads either wholly or partly within the coastal country park.

There are no public bridleways, restricted byways or byways in the coastal country park area.

Length of routes surveyed -	
Public Footpaths	64,169m
Unsurfaced Unclassified County Roads	5,397m
Permissive Footpaths	615m

Survey Method – Lincolnshire County Council undertakes an annual survey to establish the overall accessibility, or ease of use, of the definitive public rights of way network in the County.

The Ease of Use Survey aims to establish – 'The percentage of total length of public rights of way which are easy to use by members of the public.'

'Easy to use' means:

i) signposted or waymarked where the path leaves a metalled road and to the extent necessary to allow users to follow the route,
ii) free from unlawful obstructions and other interference,
iii) surface and lawful barriers (e.g. stiles, gates) in good repair and to a standard necessary to enable the public to use the way without undue inconvenience.

The survey (formerly Government Best Value Performance Indicator 178 'Ease of Use survey') has proved a useful tool in the management and improvement of Lincolnshire's public rights of way network since its introduction in 2000. The information obtained from the survey has enabled the County Council to plan work programmes, develop policies and effectively target budgets.

The 'Ease of Use' Survey methodology has been used during the Coastal Country Park public rights of way survey.





Role and Purpose of Local Access Forums


Local Access Forums (LAFs) are statutory bodies established under the Countryside and Rights of Way Act 2000. Two LAFs were established in 2003, covering Lincolnshire, North East Lincolnshire and Rutland. The Mid Lincolnshire LAF (Mid Lincs Forum) is a joint forum between Lincolnshire County Council and North East Lincolnshire Council. The South Lincolnshire and Rutland LAF (South Lincs Forum) is a joint forum between Lincolnshire County Council and Rutland County Council.

Lincolnshire County Council provides a secretariat service to both Local Access Forums.

Local Access Forums provide independent advice to the local authorities and other relevant bodies on how to make the countryside more accessible and enjoyable for open- air recreation, in ways which address social, economic and environmental interests.

The Mid Lincolnshire and South Lincolnshire and Rutland Local Access Forums provide advice on three main areas:

- □ the development of recreation and access strategies which cater for a wide range of people;

- □ the implementation, management and review of the statutory right of access to the countryside.

Membership of Local Access Forums

Each LAF consists of up to 18 members representing a wide range of interests, including rights of way users, land managers and farmers, rural business, health, heritage, nature conservation, tourism, transport, disability groups and minority groups.

Members are appointed for up to three years and the appointing authorities are required to maintain a balance of interests on each forum.

A list of members is shown in the membership section of the Annual Report.

Changes in membership and appointments

-Mid Lincs Forum

County Councillor Eran Bauer retired from the forum in May 2013 and was replaced by County Councillor Daniel McNally in June 2013.

Sandra Harrison was appointed to the forum in September 2014 to represent the interests of horse riders.

-South Lincs Forum

Barbara Smitheringale was appointed to the forum in July 2012 to represent the interests of disabled users.

-Chair Appointments

Chris Padley was re-elected as Chair of the Mid Lincs Forum and Dr. Christopher Allison was elected as the Vice-Chair at the July Annual General Meeting. County Councillor Ray Wootten was elected as Chair of the South Lincs Forum and John Williams elected as the Vice-Chair.

Review of meetings and discussions of the past year

Meeting Details

The South Lincs and Rutland LAF held 4 full meetings during the reporting period. The Mid Lincs LAF held 3 meetings (the July meeting was cancelled as the meeting would not have been quorate). Meetings have been held at the following venues:

Rights of Way Improvement Plans (RoWIP)

Lincolnshire County Council

Both forums have continued to receive updates on the implementation of the first Lincolnshire RoWIP. Improvement works have again concentrated on promoted routes, popular areas of the county and routes in the vicinity of villages and towns. Over 3km of paths have been improved during the reporting period and works have also taken place to improve the accessibility of a bridge at Saltfleet.

Progress on the development of the Second Lincolnshire RoWIP has continued throughout the year. The second ROWIP will have an increased emphasis on community involvement and partnership work as a result of the County Council's decreased capability to deliver the plan on its own.

Three broad themes have emerged for the future development of the Lincolnshire PRoW network.

Theme 1 – Network Improvements Theme 2 – Improved Customer Service Theme 3 – Social Inclusion

The process of developing the Second RoWIP has been influenced by a number of factors including significant changes in national policy, County Council priorities and the potential for a further reduction in funding in the coming years.

It is anticipated that the Second Lincolnshire Rights of Way Improvement Plan will be published in autumn 2014.

North East Lincolnshire Council

Particular focus has been given to addressing those routes that intersect with busy trafficked roads within the Borough, as highlighted as a Key Action within the North East Lincolnshire Council RoWIP. In this respect, working in partnership with the Casualty Reduction Officer for Humberside Police, legal orders have been made to divert sections of two key promoted routes, forming part of the Nev Cole Way and the Wanderlust Way, to provide a safer crossing point on the A18 Barton Street and remove the need for users to cross the Stallingborough Interchange which currently has no footway provision for pedestrians.

In addition, having reviewed current policies and procedures, officers have produced a new Enforcement Policy which has now been formally adopted. Having a more robust policy will enable officers to undertake necessary enforcement action using a consistent, well documented approach.

Rutland County Council

The first Rights of Way Improvement Plan (ROWIP) for Rutland was published in October 2007. Written to be a five year plan it was originally anticipated that a new plan (ROWIP2) would have been published by this time. However changes in national policy and unprecedented budget reductions affecting local government have both affected delivery of the first plan and delayed publication of its replacement, which is now expected by the end of 2014.

In the meantime the County Council continues to be guided by the existing plan and although Rutland County Council is no longer able to deliver some of the proposed improvements, maintenance projects are being prioritised that make the greatest contributions to the plans objectives. Forum members have been provided with regular updates on the delivery of the larger schemes, particularly when they have been part of a wider council project, such as the work financed by the Local Sustainable Transport Fund.

Motor Vehicles in the Countryside

The Mid Lincs LAF has continued to show an active interest in the use of motor vehicles in the countryside.

The Forum invited PC Nick Willey, Rural Crimes Officer, Lincolnshire Police, to discuss the issue of motor vehicles. PC Willey is the first point of contact for rural crime and is responsible for co-ordinating efforts to tackle rural issues. During the meeting the forum discussed their general concerns regarding the use of motor vehicles in the countryside in the countryside by a minority 4X4 drivers and trail riders.

Members have continued to receive regular updates of the ongoing management The Drift (Sewstern Lane). In 1986 the ancient highway was registered as a Site of Special Scientific Interest due to its rare and species rich calcareous grassland. A significant increase in the use of motor vehicles in recent years has led to a severe deterioration in the condition of the lane. The Mid Lincs LAF gave consideration to the outcome of a decision made by Lincolnshire County Council's Planning and Regulation Committee in December 2013, regarding the prohibition of motor vehicles on the section of the Drift extending from Denton to Skillington.

Access for the Disabled

The Disability sub group was established in 2012 to consider the needs of disabled users. The sub group has been working throughout the year on the development of a series of access for all leaflets aimed at disabled users and families with pushchairs. Funding for the leaflets has been provided by the Public Health Department, Lincolnshire County Council.

The sub group has now published (May 2014) a pack of 4 leaflets including routes at;

- Normanton, Rutland
- Exton, Rutand
- Willingham Woods, Nr Market Rasen

• Mareham Pastures, Sleaford

Each leaflet provides detailed information the route, including path surfaces, path gradients and cross-slopes, as well as the location of seats, gates and steps. Information regarding parking and on site facilities is also included. It is proposed to produce additional access for all leaflets in the coming year.

Access on the County Farms Estate

Lincolnshire County Council owns and manages an extensive County Farms estate of approximately 7,396 hectares. The estate is split into 150 individual estates and is concentrated mainly in the south east of the county.

The South Lincs and Rutland LAF established a working group to examine the current provision of access on the County Farms estate and the potential for creating additional routes.

The sub group found limited opportunities to provide additional access as many of the county farms are situated in remote areas of the county and are often isolated from the countryside access network. The group have so far identified one potential new at Boston connecting Boston Public Footpath No. 1 and Wyberton Road.



1. Background

The responsibility to produce a Rights of Way Improvement Plan is a statutory duty arising from the Countryside and Rights of way Act 2000. The first Lincolnshire Countryside Access & Rights of Way Improvement Plan (ROWIP) was adopted by the County Council on 3 April 2007.

The ROWIP is being implemented under four themes, each with a strategic aim and supporting the wider social objectives of the County Council including the aims of the LTP2:

- Sustainable Transport Strategic Aim to increase the use of the network for sustainable transport and utility trips
- Health and Well-being Strategic Aim to make it easier for people to incorporate exercise into their daily lives and lead healthier lifestyles
- Rural Economy and Tourism *Strategic Aim to support local businesses* and tourism through access improvements
- Social Issues Strategic Aim to enable more people to enjoy walking and riding

There is also a separate strand of Core Tasks that will assist in the management of the network and access opportunities.

The Countryside Access & Rights of Way Improvement Plan Year Action Plan is attached to this report as Appendix A.

2. Summary

Progress Report

Network Management- The highway divisions have continued to make general improvements through improved maintenance and enforcement works. In the period April 2007 to April 2014 these have included;

- 948 stiles provided or repaired,
- 1,778 new roadside signs,
- 2,092 routes waymarked,
- o 575 gates provided or repaired,
- o 390 new bridges,
- o 321 stiles replaced with kissing gates,
- 250 stiles removed.

Improvement Schemes – Work has now commenced of the 2014/15 improvement programme. Schemes have again been focussed on routes in urban areas and on the urban fringe, routes in the region of countryside heritage sites and promoted routes. This year improvement works will specifically target the Lincolnshire Coastal Country Park area.

Summary:

A report on the progress of Definitive Map Modification Order work since the inception of the current prioritisation policy (October $2006 - 20^{th}$ June 2014) and current caseloads

Recommendation(s):

That the report is noted

1. Background

As Surveying Authority the County Council has a statutory duty to keep under continuous review the Definitive Rights of Way Map and Statement for Lincolnshire and to make orders to take account of events requiring the map to be modified. This is carried out by the processing of Definitive Map Modification Orders (DMMOs) which are either applied for by the public or initiated by the Authority on the discovery of evidence.

Highways & Traffic Guidance Note HAT33/3/11 sets out that such cases will be dealt with in order of receipt/initiation unless one or more of the eight "exception criteria" apply.

The criteria are as follows:

- 1. Where there is sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce.
- 2. Where there is a significant threat to the route, likely to cause a permanent obstruction (e.g. a building, but not, for example, a locked gate or residential fencing).

- 3. Where there is, or has been, a finding of maladministration by the Local Government Ombudsman on a particular case and that in processing the case the County Council will discharge its duty to the Ombudsman's decision.
- 4. Where legal proceedings against the County Council are instigated or are likely to be instigated <u>and</u> it is possible that the Authority has a liability.
- 5. Where there is a risk to children on County Council owned property and land or where the claimed route would provide for a safer alternative route to a school, play area or other amenity for children.
- 6. Where there is a significant financial saving to the County Council (and therefore taxpayers) through the processing of an Order.
- 7. Where a new application is received that relies on evidence of a case already received or, if the new application forms part of or is adjoining to an existing claim, the new claim will be dealt with at the same time as the older application.
- 8. Where the route will <u>significantly</u> assist in achieving a Countryside and Rights of Way Improvement Plan Objective or Statement of Action.

The above numbered exception criteria do not cover every eventuality and it is recognised that in exceptional circumstances there may be other reasons why it would benefit the public for a case to be considered out of normal order. Officers will not prioritise any case under such circumstances and any appeal will only be considered by the Definitive Map & Statement of Public Rights of Way Sub-Committee.

Initially the priority of a case is set by Officers however there is a right of appeal for any affected persons whereby a decision is made by the Definitive Map & Statement of Public Rights of Way Sub-Committee.

Appendices A, B and C to this report outline the progress that has been made over since the inception of the revised Schedule of Priorities and 20th June 2014.

Since the inception of the current prioritisation policy the Definitive Map & Statement of Public Rights of Way Sub-Committee has heard appeals on a total of 12 cases. The following is a synopsis of the progress made on those specific cases.

1st March 2007

Horncastle – Claimed Public Footpath along Holt Lane to Banovallum Gardens

At the time of this sitting of the sub-committee this case was number 74 on the priority list. The sub-committee declined the appeal as it was felt that the case was likely to be dealt with in a short timescale

As the case had not been processed a further review of the decision was made at the sitting of the sub-committee on 30th June 2008 – see below.

<u>Mablethorpe and Sutton – Claimed Public Footpath from Queensway to King</u> <u>George's Field</u>

This case was number 142 on the priority list. The sub-committee allowed the appeal on the grounds that there was evidence that there was "Significant threat to the route and likely to cause a permanent obstruction with no means of resolving the problem by way of diversion ".

The Statement of Reasons for this case was submitted to the Secretary of State on 27th April 2010. The Order was **NOT CONFIRMED**

4th June 2007

<u>Stamford – Claimed Public Footpath from Welland Mews to Lower Stamford</u> Meadows

This case was number 168 on the priority list. The sub-committee declined the appeal as it was felt that the submitted petition was not representative given the size of Stamford as a town.

Since this time a second appeal was made following the inclusion of the new exception criteria 8 in 2009. Officers accepted that the claimed route would have a significant impact on the implementation of the Countryside Access & Rights of Way Improvement Plan. **NOT CONFIRMED BY SoS – Deemed to be operational railway land**

10th January 2010

Eagle & Swinethorpe / Swinderby: Claimed Public Bridleway from Southern lane to Public Bridleway 12 (Morton Lane)

This case was number 110 on the priority list. The sub-committee allowed the appeal on the grounds that there was "sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce".

Having conducted the relevant research the County Council felt that the evidence suggested that restricted byway rights, rather than public bridleway rights, existed. The order was **CONFIRMED**

<u>Sleaford – Claimed Public Footpath from Millfield Terrace to Eastgate</u>

This case had not been prioritised by officers at the time of the sitting of the subcommittee. The appeal was allowed on the grounds that there was "a risk to children on County Council owned property or where routes are likely to be used by children to provide safe access to schools, play areas or other local amenities".

Following the relevant research the County Council concluded that the submitted evidence did not show that any public right of way existed. The applicant exercised their right to appeal this decision to the Secretary of State in January 2009. the appeal was not upheld and the **ORDER WAS NOT MADE**

30th June 2008

Lea – Claimed Public Bridleway from Lea Park to new plantation off Willingham Road, (nr Gainsborough)

This case was number 147 on the priority list. The sub-committee declined the appeal as it was felt that the arguments made by the appellant did not match any of the exception criteria.

Since this time a second appeal was made following the inclusion of the new exception criteria 8 in 2009. The sub-committee allowed this appeal at the sitting of 14th September 2009 on the grounds that the claimed route would have a significant impact on the implementation of the Countryside Access & Rights of Way Improvement Plan.

After conducting research and assessing the evidence the County Council made an order on 16th July 2010. The Order was **CONFIRMED**

Horncastle – Claimed Public Footpath along Holt Lane to Banovallum Gardens

See above.

The sub-committee prioritised the case on the grounds that new information suggested that there was "a risk to children on County Council owned property or where routes are likely to be used by children to provide safe access to schools, play areas or other local amenities".

The case has been **CONFIRMED** with modifications following submission to the Secretary of State.

19th January 2009 Burgh le Marsh – Claimed Public Footpath from Faulkners Lane to Orby Road.

This case was number 77 on the priority list. The sub-committee declined the appeal as it was felt that the arguments made by the appellant did not match any of the exception criteria.

No further progress has been made on this case.

Dogdyke (Chapel Hill) – Claimed Public Footpath from The Crown Inn Public House to the River Witham.

This case was number 94 on the priority list. The sub-committee allowed the appeal on the grounds that legal proceedings against the County Council were likely to be instigated <u>and</u> it is possible that the Authority has a liability.

Following the relevant investigations the County Council made an order on 1st June 2010 and, with no objections being made, the Order was **CONFIRMED**

29th June 2009

Lincoln - Claimed Public Footpath from Dunkirk Road to Breedon Drive

This case was number 141 on the priority list. The sub-committee declined the appeal as it was felt that the arguments made by the appellant did not match any of the exception criteria.

No further progress has been made on this case.

Mumby - Realignment of Public Footpath No. 59

This case was number 142 on the priority list. The sub-committee allowed the appeal on the grounds that legal proceedings against the County Council were likely to be instigated <u>and</u> it is possible that the Authority has a liability.

Following investigation an Order was made and with objections withdrawn the Order was **CONFIRMED**.

14th September 2009

See 30th June 2008 above

12th October 2009

Raithby & Hundleby – Claimed Byway Open to All Traffic (BOAT) & upgrade of Public Bridleway No 133 to BOAT

This case was number 155 on the priority list. The sub-committee declined the appeal as it was felt that the arguments made by the appellant did not match any of the exception criteria.

No further progress has been made on this case although it has been subject to protracted correspondence and a corporate complaint. The applicant also exercised their right of appeal to the Secretary of State following the expiration of one year since the application was made. The Secretary of State felt that LCC's Schedule of Priorities was fair and declined to order that a decision be made.

4th October 2010

Caistor - Claimed Public Footpath between Buttermarket & Plough Hill

This case was number 153 on the priority list. The sub-committee allowed the appeal on the grounds that there was "sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community,

and that in processing the case early there is a strong likelihood that this will reduce".

CONFIRMED following the withdrawal of objections

5th September 2011 <u>Mablethorpe & Sutton – Claimed Public Footpath from Sandhurst Road to the</u> Promenade

The case was 129 on the priority list. The sub-committee did not allow the appeal based on the grounds that there was "sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce" also the Town Council felt that the claimed route may be useful to the fire-brigade in dealing with the regular arson attacks to the beach huts at Sandilands.

Wrangle - Claimed Byway Open to All Traffic "Cockleshell Alley"

This case was number 94 on the priority list. The sub-committee allowed the appeal on the grounds that there was "sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce".

CONFIRMED as a Public Bridleway on the strength of available evidence

3rd October 2011

Bourne – Claimed Footpath from Beaumont Drive to Bourne Woods (No.142 on the Priority List).

This case was number 142 on the priority list. The sub-committee deferred its decision pending the planning decision due to be considered by South Kesteven District Council. Having received this no further action is currently required.

Holbeach - Claimed Footpath between Langwith Gardens & Stukeley Hall Drive

This case is number 67 on the priority list. The sub-committee allowed the appeal on the grounds that there was "sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce"

The case has now been allocated to a case officer and is in progress.

16th July 2012

Sturton by Stow – Claimed Public Footpath from Bransby to Tillbridge Lane

The case is at No.124 on the priority list. The sub-committee did not allow the appeal as it did not consider that the planning permission granted for the land adjacent had an effect on the right of way

5th November 2012

<u>Utterby – Claimed Public Footpaths Grange Lane to Holywell Lane and Former</u> <u>Railway</u>

The Committee allowed the appeals for these two separate cases and were in agreement with the applicant that the routes fulfilled Criteria 8 "Where the route will significantly assist in achieving a Countryside and Rights of Way Improvement Plan Objective or Statement of Action".

The case has now been allocated to a case officer and is in progress. User interviews are complete and Orders have been made.

Colsterworth – Deletion of Public Footpath No. 14

The Committee allowed the appeal on the basis that it felt that the route was the subject of much local concern and had given rise to a number of incidents of ill-feeling in the community and had become a particular problem for the occupiers.

The case is at No.3 in the priority list and has been allocated to an officer.

8th April 2013

Heapham - Variation of Particulars contained in the Definitive Statement for PF 57

The Committee allowed the appeal on the basis that it felt that the route was the subject of much local concern and had given rise to a number of incidents of ill-feeling in the community.

The case is at No.9 in the priority list and has been allocated to an officer.

17th March 2014

<u>Skegness – Claimed Public Footpath Along Sea Bank Adjacent to North Shore Golf</u> <u>Course</u>

The Committee allowed the appeal on the basis that it felt that the route was the subject of much local concern and had given rise to a number of incidents of ill-feeling in the community.

It was also felt that the potential addition of the route to the Definitive Map & Statement may bring benefits to the local economy and PRoW network generally and fulfilled a RoWIP aim.

The case is at No.18 in the priority list and awaits allocation to an officer
