



**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of directing traffic on Emergency Evacuation Routes on roads for which Lincolnshire is traffic authority, hereby:-

1. authorises the placing at suitable sites on the said roads of a traffic sign (hereinafter referred to as “the authorised sign A”) conforming as to size, colour and character with the sign referenced A in the attached set of drawings numbered GT50/068/0019-1; and
2. authorises the placing at suitable sites on the said roads of a traffic sign (hereinafter referred to as “the authorised sign B”) conforming as to size, colour and character with the sign referenced B in the said set of drawings and
3. authorises the placing on suitable traffic signs on the said roads of a patch (hereinafter referred to as “the authorised patch C”) conforming as to size, colour and character with the patch referenced C in the said set of drawings; and
4. authorises the placing on suitable traffic signs on the said roads of a patch (hereinafter referred to as “the authorised patch D”) conforming as to size, colour and character with the patch referenced D in the said set of drawings; and
5. authorises the placing on suitable traffic signs on the said roads of a traffic sign (hereinafter referred to as “the authorised sign E”) conforming as to size, colour and character with the sign referenced E in the said set of drawings; and



6. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised signs A, B and E and authorised patches C and D, at or near the said site shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A, B and E, and authorised patches C and D, and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised signs A, B and E in the same manner as they apply to the traffic sign shown in diagram 2710 in Schedule 7 Part 8 to those Regulations.

The provisions of Regulations 12, and 20 of the 2002 Regulations shall apply to the authorised patches C and D in the same manner as they apply to the traffic sign shown in diagram 2710 in Schedule 7 Part 8 to those Regulations.
