The Report and Appendices A, 1, 2, 3 and 4 are open.

Appendix 5 is exempt and not for publication by virtue of Section 100A of the Local Government Act 1972 and/or paragraph 3 of part 1 of Schedule 12A of the Local Government Act 1972 as the Appendix contains information relating to the business affairs of bidders in a confidential procurement. That confidential information is relevant to this procurement and probably also to other procurements in the local government sector given the limited number of potential contractors in the market. The information therefore has a high commercial value and the law of confidence places a legal obligation on the Council to maintain bidder confidentiality. In the event that the Council fails to keep the information confidential then the aggrieved bidder may be able to bring a claim for compensation. In these circumstances the public interest in the Council complying with its legal obligations regarding confidentiality and protecting itself from litigation outweighs any interest in disclosing the information particularly where as much information as possible has been made available to the public in the open parts of the report.
