#### Summary:

To seek the approval of the Executive Councillor for Adult Care, Health and Children's Services on a matter relating to the membership of SACRE.

#### Recommendation(s):

That Committee "A's" (Religious and religious denominations in the area (other than Church of England) nomination of Peter Crosby, from the Lincolnshire Baptist Church, to fill a vacancy on Committee "A", on SACRE, following the resignation of Christina Dring, be approved.

#### Alternatives Considered:

Not to appoint the nomination on SACRE leaving a vacancy on Committee A and the need to seek alternate nomination to meet the principles of representation detailed in SACRE's Constitution for the appointment representatives to Committee "A". (See Appendix B).

#### Reasons for Recommendation:

It is necessary to meet the requirements of SACRE's Constitution and the requirements of the Education Act.

#### 1. Background

With regard to the nomination of representatives to vacancies on Committee "A", Peter Crosby, from the Lincolnshire Baptist Church, has been nominated by Committee "A", to fill one of the vacancies on Committee "A". Committee "A"

comprises up to 10 members of religions and other religious denominations in the area (other than Church of England). There are currently six Christian denominations, one Islamic denomination and one Hindu denomination. According to the SACRE Constitution (paragraph 4.1) Committee A representative members need to "reflect the religious traditions in the LA" ("LA" being Lincolnshire County Council area). Approval of the nomination of a representative from the Baptist Church will be consistent with achieving the requirements of the said paragraph 4.1 in "reflecting religious traditions in the LA".

Peter Crosby has, in accordance with the SACRE Constitution and Terms of Reference for SACRE, the support of the local faith group, the Baptist Church, and was initially proposed by that local faith group to Committee A, which Committee A has now further supported that in nomination for appointment.

The proposed appointee for Committee A also meets the requirement of paragraph 4 of the SACRE Terms of Reference which states "all members of Lincolnshire SACRE should have an interest in education in general and religious education in particular and must either live, work or worship in Lincolnshire. Peter Crosby worships in Lincolnshire.

The one remaining vacancy on Committee "A" will be considered by Committee "A" as soon as possible.

The SACRE Terms of Reference require that membership be annually reviewed. The next such general review of membership is scheduled to take place at the AGM of SACRE in the autumn of 2017.

#### 2. Legal Issues

#### Equality Act 2010

Under section 149 of the Equality Act 2010, the Council must, in the exercise of its functions, have due regard to the need to:

\*Eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under the Act

\* Advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it

\*Foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

The relevant protected characteristics are age; disability; gender reassignment; pregnancy and maternity; race; religion or belief; sex; and sexual orientation

Having due regard to the need to advance equality of opportunity involves having due regard, in particular, to the need to:

\*Remove or minimise disadvantages suffered by persons who share a relevant protected characteristic that are connected to that characteristic

\*Take steps to meet the needs of persons who share a relevant protected characteristic that are different from the needs of persons who do not share it

\*Encourage persons who share a relevant protected characteristic to participate in public life or in any other activity in which participation by such persons is disproportionately low

The steps involved in meeting the needs of disabled persons that are different from the needs of persons who are not disabled include, in particular, steps to take account of disabled persons' disabilities

Having due regard to the need to foster good relations between persons who share a relevant protected characteristic and persons who do not share it involves having due regard, in particular, to the need to tackle prejudice, and promote understanding

Compliance with the duties in section 149 may involve treating some persons more favourably than others

The duty cannot be delegated and must be discharged by the decision-maker. To discharge the statutory duty the decision-maker must analyse all the relevant material with the specific statutory obligations in mind. If a risk of adverse impact is identified consideration must be given to measures to avoid that impact as part of the decision making process.

The recommendation has no equality impact as the remit of the SACRE prohibits inequality which would go against its remit, moral and ethical purpose.

# Joint Strategic Needs Assessment (JSNA) and the Joint Health and Wellbeing Strategy (JHWS)

The Council must have regard to the Joint Strategic Needs Assessment (JSNA) and the Joint Health and Well Being Strategy (JHWS) in coming to a decision.

The proposed recommendation has no immediate effect on the JSNA or the JHWS.

#### Crime and Disorder Act 1998

Under section 17 of the Crime and Disorder Act 1998, the Council must exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent crime and disorder in its area (including anti-social and other behaviour adversely affecting the local environment), the misuse of drugs, alcohol and other substances in its area and re-offending in its area.

The teaching of religious education in schools can help to foster tolerance and understanding between different communities and this could help to prevent antisocial behaviour.

#### 3. Conclusion

Committee "A" have nominated Peter Crosby, whose appointment is supported by the local Baptist community, to fill the vacancy on Committee "A", in accordance

with the principles of representation for Christian denominations and other religions in the Lincolnshire County Council area.

# 4. Legal Comments:

Provided the requirements of the Constitution for SACRE have been followed in reaching a nomination, it is within the remit of the Executive Councillor for Adult Care, Health and Children's services to approve such nomination for appointment to SACRE and provided further such decision is consistent with the Policy Framework and the Budget.
