#### <u>Notes</u>

- (a) Initial enquiries indicate that longer term planning for demographic changes is undertaken by the Department for Health and Social Care, in effect a central government function. An element of medium term planning for demographic change is undertaken at a regional level by NHS England. Locally, the Lincolnshire Acute Services Review evaluated projected activity growth over the next five years for the services forming part of that review, so in effect this is undertaken on an individual basis. The Committee may wish to provide further guidance on which element of planning it would wish to focus, in order to proceed with this item.
- (b) Support from the third sector and volunteers for the NHS is extensive and ranges from volunteers providing services directly at NHS sites, such as cafes and shops at hospitals, to a full range of providers, for example ranging from Age UK to LIVES, some of whom are funded via a contract with NHS Lincolnshire Integrated Care Board. A suggested approach to this may be for the Committee to request an overview from the Lincolnshire Voluntary Engagement Team, which is a collective of voluntary groups and organisations, who have an interest in working with health and care partners to develop and deliver services.
- (c) On the item on *Local Strategic Planning of Integrated Health Provision*, which was specifically added to the list on 8 November 2023, the Committee is requested to note that two strategies: the Lincolnshire Health and Wellbeing Strategy, and the Integrated Care Strategy are due to be considered by the Committee on 21 February 2024. These two strategies are relevant to the local NHS and its partners, such as social care. In addition, NHS integrated care boards and their partner trusts are required to prepare a Joint Forward Plan, and a five year plan for the period 2023-28 was published in June 2023. The Committee may wish to consider the two items listed for 21 February 2023 before taking this forward.
