Summary:

In association with all seven district councils a Code of Practice has been produced that includes all of the information relevant to opening a cafe on the public highway. It includes a revised policy on how the county council will deal with applications for a licence for a pavement cafe.

Recommendation(s):

That Councillor W S Webb (Executive Councillor for Highways and Transport) approves the Code of Practice.

Alternatives Considered:

1. Retain current policy.

Reasons for Recommendation:

The new policy will ensure applications for pavement cafes licences are considered in a consistent and equitable way.

1. Background

1.1 The county council have had a policy on dealing with applications to operate pavement cafes on the public highway. The opportunity has been taken to produce a Code of Practice for Pavement Cafes that includes information on the requirements of both the county council and district (including Borough and City) councils. The Code of Practice will ensure pavement cafes will enhance the street scene and operate safely.

2. Conclusion

2.1 The Code of Practice is approved.

Adoption of this code of practice will allow the Council to deal with applications for pavement cafes. The application fee chargeable will be used to cover the cost of the Service.
