Question/Comment	Answer
You stated that where possible the LA wish to reduce the need for children and young people to travel – the distance between Queen's Park, St Christopher's and St Francis schools is relatively small and therefore this is only a very minor consideration in this instance.	We accept that for some children and young people (CYP) this will not be applicable. However, some CYP do currently travel some distance and this approach across the county in the wider special schools review will make a difference and reduce travel times overall.
For my child closing Queen's Park School will mean extending their travel time.	Whilst we expect an overall reduction in travel times across the county, we accept that for some CYP this proposal will make travel more complex and not benefit everyone.
Why can't the LA consider taking part of the park space at the side of Queen's Park school and then use the play areas at the school to extend the size of the school buildings?	We have considered other options and this is the proposal we feel offers the best solution. The LA does not own the park space – it is owned by Lincoln City. There are covenants in that area which restrict what the land can be used for.
Will children be asked to move school if a new provision becomes available which is nearer to them?	The LA will continue to work with parents/carers and CYP to discuss options available to them.
With the closure of Queen's Park School children and young people at that school are not being given same opportunities as other children in other special schools.	This is only a proposal and we aim to address these concerns through the detail of the consultation process. All comments will be considered.
What choices do parents/carers have if they do not want their child to go to St Francis or St Christopher's schools? You talked about providing for each child's need and yet you don't know each individual child's needs so how do you know what is best?	This is a public consultation and parents/carers can put their views in writing using the response form attached to the consultation document. As well as the meeting today parents/carers will have the opportunity to attend an additional meeting at their respective schools to discuss individual concerns. There is also the opportunity to discuss your concerns with your Headteacher and also visit St Francis and St Christopher's Schools.
The nearest school might not be the only or best option for my child, we still may need to travel a great distance to the most appropriate school for my child.	St Francis school is the only designated school in the county to specifically cater for the children that it does and so some children do travel a considerable distance if the parents choose to. We aim to try to improve the quality and breadth of provision across the county.

Previously my child was not accepted at St Francis School as the school could not meet their needs. Will you be transferring the staff with my child? You talked about the staff being paramount – will they be assimilated or will they have to reapply?	St Francis School is now catering for a wider range of need and the LA believes that extending the range of need and the accommodation and resources at St Francis School and St Christopher's School will further improve opportunities available to CYP. The staff arrangements are yet to be determined and a separate HR consultation process is taking place for this, but it is our aim to retain the skills and knowledge that would enable a successful transition to be carefully managed using all available resources. There would still be the same number of children at the end of any proposal being implemented and so staff will
Will children be made to attend the DSU provision at the Academies, as I am concerned about bullying?	still be needed to support them all. No CYP will be forced to attend the DSU provision. In future there will be more opportunities available which will be discussed with parents/carers and CYP at individual levels so they can get the most suitable provision that they are comfortable with. Parents/carers are encouraged to contact the Headteacher at Priory Witham Academy to discuss the DSU provision at that Academy as this provision will open in September 2011. The Headteacher of Priory Witham Academy will have responsibility for the DSU provision.
What about the children that have tried mainstream schools and it doesn't work?	Some CYP and parents do want this and it does work for them, so it is important that we give them the option. If they are not suited to mainstream then there will still be other options available as there are now.
Queen's Park School has good resources and staff - will those resources and staff go to the new schools?	It is the ambition of the schools and the LA to utilise the resources and staff at Queen's Park School, but we are currently going through the correct necessary HR processes. The headteachers and LA recognise the skills and expertise of the staff at Queen's Park school, and St Francis and St Christopher's schools want to utilise those skills and expertise. Meetings with staff have been included as part of this process and should the LA decide to go ahead with this proposal further consultation meetings with staff will be held.
Parents are concerned that there are not enough places in Lincolnshire special schools. The proposal for a Free School would provide additional provision within the authority – why is the LA not supporting this proposal?	The LA does not need to support a free school proposal if it judges that it can meet the needs of CYP with the provision available, which we believe we can. The LA do not see the need to support a free school at this time.

You say no child will be forced to return to a mainstream school. What about at 16?	No, they would not be forced to go to a mainstream school. There will still be a range of options available to choose from for any statemented CYP.
Who makes the decision about whether a young person goes to a DSU?	The arrangements that are currently in place for identifying a specialist placement will continue, this will involve full consultation with individual parents.
Why did the government stop the Building Schools for the Future programme?	We believe this was due to funding as there was more money being spent than there was available. If BSF funding had been received the secondary aged pupils at Queen's Park School would have been looked at as a potential recipient of the funds.
Why is the LA spending money on academies?	Academies are funded by central government, the LA does not spend money on academies. If a school decides to become an academy that money is taken back from the LA by central government who give the funding directly to the academy.
Special Schools can also convert to academies – why have the LA not given special schools the opportunity to become an academy?	It is not the responsibility of the LA to convert a school into an academy. It is a decision for the school itself to make and liaise directly with central government.
Will the views of parents/carers be listened to and taken into account and alternative option be considered before any final decision is made?	This is a proposal and this is the first stage [consultation] of the process which will run until 27 th July. All views and responses to the consultation will be taken into account and used to form a report to the Executive Councillor before deciding whether or not to proceed to the next stage. The final decision will not be made until later in the process by the full Executive Council if we get that far. No anonymous responses provided via the Consultation Response Form can be taken into account.
Before a final document and decision is published will any amendments or additions be made to the current document?	All responses received will be used to inform the paper to the Executive Councillor and if a decision is made to publish a Statutory Notice a further representation period will take place from August to October 2011 before a report is presented to the Scrutiny and Executive Committee. Reports presented will include the comments and views collated during the consultation and representation period. The current document may be changed if the Executive Councillor asks for any changes to be made as a result of the consultation.
Has the LA looked at alternative buildings for Queen's Park School?	The LA has in the past looked at different sites which were deemed not appropriate. The LA has specific building regulations that they have to work to. Other sites looked at included Myle Cross – the cost to convert

	this site would be significant, approx £7 million, Ermine Infants School – the site was unsuitable against the SEN specification and building regulations – the school would need to be demolished and a new build put onto the site – this would not have been cost effective.
Has the LA looked at the cost of building a new school for Queen's Park School	To build a new school would cost in the region of $£7\frac{1}{2}$ /8 million – this is not a cost effective solution.
Approx £2 million will be spent on extending the provision at St Francis and St Christopher's Schools – how much money has been spent by the LA on the DSU provision?	The LA does not fund academiess – this is funded directly from central government.
What will happen to the Queen's Park School site?	There are no plans for the site. If the proposal to close Queen's Park School goes ahead the future of the site will be determined by the County Council in line with current practice. The nature of the site and its size and location would limit any development
If St Francis or St Christopher's School could not meet the needs of a child currently at Queen's Park School what alternatives would there be for that child?	Individual discussions will be held with parents/carers as to their child's individual needs and how those needs can be met.
Previously St Christopher's School could not meet the needs of child/children or it was suggested that the children go to separate schools. How can St Christopher's meet their needs now?	The range of need catered for at St Christopher's School has changed. The LA believes that extending the range of need and the accommodation and resources at St Francis School and St Christopher's School will further improve opportunities available to CYP. Each HT will do everything they can to meet the needs of each child and parent.
For parents/carers of children with SEN ensuring their needs can be met is very exhausting and liaising with all relevant agencies is also very exhausting. The closure of Queen's Park School adds to the stress and pressure for parents/carers.	We acknowledge comments made. This is a proposal and no decision on the closure of Queen's Park School has been made, and we appreciate what you and others may have to go through and we can assure you that with the support of the schools involved any change would be very carefully managed.
Queen's Park School is a good school with an outstanding Ofsted. Why close it?	This is a proposal. The reasons are all detailed within the consultation document. Amongst other reasons the main site building is no longer fit for purpose and is not on a site which can be developed or rebuilt on.
Transport for some children and young people is an issue. Closing Queen's Park School will add to the transport issues for some Children and Young People. How long will the Annex remain open?	The LA recognises that there needs to be appropriate training and support for transport providers and continues to assess this to ensure it is managed appropriately. There is no expectation that the Annex will close, however, we cannot say that this will
	remain open for 5 years or 20 years as

Why will the Annex remain open but not the main building?	circumstances change. The proposal is that the Annex building will be managed by St Christopher's School and will be part of the wider Post 16 offer for young people with learning difficulties and/or disabilities in Lincoln City. The Annex is considered to be suitable for young people and it is being retained for post 16 provision only as this is still needed. However the main building is no longer fit for purpose and the only viable option is to
How will meals be provided for young people at the Annex?	invest in the other two schools. Provision for meals will be made through either St Christopher's or St Francis School or another provider.
On what grounds is the main site of Queen's Park judged to be not fit for purpose?	Headteacher, governing body and parents/carers have over the last 5 years expressed concerns regarding the main site of Queen's Park School not being fit to meet the needs of the CYP. The site is a split site and is not large enough to meet the needs of CYP. Although the building has met all health and safety requirements with regards to safety and security, the building is not judged to be big enough or suitable to meet the long term needs of CYP. To make the site fit for purpose would mean taking the CYP off site, knocking down and rebuilding the school. This is not cost effective and would not be achievable with available resources.
Why can't the young people aged 14-19 be accommodated on the Queen's Park School main site as they would have access to more space and the hydrotherapy pool?	The LA will consider all comments and suggestions made.
How many pupils does the Annex currently cater for?	Currently 42 young people with a variety of needs including severe autism and profound and multiple learning difficulties. The proposal is over time the Annex will cater for young people from 16 to 19 and therefore numbers will reduce. It also expected that young people will not only be educated in the Annex – opportunities will be provided at St Francis School, College, work providers, etc.
I don't think the annex is suitable for a 16-19 location as it is on a main road and the CYP will be vulnerable. Also what other sites have been looked at?	We have considered other sites across the city. The specification at the Ermine makes it unsuitable for conversion. The annex is already used for 16-19 education and was built to meet the required regulations at the time.
How many young people in wheelchairs attend the Annex as there is not enough space for wheelchairs?	Currently 7, this will rise to 9 in September and approx 11 over the next 4 years. St Francis school could offer a solution to space and would provide an element of choice for

This proposal has come from the 3 HTs. The HTs have put the needs of CYP first and they want to be able to provide a better environment for CYP so that they can be nurtured even more. HTs have considered the impact a change in environment can have on children and if the proposal goes ahead the movement of children from Queen's Park School will be managed in a sensitive way.
What is the planned building work at St Christopher's School?	The proposal for St Christopher's School is to build 5 additional classrooms along with specialist areas and hygiene suite which will provide flexibility and a range of space to meet different needs. The building will be accessed by children from Queen's Park School and St Christopher's School, allowing interchange.
When talking about moving children over class by class will the teachers move over with that class?	There is no reason why we can't as far as possible replicate the environment the CYP are moving from as a starting point. Would want to discuss with parents/carers how their child can be integrated into St Christopher's and provide the child with a personalised and individualised timetable. Separate discussions are being held with staff regarding their rights and opportunities, we would want staff from QP to follow children to their new school environment and will actively pursue this.
What are the class sizes at St Christopher's as don't want my child to move from a class of 5 to a class of 15?	The classes at St Christopher's are about 12 although provision for early years, more severe learning difficulties and ASD pupils is made in much smaller classes of between 8 and 4
My child did try St Christopher's but then was sent to Queen's Park School and now may have to go back to St Christopher's and go through the whole process again of changing schools.	If this proposal goes ahead we would aim to develop a range of provision similar to Queen's Park School.
Seems there is a lot of anxiety from parents/carers of CYP at Queen's Park School, but parents/carers at St Christopher's school are also anxious about the effect any change could have on their CYP.	This is noted and all concerns will be taken into consideration.
Parents/carers are concerned regarding St Francis and St Christopher's Schools already being over-subscribed and cannot meet the needs of CYP from Queen's Park School.	The LA judges that if the proposal goes ahead including the additional provision at St Christopher's and St Francis Schools and the DSU provision it can sufficiently meet the needs of CYP in Lincoln city.

The balance of provision is not right in all areas of Lincolnshire, e.g. Sleaford no Special School provision	This is something we will need to address. The LA recognises this and will be reviewing provision in other areas, but has started the first part of the review with Lincoln city.
How will children from Queen's Park School be separated between the other two schools?	Discussions will be held with individual parents/carers on their child's needs and most suitable provision to meet those needs.
Will statements be changed to reflect any change in school?	All statements will be reviewed accordingly to ensure that any change in school will meet the needs of the statement and the provision required.
Who will be the headteacher at St Christopher's School should this proposal go ahead?	All HTs are committed to seeing this process through. All issues regarding staff and recruitment are yet to be addressed. This is only the beginning of a complex process that we need to work through together. We do not want to lose any staff through uncertainty about the process.
Understand that individual needs, economic climate and excellent facilities that are available at the other two schools have been taken into account. The real sense from people is that it is not just about the loss of Queen's Park School but there is also a strength of feeling that it is also a loss of a community and parents/carers would not want this to be missed as part of the debate.	This is noted and all concerns will be taken into consideration.
What sort of work is being done in relation to planning, tendering, contractors, etc?	This is still a proposal and no tendering or contracting has taken place. Only discussions taken place are of what can and need to be done at St Christopher's and St Francis schools and the proposed cost.
The publication of a statutory notice is planned for August 2011. Would LCC consider doing this at the beginning of September as in August a lot of people will be on holiday?	This is still a proposal. LCC will consider all comments and views expressed during this consultation meeting and also in the Consultation Response Form but we do need a decision made so that we know what we are working towards and by when.
Will statements or comments from parents/carers be included in the document?	LCC will not release any information about individual people as part of this process but statements/comments received will be included in the consultation, although any statements/comments submitted that are anonymous cannot be included.
You say that the LA is acting in the best interests of the CYP, but let's not deny that this is determined by financial constraints	Previously funding was provided on a different basis and now we are in a more stable environment than in previous years.

The DSUs in the academies have no track record regarding education and provision. What responsibility does the LA have with regards to appropriate staffing for the DSUs?	The DSUs will belong to the academies. A specification of provision has been drawn up and agreed with each of the academies which includes staffing and resources. CYP accessing the DSU provision will have a statement and the LA will maintain a duty to ensure the needs of the CYP are met and the LA will work with the academies to assess and monitor how the needs of the CYP are being met. If the LA has a concern it can go to central government and challenge how the DSU is being run.
I was recently approached to be a parent governor at the Witham Academy and all plans are in place and the ethos is excellent. Parents need to take the effort to investigate the academy and not believe all the negative coverage.	Noted
What buildings are going to be developed at St Francis School?	The proposal for St Francis School is to build an additional 3 or 4 new classrooms with sensory rooms within the school site. The new classrooms will be accessed by CYP from both Queen's Park School and St Francis School.
Will the new buildings only be for the benefit of Queen's Park children?	We won't be segregating CYP – the new classrooms and sensory spaces will benefit all
What about classroom sizes?	We already have good sized classrooms but will hopefully be able to have even larger classrooms (50-60 m ²)
How are you making all parents aware that they are welcome to visit the schools?	3 days have been set aside in July to have meetings with parents and Allan Lacey will be writing to all parents. But we stress that all parents are welcome to arrange to visit outside of these dates.
Why has a DSU been considered at Witham and City of Lincoln academies but not at LSST?	This was to do with funding arrangements at the time when building academies. DSU opportunities should be embraced and for some parents they provide opportunities not previously available

Why wasn't this site considered?	A new school was built which opened as a Sports Academy – Special School accommodating CYP with complex behavioural needs. This was part of our planned provision for CYP (four schools in total) with such needs and was supported by the government
Queen's Park School is not just another school. It is another home for those children. This should not be about money but about the children. No matter how much money is put into St Francis and St Christopher's this will not be replaced. We don't have any information about how the proposal will achieve what it sets out to do with children of differing needs.	Noted. Parents are welcome to visit St Francis and St Christopher's Schools. Our community at Queen's Park School is not very large. Why were we never consulted as parents. The first I found out about the proposed closure was through the media. Now I hear other sites had been considered and those proposals should have been seen by us. Our children and their families are the ones who are being affected.	Letters were sent home to all parents inviting parents to meetings regarding the proposals, including a copy of the report which went to Scrutiny. Apologies if you did not receive the correspondence – please discuss this with Mr Lacey. We are working with the press and have tried to ensure that parents are made aware of developments before these are in the media.
Queen's Park School received an outstanding Ofsted. Why after that Ofsted did the school not consider becoming an academy and thus having more control over its future?	LCC cannot not stop any school from becoming an academy. The government regulations are that Special Schools cannot look at becoming an academy until September 2012 at the earliest. All special schools are entitled to become an academy.
	Mr Lacey responded – the governing body looked at the academy system and at the time the school could not apply, the governing body felt that it was not a right decision for the school at that time. The school also considered becoming part of the Lincoln academy but also considered this was not a suitable option.

When my son moved from Chad Varah School to Queen's Park School this was most upsetting and the Queen's Park Staff were integral to him settling in. My son can't handle change and what reassurances can I have that this won't be held against him if he moves to St Christopher's or St Francis schools or somewhere else.	The LA and school staff have experience of moving children into a new school and it has been very successful. We will be drawing upon those experiences in the future.
I am concerned regarding the DSU places. Are those children going to be made to move mostly from St Christopher's and who decides at the end of the day where children go?	There is no assumption that a child from a special school will be moved into the DSU. This will be a slow and well managed process. If there are any future requests for places into a special school then the LA may also look at whether the DSU is an option. There has been no statement that staff will have to move to an academy unless that is their wish to do so.
The DSUs seem to be a cause for concern and some parents have already contacted me expressing concern about their children who have been enrolled for September and there are a lot of unanswered questions.	I am aware that children enrolled in the DSU provision for September, this is not my area ofresponsibility. This meeting is about the proposal to close Queen's Park School. The DSUs are not open for business yet. The DSU at Priory Witham Academy opens in September 2011 and we have already explained the process with regards to admission arrangements and these would have been shared with parents as part of the statementing process. The DSU at Priory City of Lincoln Academy will not open until September 2014. The DSUs are part of a new offer in Lincoln with regards to special school provision. The DSUs will fill very slowly and there is no intention to force any children to go there. All parents/carers who may be interested in the DSU provision at Priory Witham Academy are invited to contact the headteacher and arrange to go and visit the provision.
The current SEN Code of Practise is well known but what if a statement says a child must go to a DSU?	We understand parental concerns and are always happy to work with parents to alleviate any anxiety. There are some excellent opportunities provided by working with DSUs.
With regards to post 16 children with PMLD, are they going to be given the option to attend the Annex or are they going to be made to attend St Francis school?	At this stage this is only a proposal but if there is the opportunity to attend either then children's individual needs will be discussed at individual level with parents/carers.
