Summary:

Following changes in 2012 to the national process for classifying roads, this paper sets out a Road Classification Policy for Lincolnshire in line with guidance published by the Department for Transport (DfT).

Recommendation(s):

That the proposed Road Classification Policy for Lincolnshire attached at Appendix A to this report be adopted.

Alternatives Considered:

1. To not adopt the policy would leave the Council open to possible challenge on future classification proposals

Reasons for Recommendation:

To provide a consistent approach to road classification across Lincolnshire in line with DfT guidance and to provide support should classifications be challenged.

1. Background

- 1.1 The national road classification system dates back to the 1920s. Over the years, this has developed into the current categories of:
 - Motorways
 - A roads
 - B roads
 - Classified Unnumbered Roads (known locally as C roads)
 - Unclassified roads

- 1.2 Prior to April 2012, any transport authority wishing to change the classification of an existing road (or classify a newly constructed road) was required to complete the necessary paperwork and submit this to the Department of Transport (DfT) for their agreement.
- 1.3 Since April 2012, local transport authorities have been given greater responsibility and they no longer need to seek DfT's consent on such issues (although the Secretary of State does retain the ultimate right to intervene and make a decision if necessary).
- 1.4 DfT has produced guidance to assist transport authorities in their new role. This indicates that authorities should put in place their own policy on road classification which sets out in general terms the approach and processes to be used to ensure consistency and assist in any disputes.
- 1.5 The proposed Road Classification Policy for Lincolnshire is attached at Appendix A. This has been prepared taking into account the guidance provided by DfT.

2. Conclusion

2.1 To fulfil the requirements of the DfT Guidance, the policy attached at Appendix A should be adopted.
