Summary:

Lincolnshire County Council's Transport Asset Management Plan (TAMP) has been developed further. The TAMP aims to improve our ability to use our available resources as efficiently as possible and provides improved information and guidance to those delivering highway services.

Recommendation(s):

That the Transport Asset Management Plan (TAMP) is accepted by the Executive Councillor for Highways and Transport.

Reasons for Recommendation:

The TAMP has been presented to Members at the Highways, Transport and Technology Scrutiny Committee. The TAMP allows Lincolnshire County Council to:

- Formalise our strategies for investment in the key highways asset groups (carriageways, footways, structures, street lighting, signals)
- Define affordable service standards
- Improve how the highways assets are managed
- Ensure value for money is delivered in the management of our assets.

1. Background

1.1 Lincolnshire County Council's first Highways Asset Management Plan (HAMP) was produced in 2006. Since then work has been undertaken to update and improve the information we hold on our highways asset in addition to investment in a new Highways Asset Management System (CONFIRM). National developments such as the implementation of SCANNER (Surface Condition Assessment for the National Network of Roads) machines to measure the condition of the surface of the carriageway have also been implemented. The TAMP will help ensure that investment decisions are robust and balanced across the various asset groups.

2. Conclusion

2.1 Lincolnshire County Council's Transport Asset Management Plan 2012-2016 has now been developed (see Appendix A).

3. Legal Comments:

The Executive Councillor has the remit to approve the TAMP provided he has the delegated authority of the Leader.

4. Resource Comments:

Highways maintenance is funded in two ways. Direct capital grant provided for Asset Protection from the Department of Transport and revenue funding from the Council's overall budget. The TAMP shows that total funding over the last seven years has ranged from £44m-£56m and approved budgets 2012/13 to 2014/15 show £48.7m, £48.0, and £46.6m respectively earmarked to be spent maintaining the road network and an assumed amount of £46.6m 2015/16 and beyond.

Since the TAMP was written, the Department for Transport has recognised the deterioration in the condition of the road network nationally and announced additional capital funding for Asset Protection of £6.5m spread over the next two years. This will increase the total spend on the network to £52.2m in 2013/14 and £48.9m in 2014/15.
