# **Summary:**

This decision updates the Street Lighting Policy.

# Recommendation(s):

That the Street Lighting Policy as attached in Appendix A is adopted.

#### Alternatives Considered:

1. Not updating the Street Lighting Policy has been considered but this would impede the County Council to effectively respond to carbon management and energy efficiency agendas in the area of street lighting.

### Reasons for Recommendation:

Updating the Street Lighting Policy will allow the County Council to manage these assets in the most effective manner possible taking into account the desire to have carbon and energy efficient assets.

#### 1. Background

The updated Street Lighting Policy was considered by Highways, Transport and Technology Scrutiny Committee on 13 September 2010. The Policy has had further minor revision as a result of the specific issues raised by scrutiny. Consultation with the Police and the Road Safety Partnership did not raise any concerns that had not already been taken into account in the proposed update. The final version of the proposed updated Street Lighting Policy is shown in Appendix A.

### 2. Conclusion

The Street Lighting Policy update as attached at Appendix A is recommended for adoption.

The Council as local highway authority is empowered under the Highways Act 1980 to provide lighting for any highway for which it is the highway authority. This decision is therefore lawful and within the remit of the Executive Councillor provided he has the delegated authority of the Leader
