

# Proposed changes to the provision of home to school / college transport for post 16 students

#### Have your say!

Closing date for responses: Wednesday 16th March 2011.

In the light of the significant savings that Lincolnshire County Council and all local authorities have to make over the next four years, the Council has concluded, reluctantly, that certain elements of its discretionary post-16 home to school/college policy need to be changed to ensure its longer term sustainability. The total home to school/college transport budget in Lincolnshire is currently £30,683,000, which makes the County one of the very highest spending authorities per pupil in the country. The law does not define precisely the circumstances which make assistance with transport necessary for post-16 pupils. There is no statutory requirement for the local authority to provide the transport. It is, therefore, for the County Council to decide, against the statutory guidance on post-16 transport issued annually by the Young People's Learning Agency (YPLA), what transport provision should be made and under which circumstances assistance with travel should be available.

After careful consideration, the Council is proposing the following policy changes which will still leave in place a high level of support for students but, at the same time, will achieve a very necessary reduction in costs. If agreed, these changes will be implemented 1st September 2011:

- 1. An increase in the annual contribution by students to the cost of transport to their nearest suitable sixth form or college in Lincolnshire where the home to school/college journey is greater than 3 miles.
- 2. Provide transport to only the nearest further education (FE) college or sixth form.
- 3. No longer provide transport for students from home to school or college along unsuitable walking routes where the distance is less than three miles.

#### 1. Annual contribution

At present the contribution from students is £202 towards the total transport costs for the year, or three termly payments of £69 (a total of £207, including administration costs). Lincolnshire County Council is proposing, from September 2011, to increase the annual contribution to £390, or three termly payments of £132 (a total of £396, including administration costs), This amounts to just £2.05 a day, which will still compare favourably with charges made by neighbouring rural authorities.

These proposed costs would be subject to future increases in line with normal annual adjustments made for inflation.

### 2. The FE college and sixth form to which transport is provided

a) Currently, students are entitled to transport provision to the main sites of their designated or nearest of four FE colleges in Lincolnshire, where the home to college journey is greater than 3 miles (See map/Appendix A)

Students are, however, also entitled to transport to a college which is out of County if it is closer to the nearest one to them in Lincolnshire. The majority of students who live close to the Lincolnshire border choose this option where the alternative journey to their nearest college in Lincolnshire is a long and arduous one. To offer these students transport to a Lincolnshire college in these circumstances is not only very costly, but also raises the question of fairness. The fact that some students are currently offered the choice of transport to more than one college, whereas most students are offered transport to a single college, their nearest one, can be viewed as not being fair and equitable.

The County Council is, therefore, proposing that transport provision will, for students enrolling for the first time in FE colleges in September 2011, be made only to the college nearest to a student's home address. A map to show which college students will be entitled to transport provision is attached as Appendix B.

The above proposal will similarly apply to students attending sixth forms, other than where a student was both on roll at the school in Year 11 and had a statutory entitlement to transport before transferring to the sixth form of the same establishment.

- b) Where a FE college has a satellite centre at which full time courses are offered, transport provision to this site will be offered to students enrolling for the first time in September 2011 only where the journey from home to that site is equal to or less than the journey to the student's nearest college.
- c) The County Council is also of the view that it is no longer able to make transport provision for students enrolling for the first time in September 2011 to other than the nearest college or sixth form, regardless of whether the course a student wishes to study is available at their nearest college or sixth form.

The only exceptions to the proposal c) above are:

- → Attendance of learners with recognised learning difficulties and/or disabilities (LLDD) at other than their nearest college or school where this is agreed by the local authority.
- → Level 2 or above Land Based courses (listed below) at specialist colleges where the home to nearest college journey does not exceed 45 miles (daily journeys will be arranged for the beginning and end of the normal college day on week days only).

Courses for which transport provision will be considered:

- Agriculture
- Environmental Studies
- Horticulture
- Arboriculture
- Large animal management
