

The style of this performance report is consistent with previous reports provided to the children and young people scrutiny committee. These categories are included for each every child matters outcome as well as for the 'service management' outcome, which covers the way that we deliver services and govern ourselves. In addition to this, those indicators that are over or under-performing have been listed. The intention of listing the indicators is to help keep the focus on the key questions: '*how well are we doing with the outcome?*' I.E. '*Are children safe?*' If the list of under-performing indicators was found to have a common theme (e.g. age of children, or those children that are looked after) then questions around this theme may be more useful than questions based on an individual indicator.

### **Summary Position**

Due to the annual nature of most NHS indicators, the actual performance in most indicators is difficult to assess until quarter 4. A revised breast feeding pathway is in place, and a task group is focussing on improving performance. Chlamydia screening target looks high risk despite an improving performance. The future pathways and arrangements for CMHS will be reviewed over the next 3 months in light of LCC commissioning intentions on CAMHs



**Summary Position** 

There are 20 indicators either on or ahead of target. In respect of the 15 behind target as listed:

2060SC The 2% is a reporting error. All children have a qualified social worker allocated to them 2015SC This is a local target and we have no control over the number of referrals. We are requested to meet need, our CAF's continue to rise.

2023SC We have clear thresholds for CP conferences. Those children subject to a plan need one. Thresholds are constantly monitored

CS128 We are dependent on receiving hospital reports from regional and national hospitals. The DoH has been alerted and asked to remind all hospitals of their safeguarding duty by the LSCB.

CS131 See commentary: the work has been detailed owing to the complexity of the work

CS012 Performance has decreased – a reminder has been sent and any data errors corrected. Visits where the child is well settled in reality have lower priority than CP investigation

CS127 & CS048 We are going to fundamentally review our CWD services. It is accepted that performance is not good enough. A report following our review can be presented to scrutiny.

NI060 More core assessments are being completed. Performance remains 27.68% below performance. Completion is dependent upon a holistic assessment of a child and family needs in a 35 day period. In practice such a comprehensive assessment is difficult to complete despite endeavours to do this. The most important task is to ensure interventions are focused and delivered. NI062 The closure of Ashleigh and a number of disrupted placements has decreased performance by 2%. This is also a difficult indicator to meet and our children have complex attachment difficulties sometimes negating placement stability.

NI067 This is a data error and needs correcting. The January figure is 100%

NI070 A report is available to the Assitant Director detailing the causes of injury that are associated with these admissions.

CS091 This anomaly reported by our DV coordinator is being addressed.

CS093 The figure is cumulative and there has been some improvement (this continues to be adjusted)

#### **Missing data**

NI069 16.2% of students (Primary and Secondary) have stated that they are being bullied against a2009/10 target of 45% .

This is a significant reduction in the number of reported incidents (the figure 2 years ago was 57.3% Tell Us 3 and 34.2% in 2009/10 Tell Us 4)

The following factors have contributed to this;

- Supplimenting the national Tell Us Data with our localised ECM Perceptions Survey

- The permanent appointment of an anti bullying officer.

- An Anti Bullying Strategy and Action Plan have been written

- The formation of an anti bullying working group to facilitate cross partner working.

- Anti Bullying Week 2010 being our most successful campaign to date.


- Active engagement with the Anti Bullying Alliance has enabled greater networking, consultation and knowledge gathering.

NI071 The number of children missing from home is 75 in December 2010, a reduction of 25 since April 2010. The action plan around children and young people missing from care, education and home have been completed and there is regular reporting into DMT.

### **Summary Position**

Enjoy and Achieve continues to do well overall, and although 37% are shown as behind target, these all cover areas where there are ambitious targets, mainly in the school performance areas where all targets are aspirational.

Although this report is up to the end of December, the verified data published in early January provides confirmation of a very good performance in some key indicators. The poor weather in December did not influence the 3rd quarter performance, although school absence data will be affected later in the year.



### **Summary Position**

53% of targets are on plan or above target and performance in relation to positive contribution continues to be strong.

Youth work outcomes are good with Lincolnshire showing good performance in relation to participation in volunteering as well as youth service recorded and accredited outcomes - It will be difficult to sustain performance next year if the proposed budget cuts are implemented.

Percentage of parents engaged in children's centre management continues to increase and plans to further improve this are in place.

There is an action plan in place to address the low uptake of the family information service and we are keen to make this more accessible so that it becomes the first point of access about services in Lincolnshire.

We have had 2 children's centre inspections this month with both outcomes demonstrating good performance.



There are two underperforming areas this quarter.

LLD clients in EET should improve as this is reported as missing due to a lag in data entry.

Young Offenders in suitable education, employment and training remains a concern and is being addressed further with the Youth offending Team.

Performance is ahead of target for the take up of 14-19 learning diplomas, however, funding for the development of new diplomas has been stopped by Government and the qualification's future is unclear.

Performance in Care Leavers in Education, Employment and Training and in suitable accommodation has improved over the quarter and are now both on plan.



**Summary Position** 

There are four areas underperforming.

Foster carers approved in 7 months is reporting that it will meet the year end target and the current data is being validated.

Statutory returns in timescales. One return out of timescale this quarter which was beyond the control of the Local Authority.

The last two indicators relate to training. The first was adversely effected by the weather in December and the second, although a drop on last quarter continues at a much higher rate than in the first quarter.

4 areas are performing better than expected, including in year admission appeals and qualification rates residential childcare staff.
