Proposed changes to the provision of home to school/college transport - consultation feedback from public meetings

ATTENDEES: 20

**Question:** Reference to website/guidance that points to the relaxation on the ring fence for the fund in schools enabling the Learner Support Grant to be used for transport?

**Answer:** Unable to point specifically where, we are aware that the Government's direction of travel is to un-ring fence grants. Meeting with college Principals next week and will explore this further. We are seeking further detail from Government.

**Question:** How can we finish the consultation without knowing the detail of the guidance from Government on hardship support? The county is a rural one and has areas of significant deprivation.

**Answer:** Yes we are rural but our policies are generous compared to other counties e.g. Yorkshire, Devon, and Somerset. Currently we are on average about £100 less and others are also looking to put up their prices. Government has promised to replace ema with "targeted support for those who face genuine financial barriers to participation"

**Question:** But more people are on benefits in Lincolnshire compared to Norfolk, have we compared our rise to theirs – have they doubled the cost?

**Answer:** All are currently consulting

**Comment:** Some of the inflexibility in provision today could have resulted from the current transport arrangements.

Question: Not fair or equal to those that cannot afford travel, have to buy other kit too?

**Answer:** So concern is how will people from low income be taken into account? So the feedback is that we should consider the impact on low income families.

**Question:** In the presentation, Lincolnshire more generous than other LAs. Are any others more generous than us? Citing the full picture is important not just one sided.

Answer: Yes, a few are. The point is noted

**Question:** £923 actual cost on average but some will not live far away and could be on low income – again picture could be misleading, people should see.

**Answer:** It is a very difficult area. Should we offer subsidy to those on low income for example or ask everyone to pay the same rate? These other options are what we are trying to capture during consultation so please feed back.

**Question:** If increase these changes what will you do to address poor service from operators?

**Answer:** We would recommend that you let Transport Services Group know at Lincolnshire County Council, this can be in addition to informing the operator as well. As we are the contracting body we would like to hear your feedback.

Question: Complaint on 24th September – 10 day reply but nothing yet.

**Answer:** Details taken to be followed up.

**Question:** My daughter finishes College on a Friday at 1pm but has to wait 3 hours for the bus.

**Answer:** Transport is only provided at the beginning and end of the normal school or college day for all students.

**Question:** Shame Cllr Bradwell or other Executive Members are not here when difficult issues are raised. Few people present this evening maybe due to poor access in the area. Lincolnshire is generous in difficult times. E.g. Does the council have a statutory duty to put £2m into Stamford School Scheme?

**Answer:** Review was done a few years a go with decision to taper out the provision. Not statutory requirement but pledge given to review again this year. This scheme is not funded through the same budget as transport.

**Question:** Would be interested in cost per pupil and Executive should look at the privileged few?

**Answer:** They are two separate budgets – transport and dedicated schools grant (DSG can only be used for schools). There is no flexibility to take £2m from DSG to put into transport.

**Question:** Could give money to colleges though?

**Answer:** This cannot be done as the guidance on the use of the DSG is clear.

Question: But could review taper?

**Answer:** Yes they could.

Question: Council reserves – ask Executive to use reserves?

**Answer:** Comments will be fed back.

**Question:** Echo low pay comment/reserves/Stamford. Young person not able to follow through their hopes and dreams – once make a contract with a provider what if the drop out rate increases because they are doing a course they don't want to do, is this wasting money?

**Answer:** Post 16 group looked at transport as a barrier and it was not the main reason in fact low on the list of barriers. Perhaps one of the issues is a lack of provision in some areas, meaning we have to transport significant distances. Perhaps more should be done to look at the distribution of provision. We should be working with Further Education to ensure all provision is good and equal.

Question: What about a one year course progressing to another one year?

**Answer:** Progression from year 1 to year 2 honoured.

Question: Does it need to be such a big increase from £202 to £392?

**Answer:** We needed to frontload our reductions so hence the proposed increase. I'm afraid I can only explain the reasons why.

**Comments:** For five miles that's a lot of money

The charge is a flat-rate charge for all – yes.

**Question:** What if buses don't run/doing half course?

**Answer:** Transport is only provided at start and end of day, Monday to Friday.

Question: Louth resident, which Grimsby College?

**Answer:** Transport will be provided to either.

**Question:** Safe walking route decision – I would just like to register my disagreement and how does this fit into ECM agenda?

**Answer:** Every Child Matters was the previous Government's framework, but the principles still apply.

**Question:** How is three miles measured?

**Answer:** Three miles by nearest and most direct available route.

**Question:** Example £9.20 per week by using North Hykeham to Boston Mega-Rider bus route?

bus route:

**Answer:** We think this could be the cost to Lincoln from North Hykeham.

**Question:** Widening provision: restriction on travel could reduce specialism of colleges and so reduce choice?

**Answer:** Feedback special cases during consultation please.

Question: Value of courses to tourism but no mention of protection for them?

**Answer:** Feedback special cases during consultation please.

**Question:** Any assurance of future years?

**Answer:** My understanding as an officer is that there are no plans in next few years, but no one knows the future. Future increase above £390 will be directly linked to inflation. We have only had a two year settlement so that's what we are comfortable about.

**Comment:** Political choices so there are choices for taking funding off other areas the council funds.

**Question:** How will you influence colleges?

**Answer:** LSC has been the commissioner previously. LA is the commissioning body so should have more influence but not overnight.

Question: How is this going to affect children in 6<sup>th</sup> forms?

**Answer:** Those that are currently in a school sixth form will get transport provided for Y2 if their course is for 2 years e.g. an A level.

Question: What about 11-16 schools or those going to different 6<sup>th</sup> form?

**Answer:** 11-16 transport will not be affected by these proposals. If the school does not offer a sixth form then they will be eligible to transport to their nearest school/college (if over 3 miles) but there will be a charge.

**Question:** My child is currently now at Monk's Dyke and next year will be in Monk's Dyke's sixth form so she will have to pay?

**Answer:** Yes, statutory requirement to provide free transport up to 16 but discretionary post 16.

**Question:** The cost is double what it was previously, must it be so large?

**Answer:** Noted. This point has come through quite clearly.

\_\_\_\_\_

**Question:** Unsuitable, criteria have deemed there are risks, who now accept the risk, not yet adults?

**Answer:** They are deemed unsuitable not unsafe. Some young people at the age of 16 will be making their own transport arrangements if they go to work or undertake training with an employer – the Council does not provide transport in these situations. The Council believes that young people at this age are capable of judging the risks on these journeys.

Question: At what point has thinking around EIA been done?

**Answer:** The initial EIA has been completed and will be published on the website. The consultation will inform the next stage in the process and will be available to both Scrutiny and the Executive at the time of the decision making.

**Question:** Will your EIA include socio economic factor?

**Answer:** Socio-economic factors are not included in the Council's EIA policy as it is not a statutory requirement. Your comments though will be taken to the next Scrutiny meeting and to the Executive meeting. We will raise the point about no SE factor in our policy with colleagues.

**Question:** What if my child changes to a college after the start of September because of bullying?

**Answer:** That is not a routine event now, but there is always a discretionary element though. We currently do individual assessments on a case by case basis and that will not change.

**Question:** But we are being encouraged to raise the participation age?

**Answer:** Raising the participation age yes, but this is not statutory. Statutory school age is still up to 16 and for this there is free transport. Post 16 is not free but discretionary for the Council.

Answer: Pupils with statements will have their individual cases looked at. To

stress these are proposals and the budget challenge is real.

**Question:** Has anyone looked at bus timetables?

**Answer:** If already going to college this will continue. If local bus service (public)

does not provide a provision then we will make this provision. If proposal

accepted we will ensure travel provision is available.

**Question:** No special student prices, they pay adult fare.

**Answer:** We would provide concessionary travel rate of £390, but yes the choice

of college will be affected.

Question: Just point out that the EMA replacement is the pupil premium targeted at

school age children, who have free school meals.

**Answer:** Government thinks EMA was targeted too wide and they want to focus

funding. We also expect the Learner Support Grant to be un-ring fenced

so that it could be used to help with transport.

Question: As parent of children with autism, welcome LLDD exception, although in

my instance there are no computer based courses in Lincoln.

**Answer:** This consultation is about transport, but yes local need is being looked at

specifically with regards to children with disabilities.

Question: There are some parents who just can't afford this and so pupils won't go

to college, particularly parents of children with educational needs.

Answer: Issues brought up so far recognise the need for an increased

contribution but the effect on multiple siblings and choice of courses

needs looking at further

Question: Live on A607 so how will we get transport to Newark College, as no local

provision available.

Answer: Commercial travel routes do change but please do put forward case

study for consideration. The principle is based on nearest 6<sup>th</sup> form or college but do take point that easier to travel to Lincoln as routes exist and those to Newark do not. We do need though an objective policy so

that it can implemented.

Question: How does Council plan to address duty to put on transport for young

people to have a reasonable opportunity to choose between different

courses available to them at 16?

**Answer:** Key word is reasonable; we do act within the law and do what is

possible.

Question: Choices of courses at Boston and Lincoln very different with one suiting

my daughter's needs better

**Answer:** This is a matter for course providers to consider rather than the LA as

the transport provider.

Comment: You are not recognising current transport arrangements and it seems

counter-productive to set up new courses

**Question:** You should not be a surprise that we have a large transport cost.

Answer: We look at statistical neighbour authorities that are geographically

similar to ourselves. We benchmark our costs against theirs to see how

we compare.

Question: Lord Hill extract - "obliged to ensure that transport is not a barrier and

encouraged parents to complain" Can you comment?

**Answer:** Still a full commitment to access transport to their nearest college, many

authorities don't. No matter how difficult we will provide transport.

**Question:** But cost is a barrier

Answer: We are awaiting clarity over the school/colleges enhanced learner

support and removal of its ring fence - but yes suspect that this will not

be the same amount of money as the EMA

Question: Has an EIA been undertaken?

**Answer:** Initial was and informed we need to go to partial

**Question:** What interested groups have we consulted?

**Answer:** Public groups and Parent Carer Council.

Question: Specialist course, e.g. Performing Arts & Music

**Answer:** Will come down to provision that 6<sup>th</sup> form and college make. Also please

feed back any special courses to be considered for adding to the

discretionary subjects list.

**Question:** Sir William Robertson looking to put on a 6<sup>th</sup> Form

Answer: Next nearest can be provided if nearest provision full. Our view is that

the 6<sup>th</sup> form has to offer a broad range of subjects at either an academic

or vocational level to qualify as a sixth form.

**Question:** Special transport provision for violin courses?

**Answer:** We would not at the moment and do not expect to in the future

**Question:** Why transport out of County.

**Answer:** Legal precedent has guided the Council always to transport to nearest

and not just in the County sixth form or college. There have been strong

cross-border flows of students for many years.

**Question:** How did you notify this consultation to people?

Answer: Sent to all schools and colleges and asked to pass on to students and

parents. Published on Council's website. Posters distributed county-

wide.

Comment: Should have sent to Y11 pupils

Question: Reasonable choice – how does a BTEC compare to an A Level?

**Answer:** Always have a choice of 6<sup>th</sup> Form or College.

Question: What if course is not available at nearest 6<sup>th</sup> Form or College

**Answer:** Proposals would say you make your own transport arrangements

**Question:** Unsuitable walking routes: what is unsuitable?

Answer: Unsuitable relates to the route and traffic risks e.g. sight lines round

corners, pavements exist, traffic volumes etc; does not include

provisions of street lighting.

**Question:** Once 16 seem to have to get hurt before something done.

**Answer:** Provision not made for under 3 miles.

Question: Youth unemployment is the highest age group and expect it to rise

further. Do we know if colleges etc, have the capacity to take new pupils

going to nearest college?

Cost too high per proportion of income and EMA is double hit this will also impact on NEET how will a single parent find the additional money?

**Answer:** The number of young people with no education, employment or training

(NEET) has fallen year on year despite the introduction of charges in 2006 and an annual increase to date. Executive thought that £2 per day was affordable – feed back suggest this is not the case for those families

on low income.

**Question:** Will Council publish saving as a result of their decisions, for every

decision?

**Answer:** Full Council has already agreed the savings needed and from what

areas. Whole provision has been modelled and this is where the savings

were identified. Also external consultants helped with these proposals

**Comment:** But what if courses can't now run - this could impact further.

**Answer:** Year 1 - £1 million from transport budget, which comes from Children's

Services budget which is made up as follows:

these services from large budget cuts

The rest; e.g. Youth and Connexions services have been hit the hardest along with management and back-office support functions.

Question: £3,654 saving on unsuitable routes, how is it justifiable? Savings vs

safety

**Answer:** Environment does not contribute to suitable walking routes – it is about

traffic and walking conditions.

**Answer:** £1 million cut off £5 million transport fund for older people

Question: Unsuitable travel, even though doesn't include lighting is unsafe now

**Answer:** Unsuitable not unsafe

**Question:** Impact of low numbers meaning course can't run.

**Answer:** Incredibly complex, transport being just one factor that could increase

unavailability – we can't say that these proposals will reduce availability.

Currently pupils don't have a choice around all "A" levels now.

**Question:** Clarification of proposal 2 – have designated 6<sup>th</sup> Forms gone?

**Answer:** Existing DTA's for schools continue

**Question:** If they are currently eligible for transport in Y1 of lower sixth will they get

transport for Y2?

Answer: Yes

Question: Inconsistencies in current system, could this not have been looked at

before these cuts?

**Answer:** 23,000 journeys per day, some provision is case specific, there is a

rolling programme looking at each area to review current practice. Cost

per mile is comparable to other similar authorities.

**Question:** If pay termly why are they penalised yet Council tax is not

**Answer:** The cost is to cover administration, more instalments = more cost. We

are not legally entitled to charge for the collection of Council Tax. Do

feedback your views on charging for instalments.

**Comment:** Support for single parent very difficult now.

**Question:** County Council; how can it ignore paragraph 23.5 of transport guidance

**Answer:** All areas have been looked at and large cuts have been made

more expensive.

Answer: Sometimes we buy tickets on service buses, if none available we will put

on contracted transport. Providing contracted transport in some circumstances can be less expensive than buying tickets on services.

Question: Impact of more buses going through Leadenham village

**Answer:** Would be less as more would go to Newark.

Question: What other cuts are the Council making?

**Answer:** £100m Budget; £30m transport, £35m Social Care, the rest is for other

services; e.g. connexions, children's centres. We have to remove £22m from the £100m. We have costed statutory 'must do' services and then

Question: You are proposing to provide transport to nearest college even if course

not available there.

**Answer:** We don't transport now to any 6<sup>th</sup> form/college for e.g. "A" level courses,

only for vocational courses, where a course is not offered. These cohorts tend to be small and so can involve expensive modes of transport

against the normal flow of transport.

Question: 1200 responses received. Is this how many you expected?

**Answer:** No expectations, but responses are still coming in.

Question: Students have been having interviews and think they are going through

with this with transport.

**Answer:** Have been receiving applications for transport, where affected we have

written pointing out these proposals and pointing out they may not get

transport.

**Comment:** Music only available at Nottingham and Lincoln. Travelling to Nottingham

is too expensive on train, so has to be Lincoln. These proposals will

prevent talented young people succeeding.

Question: What is the point of transport to nearest college if course not offered

there?

**Answer:** We currently do not transport to a place where a preferred academic

course is offered at a college. But, in addition, transport is always offered

to the nearest school 6<sup>th</sup> form as well as the nearest college.

**Answer:** Would require more uniformity between colleges to get these savings

e.g. which 3 days will they only be open for?

**Question:** Why not phase in the approach over four years. e.g. 25% per year

**Answer:** Have to achieve most of the savings in year one.

**Comment:** Why so big an increase nothing else has gone up by this amount?

Question: Will you be training staff to ensure that these changes are brought in

correctly and will there be an appeals process?

**Answer:** Yes, appeals provision will be in operation. To date the current staff

understand very well the current arrangements and would expect them

to easily adapt to these changes.

**Comment:** Unintended consequences e.g. participation rates and also affects on

institutions who have invested in courses/tutors, all of which will impact

on the economy of the Country.

**Answer:** The council tax freeze helps all people in Lincolnshire rather that any

Question: Have we worked out the cost to each household to fund this?

**Answer:** No – we have agreed to keep Council Tax the same

**Comment:** Need to continue to be responsible for our children's future, the increase

needs to be means tested in some way

Question: What arrangement has been made to assess the impact of these

proposals?

**Answer:** Initial equality impact assessment (EIA) directed us to do a partial EIA,

Parent Carer Council is present here tonight to help feedback their views

as a representative group.

**Comment:** Can you look at means testing? **Comment:** Can it not be spread over two years?

**Comment:** Can a monthly payment scheme be offered to people more widely?

Comment: Do we know what will happen if people can't afford this?

**Question:** How many won't be able to pay?

**Answer:** We don't know this as we do not currently means test.

**Comment:** Could you not have asked on the questionnaire would you be able to

afford it?

Question: Won't 6<sup>th</sup> forms just get full up and colleges shrink

**Answer:** Young people have a choice over where they can study and schools and

colleges will no doubt respond to any changes in choices that young

people make.

**Question:** What are the consequences?

**Answer:** When charges were first introduced we did not see a reduction in

numbers or when it increased, but we do accept that EMA was in place

then.

**Question:** Are you prepared to means test?

**Answer:** Has come out as a question from all consultations so far for us to take

back.

**Question:** Have you had discussions with industry/business to stimulate some form

of apprenticeship work etc. for those not going to post 16 education?

**Answer:** Yes we have

**Question:** Service quality issues

**Answer:** Have you reported them? – Yes to the bus company, but also report to

us (Transport Services Group) as we contract the services.

Question: Why should we stop/reduce subsidy just because other authorities have

done?

**Answer:** We are a generous authority and also spend more on transport. The

authority does have to make tough decisions based on priorities.

Question: The effect of these proposals on Stamford College is high, if you don't

transport pupils they will not be able to get here as there is no service bus. Why not give £533 to the pupil or college and let them run their own

transport provision or make their own choice.

**Answer:** This has been mentioned previously.

**Comment:** If you get it wrong there is no turning back

**Question:** Have you been to every secondary school and made all parents aware?

**Answer:** Consultation launched on 5<sup>th</sup> January using the Council's website and at

the same time all school and colleges were contacted and asked to make students and parents aware using posters and entries into

newsletters etc. We have not written to all parents individually.

Question: This is a substantial increase above RPI – will future years be increased

only by RPI?

**Answer:** Members recognise this is a substantial increase and are not expecting

to substantially increase again, only in line with inflationary increases.

Comment: Please state which inflation model is to be used in the policy so we

know.

Comment: If previously increased by RPI then this hike would not have been

necessary.

**Question:** Do we pay when they start 6<sup>th</sup> Form or October?

Answer: Payment in made at the beginning of September in advance of the

travel.

**Question:** Been told will pay £390 by LCC already.

**Answer:** We are still consulting, these are proposals.

Question: I am paying £280 not £202

**Answer:** We'll take your details and get back to you – this has since been

resolved and a payment of £202 was confirmed

**Question:** Was a consultation done when these were first brought in?

**Answer:** Yes – full public consultation did take place.

Question: Now 8<sup>th</sup> March and first I have heard of this.

**Answer:** There were 3 public consultation events advertised from 5<sup>th</sup> January with

a further additional one (ie this one in Spalding) added at the request of Elected members. Each event has increasingly become better attended and we have had over 1200 replies to the on-line survey as well.

Yes this was late notice for this event, but others were advertised.

**Question:** Why the approved list of courses – where did they come from?

**Answer:** Members chose them to reflect the needs of Lincolnshire's economy and

desire to preserve specialist land based courses. If you feel that there should not be such a list or that the courses listed should be different

then please feed this back.

**Comment:** But Every Child Matters

Question: Year 11's are already looking at university courses; these proposals

restrict post 18 choices

**Answer:** We don't do that now – we do for vocational courses, but not "A" levels.

Agreed this will impact on vocational choice

\_\_\_\_

Question: But you do for some A levels, don't you?

**Answer:** Yes, if a student can confirm that a university course states a specific

subject as an entry requirement, then we will consider transport.

\_\_\_\_\_

**Question:** LLDD vague criteria – who decides?

Answer: Additional Needs Service, Heads of Schools and Connexions Service

make decision as to where the child's needs can be met.

**Question:** What criteria will Additional Needs use? It all sounds vague.

Answer: These arrangements are already in place for current children with

additional needs, this is not new. Decisions are often made on a case-

by-case basis based on medical need.

Question: Can you confirm that those already in year 1 of a sixth form/college

course will still get transport but those due to start in September will be

affected?

**Answer:** Yes that's right, year 2 school/college course needs to show progression

of the subject i.e. the same subject progressed and not a new unrelated

course.

**Question:** Question was related to a specific case of a shorter distance.

**Answer:** If anyone wants to dispute lines drawn on shortest distance then come

back to us with your example.

**Question:** Why is there a greater that 23% reduction?

Answer: We agree we are disproportional affecting the transport budget -

Children's Services budgets are made up as follows (in broad figures):

e.g. £100m – total budget for all Children's Services

£35m – Child Protection Work

£30m - Transport

£10m - Youth Work/Connexions

Others e.g. back office functions, commissioning and performance

management.

We have not applied 23% across the board as we want to protect some services e.g. Child Protection, which means that other services have to

take a harder hit e.g. connexions/Youth work.

**Question:** Why have you chosen to cut the budget this way and not on others?

**Answer:** These are political decisions and have been put forward as proposals.

\_\_\_\_\_

Question: This is too big an increase in one go, why not 50% in year 1 then rest in

year 2 to reduce the pain?

**Answer:** This message has been consistently made at the other events and has

been taken on board and noted by Elected Members.

**Comment:** 3 miles in Lincolnshire is often on roads with no pavement, bends etc, or

at least a good proportion of the three miles.

Question: Is £30m figure just on School transport or is it also including taxi fares for

Foster Children?

**Answer:** Just home to school/college transport.

**Question:** If we pay more will we get better quality buses?

**Answer:** Quality has been raised before. Advise you to inform Transport Services

Group and/or operator also as we commission the service. Not all provision is poor so do feedback specific issues – there is a general

trend to under report.

**Question:** Why is it not a Legal requirement to have seat belts?

**Answer:** Some are service buses and open to the public. Council meets

requirements by Law but to fit seatbelts and newer buses will ultimately

increase costs

Question: Parents and students don't have choice as to what is offered, currently

use EMA to pay for transport, simply will not be able to afford this. There are few jobs available to supplement income whilst learning. Any further

thoughts how parents or those on benefits can afford this?

**Answer:** Recognise double hit of this and loss of EMA. The Government has said

that it will replace the EMA with "targeted support for those who face genuine financial barriers to participation". We assume this relates to the, now un-ring fenced, Learner Support Grant that goes into schools/colleges, but we recognise that this grant will not be the same

size as that of the EMA.

**Question:** Have they thought about unintentional consequences?

**Answer:** Point made at all meetings so far. We do have to take tough decisions to

meet financial pressures.

Question: Just too much of an increase

**Answer:** We will ensure this is made clear to members.

\_\_\_\_\_

Question: Has consideration been taken where taxis' are used to transport

individuals where they could catch a bus and walk from one school to

the other where only about ½ mile away

**Answer:** Review team does do this on a rolling basis and is making substantial

savings, approx. £600k to date.

**Question:** If majority of people disagree, what next?

**Answer:** It is a Political decision so please do contact your Elected Member.

Following these events your views and those received through the online/paper consultation will be summarised and presented back to the Children and Young People's Scrutiny Committee. They will make comments/recommendations before it is passed to the Executive for

decision.

**Comment:** Quality of buses, LA – does nothing and bus companies think you're

stupid. I would recommend that people actually contact VOSA as they

have been effective in the past.

**Comment:** £1.06 to £2.05 nearly 100% increase – on a daily basis. Doubling is just

too much and it looks like pupils won't want to do the course anyway.

**Comment:** By Principal of Stamford College

All four college Principals have been objecting, please do go on-line and give your thoughts. There is a view that this is a done deal and already children are coming back to us saying they can't come to the college now. New Stamford College will make transport provision for children if

LCC does not.

Question: But can you afford it?

**Answer:** I'll have to find where to get the money from by making cuts elsewhere.

**Comment:** Really pleased to hear what you have just said. I am a student too and

wouldn't be able to afford both myself and daughter to study. Only

Stamford offers the course for my daughter.

**Question:** I still pay all my taxes but yet no local transport services.

**Answer:** You would get transport to a college or 6<sup>th</sup> Form if the distance is over 3

miles, but not necessary for the preferred course.

Question: First the increasing of the leaving age and now reduced access to

preferred course plus benefits start to taper off post 16...

**Answer:** Raising the school leaving age to 18 is not quite right; it is a participation

age that is raised i.e. non-statutory. Statutory school age is still up to 16.

This point has been noted from other sessions too.

Question: Daughter going to Stamford, but now not eligible for transport

**Answer:** She will be able to get transport for the second year of her course.

**Question:** If service already runs now I'm prepared to pay to get her there.

**Answer:** This would change with the proposals as transport provided by the

Council would be to nearest 6<sup>th</sup> form or college only.

**Question:** Would you consider transporting to a hub to allow children to then

transport to connexions put on by college?

**Answer:** Complex but noted: often it is easier to see how this might work for

individuals but difficult when considering all travel requirements.

**Question:** If people are paying for the bus why can't you just run it?

**Answer:** Subsidised by Council so generally cost prohibitive.

**Question:** Money would be wasted if people do courses that don't work

**Answer:** We are not stopping people going to any college, we just won't transport

them there if it is not their nearest.

\_\_\_\_\_

**Question:** If in future you will be transporting less people, will we be charged more?

**Answer:** No - contracts would be retendered as fewer places, this would then be

cheaper.

**Comment:** Best proposal tonight is the hub model. Call connects exist but you have

to pay for it

Question: What if can't afford it?

**Answer:** Council opinion is £2 per day is affordable in these proposals.

**Question:** Have you worked out how many people will be on the dole if courses are

over-subscribed? For example what if I can't get on a course in a 6<sup>th</sup> form (where I could walk to) as there are only 30 places, but say 60 applied I would then have to pay to go to Boston, but I can't afford this?

**Answer:** It is not possible to model this as there are many variables involved.

Question: Everyone wants to be transported to Stamford and not Boston, so why

can't you allow this?

**Answer:** Significant numbers go from Spalding to Boston already and large

numbers go to Stamford too.

Comment: Can't go to college

Can't go to University No Doctors, Lawyers All then paid to sit at home

**Comment:** Difficult to get young people motivated on a course they don't want to do.

Question: Can't you give every child an amount of money and let them decide

where to go and if more, then they pay the rest

**Answer:** Practical suggestion if there is a local bus service, but infrastructure

does not support this. An alternative view is to give money to

school/college to sort.

**Comment:** Buses will follow the money

**Comment**: LCC should be supporting the choices of young people

**Comment:** We don't feel we have a choice
