The growth in numbers of children with a child protection plan has grown over the last three months, meaning that out of a population of 139900 271 children had a plan at the end of March. The target was therefore not met and is 2.37% over the planned situation. Reasons for this, upon research, appear to be the arrival with plans of several families where there are above average numbers of siblings (5, 6,7 or 8). The figure should also be set against the reducing numbers of children looked after which has now falled steadily over the last few months and this means that risk is being managed at home rather than in care. A training session with team managers and conference chairs is planned in late May to look at thresholds for the calling of conferences to ensure a level of consistency. The target for next year may need to be revised. Child protection planning represents a robust multi agency opportunity to safeguard children, but is to be seen within the continuum of child in need and team around the child planning.

Each individual delay is followed up by the Child Death Administrator and, where appropriate, by the Child Death Review Panel Chair. There has been an improvement over the last few months but the Panel recognises that further work is necessary in order to achieve our target of all eligible child deaths being reviewed within six months. This matter is being addressed by the Chair of the Panel.

Commentary from provision Planning used for the School Capacity Collection return:

Replacing some separate infant and junior schools with primary schools has taken place in recent years with three mergers complete with new buildings which has taken out significant levels of surplus capacity. Two further mergers were refused by the Schools Adjudicator due to the 'rural' classification of the schools involved, denying the LA the opportunity to reduce surplus places and improve facilities. Part of the plans for one of the new Lincoln Academies currently in the process of being built will see an infant and junior school brought together with a secondary school for the first all-through 3-18 school in Lincolnshire (the Priory Witham Academy) along with the first primary Designated Special Unit on the same site. 150 secondary and 40 primary surplus places will be removed as a result of this one project which will be completed ready for September 2011.

The LA has developed a policy to remove surplus places in the primary sector (The Primary School Provision Policy) which was approved in December 2006. The use of a sophisticated matrix model

- reductions in Published Admission Number (PAN) to logical numbers
- removal of temporary classrooms and other redundant buildings
- federations and mergers of primary schools
- closure of educationally and financially non-viable schools (tempered by the fact that these are often rural schools)
