1. C4EO theme and priority which is the focus

Early Years - Narrowing the gap in outcomes for young children through effective practices in the early years

2. Brief summary of support proposed

- In 2009/2010 C4EO supported Lincolnshire County Council Children and Young People Scrutiny Committee to undertake a scrutiny review into narrowing the gap. This review was carried out between December 2009 and June 2010 and focussed on interviews with relevant staff in Children's Services; visits to Moorland Children's Centre in Lincoln and Mablethorpe Children's Centre, combined with interviews with parents and a range of contributors and practitioners; and questionnaires to the catchment schools and Heads of Services for the three wards. The review was supported by a sector specialist from C4EO who provided expert guidance, advice and research throughout the review. The report to Scrutiny contained an offer from C4EO to provide further support to progress a number of the recommendations including those relating to transient coastal populations. This support was agreed with C4EO in June 2011.
- From June to August 2011 C4EO supported Lincolnshire County Council with further research into the needs of transient populations in coastal regions. This was reported

in August 2011. The report of the research undertaken, which included gathering examples of best practice where possible, concluded that it would be necessary to work with relevant children's centres to develop local solutions within the specific a local context. It was agreed that this would be the focus of a second phase assignment.

- Further findings and recommendations arising from this support work will be fed into the report to Scrutiny at the end of this calendar year
- This scope was revised at a meeting on 09/01/12. Since the initial scope the children centre in Mablethorpe has received a very positive inspection including outstanding judgements for its work on Narrowing the Gap. In light of this and other local developments this scope has been refocused to examine the barriers and opportunities for engaging the populations of a number of small rural populations in the Mablethorpe reach area, between the Mablethorpe and Skegness settlements i.e. Sutton on sea, Ingoldmells, Hoggsthorpe, Chapel St Leonards. The activity undertaken will explore why those in these areas do not access existing provision and potential new delivery models. An additional benefit from this activity will be improved relationships with Health to ease the sharing of information.
