Subject:	Lincolnshire County Strategy for Post 16 Learners with Learning Difficulties and or Disabilities

Summary:

This report invites the Children and Young People Scrutiny Committee to consider Lincolnshire County Council's Lincolnshire County Strategy for Post 16 Learners with Learning Difficulties and or Disabilities (LLDD) which is due to be considered by the Executive on 3rd July 2012. The views of the Scrutiny Committee will be reported to the Executive, as part of its consideration of this item.

Actions Required:

- 1. To consider the attached Lincolnshire County Strategy for Post 16 Learners with Learning Difficulties and or Disabilities and to determine whether the Committee supports the recommendation(s) to the Executive set out in the report.

1. Background

This is the fourth strand of the Special School and Mainstream Unit provision review. As a part of this wide ranging review it was agreed that a review of post 16 LLDD provision be undertaken and a strategy agreed so that the County Council is well placed to meet its obligations in respect of this group of vulnerable learners.

The Executive is due to consider the report on the Lincolnshire County Strategy for Post 16 Learners with Learning Difficulties and or Disabilities on 3rd July 2012. The full report to the Executive and the Strategy are attached at Appendices A and B.

2. Conclusion

Following consideration of the attached report, any comments agreed by the Children and young People Scrutiny Committee will be passed on to the Executive on 3rd July 2012 to inform and assist the decision making process in respect of the adoption of this Strategy as Lincolnshire County Council Policy.
