Contact details

This proposal has been published by Lincolnshire County Council, County Offices, Newland, Lincoln LN1 1YQ regarding the discontinuance of Tennyson High School, Seaholme Road, Mablethorpe LN12 2DF.

Implementation

The proposal is to discontinue Tennyson High School with effect from 31 August 2012 on the condition that Monks' Dyke Technology College expands with effect from 1 September 2012. It is proposed that all pupils attending Tennyson High School at the time of closure will transfer to the roll of the newly expanded school. This proposal (when linked with the related expansion proposal at Monks' Dyke Technology College) will provide sufficient school places for current and forecast pupil numbers in the secondary sector in Louth and Mablethorpe whilst at the same time providing the platform to improve educational standards and opportunities for the young people in the area. If the proposals are implemented the enlarged school incorporating sixth form provision will operate on both the current sites of the two existing schools in Louth and Mablethorpe, therefore retaining secondary education in the town of Mablethorpe.

Consultation

Monks' Dyke Technology College and Tennyson High School have been working together in a formal Federation since February 2010. Before that the two schools have worked in partnership since September 2008. Merging the two schools is the final step in the original long-term plan agreed by the governing bodies at the time. The federated governing body of the two schools requested that the Local Authority (LA) consider the proposal to merge the schools and the LA agreed to facilitate the statutory consultation process. Under current legislation the LA is the decision maker for the proposal.

Consultation originally began on 1 December 2011 with a letter and consultation document being sent to all parents of pupils attending the schools informing them of the proposal. Interested parties were also informed as required by guidelines issued by the Department for Education (DfE). During the consultation period two public meetings were held on 12 December with one at Monks' Dyke Technology College and one at Tennyson High School.

These meetings allowed those having an interest in this proposal to be able to gather information, ask questions and get involved in the debate. All parents/carers and other interested parties were given the opportunity to respond as part of the consultation process by 26 January 2012. The headteacher and the staff at both Monks' Dyke Technology College and Tennyson High School have discussed, and are continuing to discuss, the proposal with the pupils currently on roll.

All applicable statutory requirements to consult in relation to the proposal were complied with.

Objectives

The proposal detailed in this document is to discontinue Tennyson High School with effect from 31 August 2012 on the condition that Monks' Dyke Technology College expands with effect from 1 September 2012. The objective of these related proposals is to enhance the standard of provision of secondary education for pupils in Louth and Mablethorpe by creating high quality learning environments which will stimulate and enrich students' learning. The LA considers this proposal to be in the best interests of local children and educational provision in the area. It reinforces the priorities in the Children and Young People's Plan and supports the Council's aim of ensuring that as many children as possible can reach their full potential.

There are many advantages to the proposal to close Tennyson High School when considered alongside the related expansion proposal at Monks' Dyke Technology College. The LA has a duty to balance the raising of standards with the maintenance of diversity of provision, parental choice and a focus on local communities. The proposal will create the conditions for the newly expanded school to achieve this and enable children and young people in the communities to access strong educational opportunities.

The LA would not be actively participating in this process if it did not see significant advantages for children and young people, their parents/carers and the local communities and supports the related proposals for the following reasons:-

- To enable the process to continue to the next stage and allow a further opportunity for people and organisations to express their views about the proposals and ensure that they will be taken into account by the Executive.
- To enable the statutory and legal processes to proceed.

- The DfE has made it clear that unless a structural solution can be found that will improve standards at Tennyson High School then it will impose its own Academy solution outside of the control of the schools and the LA.
- It will enable better and more effective use of resources so that all pupils can have access to the facilities at both sites.
- The merged school will be able to provide a full range of courses to meet students' academic and vocational needs. This greater curriculum choice, including access to specialist vocational facilities, will provide the opportunity for young people in Louth and Mablethorpe to achieve their maximum potential.
- Access to a comprehensive menu of study support activities throughout the year will be provided as an integral part of this wider curriculum.
- The LA believes that the formation of the merged school will provide the opportunity for standards and results to improve.
- The merged school will retain the appropriate number of secondary school places in Louth and Mablethorpe and help to ensure that secondary education continues on both sites so providing significant stability to the education of young people in the local area and ensuring that secondary provision remains sustainable for the future.
- The revised staffing structure and other economies of scale that will follow the reorganisation as one school will enable better management of costs and assist in managing the existing budget deficit.
- The proposal will enable wider access to a range of extended services and improved opportunities for community and family learning supporting the LA's Children's Services vision and the Children and Young People's Plan.
- The merged school will benefit from the expertise and leadership of the senior management teams from both schools.
- The proposal will offer wider development opportunities for all staff, which will help maintain stability and provision of high quality teaching and learning whilst enhancing recruitment and securing the quality of staffing. It will also enable a greater focus on the development for senior and middle leadership models so increasing leadership capacity.

Standards and Diversity

The educational challenges faced by Tennyson High School are not temporary in nature but are features of the size and nature of the school and the context within which it operates. Progress has been made in addressing standards through the federation by drawing on the strengths of both schools. Importantly, the collaboration has also brought new opportunities to Mablethorpe students: a broader curriculum and a wider range of extra-curricular activities which could not have been supported by a smaller school on its own. The governing body is convinced that merging the schools will only add to this richness and help to ensure equality of opportunities for students of all abilities in both Louth and Mablethorpe.

There are a number of justifications for the closure of Tennyson High School from an education perspective. These focus on the following:

- 1. current and future standards of attainment
- 2. breadth of curriculum (diversity)
- 3. recruitment and retention of specialist, high quality teaching staff
- 4. financial sustainability and falling rolls

1. Current and future standards of pupil attainment

• The results for both schools at Key stage 4 using the measure of the percentage of pupils achieving 5 or more A*-C including English and maths (5ACEM) remain below the average for all Lincolnshire Schools. Recent results at both schools show some fluctuations. Although there has been a significant dip in attainment on the 5ACEM measure at Mablethorpe, there are verifiable indications that standards will recover substantially in 2012 restoring the overall pattern of improvement. The LA believes that advantages detailed in this document that will come with the formation of a merged school will provide the opportunity for standards and results to improve further.

• The predictions for the results for a merged school indicate an upward trend over the next two years towards the government's floor target of 50% for 2015. This should allow the governors and the leadership of the two schools to decide the future of the education on offer without the imposition of an external solution.

• Post-16 provision accessible to students at both sites will be significantly improved by the merger enhancing relevance, motivation and ultimate achievement.

• Access to a comprehensive menu of study support activities throughout the year will be provided as an integral part of the wider curriculum and therefore help to enhance pupil attainment.

2. Breadth of curriculum (diversity)

• Greater curriculum choice including wider access to specialist facilities across the federation will create a broad and rich opportunity for young people in Louth and Mablethorpe to achieve their maximum potential.

• All pupils will benefit from the potential curriculum expertise that will be on offer at each site.

• The potential to provide a much broader curriculum offer to all students at Key Stages 3, 4 and 5 will benefit all pupils.

• 'A' level expertise at Key Stage 5 in Monks' Dyke Technology College will benefit the Tennyson High School pupils with a greater breadth of subjects and courses available to all.

• The existing provision of the English Baccalaureate will be secured for all pupils on both sites.

3. Retaining and recruiting high quality teaching staff

Most secondary schools on or near Lincolnshire's east coast experience difficulties in recruiting qualified teaching staff with appropriate subject specialisms. One larger organisation across the two sites will offer greater career opportunities to existing staff and to potential future applicants when seeking to recruit high quality teaching staff.

These wider development opportunities will help to secure the quality of staffing and enable a greater focus on the development of senior and middle management whilst also maintaining the provision and stability of high quality teaching and learning. The new school will benefit from the expertise and experience of senior management teams at both schools.

4. Financial sustainability and falling rolls

The number of pupils entering secondary education in both areas is now falling as the low numbers from primary schools in recent years have fed through into the secondary sector. This is a trend experienced by many secondary schools across the county and these low numbers are set to continue for a number of years in East Lindsey. As the majority of school funding is calculated according to the number of pupils on roll this will have a negative impact on the level of funding received as numbers fall and put significant pressure on schools to remain educationally and financially sustainable. These financial pressures require careful planning to ensure that sustainable curriculum and staffing models are in place.

This proposal will help to provide a degree of financial stability and a better opportunity for long term, sustainable, high quality secondary education for children and young people in Louth and Mablethorpe. The revised reduced staffing structure, and other economies of scale that will follow the reorganisation into one school, will enable better management of costs and assist in dealing with a deficit budget situation. In the short term the two schools have already visited the staffing reduction panel for approval of their indicative proposals. The proposal will also enable better and more effective use of resources so that all pupils can have access to the facilities available at both schools.

Provision for 16-19 year olds

Tennyson High School is designated as providing education only for pupils aged 11-16 years. However, there is a very limited provision for sixth form education on site which has been made possible since the federation with Monks' Dyke Technology College. Post 16 provision accessible to students at both sites will be significantly enhanced by the merger. Although the proposal involves the closure of a school the replacement merged school will enable improvements in the range, participation and achievement in education and training for 16–19 year olds in Louth and Mablethorpe.

Need for places

The proposal to close Tennyson High School must be considered alongside the proposal to expand Monks' Dyke Technology College. These proposals are related and one proposal cannot go ahead without the other.

The current net capacity for Years 7 - 11 of Monks' Dyke Technology College is 1219 and the capacity of Tennyson High School is 425. If these proposals are implemented the proposed total net capacity will be a minimum of 1515. The current admission number in Years 7 – 11 for Monks' Dyke Technology College is 200 and for Tennyson High School this is 85. The proposed total admission number across both sites will be 200. In Years 7 – 11 there are currently 638 pupils on roll at Monks' Dyke Technology College and 296 pupils on roll at Tennyson High School. As numbers are falling in the area the proposal will provide sufficient places for current and forecast secondary pupil numbers with the capacity to increase if pupil numbers rise in the future. If the proposals are implemented the merged school incorporating the sixth form provision (capacity 250-280) will operate across both the existing sites.

Displaced Pupils

It is anticipated that pupils attending Tennyson High School at the time of closure will transfer onto the roll of the newly merged school operating across the two existing sites so that there will be no displaced pupils. Parents may also seek admission to other schools in the area which have places available should they wish to do so. Current and forecast secondary pupil numbers for the area indicate that all of the displaced pupils can be accommodated at the newly merged school.

Impact on the Community

There will be minimal impact on the community as the two existing sites will continue to operate as educational establishments with the same facilities with continued community use. Both schools currently deliver the extended services agenda which will not be negatively affected by the closure of Tennyson School and the LA believes that the proposal will actually lead to improved opportunities for community and family learning.

Travel

The newly merged school will continue on the two existing sites and so the current Tennyson High School pupils will not be displaced following the discontinuance of the school but will be able to continue their education at the existing sites. There will therefore be minimal impact on the current transport arrangements and journey distance and times for those pupils and this should not lead to any increased car use. No specific arrangements are proposed for the travel of any displaced pupils to other schools as pupils are expected to remain on roll at the merged school.

The County Council home-to-school transport policy will continue to apply – this provides free home-to-school transport for pupils to their nearest designated school (if it is more than 3 miles away for secondary aged pupils).

Related Proposals

The proposal to close Tennyson High School is related to the proposal to expand Monks' Dyke Technology College.

The separate statutory processes regarding these proposals are taking place in parallel, and will be determined together with each being conditional on the other going ahead, leading to the formation of one merged school across the two existing sites (with a new name which will be decided on later if the proposal goes ahead).

Special Educational Needs (SEN) provision

As education is continuing on the two existing sites there is likely to be no impact on SEN provision other than an opportunity to improve the provision with better access to resources and consistently good quality teaching, learning and leadership at the newly merged school. Consideration of pupils with SEN will take place should there be any relocation of pupils to an alternative part of the existing sites and physical access will be assured should a need be presented. The LA will continue to look to make improvements in the standard, quality and/or range of the education provision for children with SEN.

As education is continuing on the two existing sites there is likely to be no impact on SEN provision other than an opportunity to improve the provision with better access to resources and consistently good quality teaching, learning and leadership at the newly merged school. Consideration of pupils with SEN will take place should there be any relocation of pupils to an alternative part of the existing sites and physical access will be assured should a need be presented. The LA will continue to look to make improvements in the standard, quality and/or range of the education provision for children with SEN.

Need for places

The proposal to close Tennyson High School must be considered alongside the proposal to expand Monks' Dyke Technology College. These proposals are related and one proposal cannot go ahead without the other.

As detailed earlier in this document, under "**School Capacity and Site**", the proposal will provide sufficient places for current and forecast secondary pupil numbers in Louth and Mablethorpe.

Expansion of successful and popular schools

The Government is committed to ensuring that every parent can choose an excellent school for their child with the wishes of parents being taken into account. There is a strong presumption that proposals to expand popular and successful schools should be approved. The latest Ofsted report rated Monks' Dyke Technology College's overall effectiveness as satisfactory with an effective leadership. Whilst standards at the college have been below average in the recent past the Ofsted inspectors felt that these are now rising and the proportion of students who achieve the 5ACEM measure has increased. Responses from parents to the questionnaire conducted during this Ofsted inspection were extremely positive with the overwhelming majority saying that their children are taught well at the college.

PROPOSAL TO MERGE MONKS' DYKE TECHNOLOGY COLLEGE AND TENNYSON HIGH SCHOOL

PUBLIC CONSULTATION MEETING AT TENNYSON HIGH SCHOOL at 6.00pm on 12 DECEMBER 2011

PANEL MEMBERS: Paul Holmes (LCC) Tim Mudge (Chair of federated governing body) Dr Chris Rolph (Executive Headteacher)

Tim Mudge introduced the evening and re-affirmed the governing body's unanimous commitment to maintaining secondary education provision in Mablethorpe and to provide the best solution for the children and young people of Mablethorpe.

Dr Rolph summarised the background leading up to the current proposal.

Paul Holmes explained that this meeting is part of the consultation process on the proposal to merge the two schools but which technically is to close Tennyson High School and expand Monks' Dyke Technology College to form one enlarged school over two sites. He introduced the members of the panel and confirmed that there were also officers from LCC and CfBT present to assist in answering any issues raised. The purpose of this meeting is to give members of the public opportunity to find out more about the proposal and express their views and Paul also stressed the importance of returning a response form to enable all issues raised to be taken into consideration in the decision making process.

Approximately 25 people in total attended the meeting including Local Authority officers, parents and other members of the public.

The following is a record of the questions and answers at the meeting.

- **Q** I appreciate issues of falling rolls, particularly at Monks' Dyke, with the financial implications surely the common sense approach would be to incorporate the two schools into one building and not maintain two sites.
- A If this was looked at purely as an exercise in numbers then this might be the answer. But we are talking about young people not numbers. The LA preference is to maintain education in Mablethorpe and the governing body support this. A town of this size needs a secondary school. The model proposed allows for staff and for pupil movement on certain days. The governing body appreciates there are financial challenges but is committed to providing secondary education in Mablethorpe.
- **Q** I agree we don't want children to travel unreasonably but this proposal must be financially viable. Will keeping two sites be financially viable?
- A The governing body is not complacent and appreciates it will be a challenge but will make every effort to ensure the merged school is a success. LCC also believes it is important to maintain secondary education in Mablethorpe and will work with the governing body to try to ensure that one school over two sites will work successfully.

- **Q** Can you guarantee that in a couple of years the site in Mablethorpe will not close down anyway. Will the merge become a closure?
- A In some parts of the county schools have had to close. We will do everything in our power with the governing body to ensure that the two sites remain. There is a decline in secondary rolls. We have to get the balance right and maintain enough provision for the future. There is however no absolute guarantee but we will do our best.
- **Q** In the past in other areas parents have agreed to a merger as they were promised a "super new school" which then hasn't materialised and people have had to be taught in portakabins. Will this happen here?
- A There is no promise of a "super new school". There is no capital available to deliver this. We aim to maintain both sites with the current buildings. There is no "behind the scenes" plan.
- **Q** I am concerned about transportation costs. Will pupils have to pay?
- A LCC policy will apply. The policy is to provide transport to the nearest appropriate school if this is over 3 miles, or less than 3 miles if not a safe walking distance. If pupils have to travel between sites, this will be free for those aged 11-16 years. In addition under the proposal subsidised transport will be provided for the first time for students travelling from Mablethorpe to Louth.
- **Q** But what if you live in Louth and a subject such as Maths is at the Mablethorpe site?
- A All core curriculum subjects for Years 7-11 will be offered at both sites. We will aim to minimise travel. Subjects at A level will be offered according to demand as is the current practice.
- **Q** Money is an important issue will there be a bursar or will the governing body supervise?
- A The new staffing structure has not been produced but the bursar's role is an important one and I'm sure that there will be at least one financial manager for the merged school.
- **Q** Will the uniform change?
- A Yes. It is important that we build an identity for the new school so that pupils feel that they are a part of one school whichever site they are at. A new uniform will help here, but despite whatever rumours are around, no decisions have been made. As part of this new identity the governing body is also looking at a new name for the merged school.
- **Q** The majority of 6th form provision will be in Louth transport is subsidised but not free. As the Educational Maintenance Allowance has also been withdrawn will this put young people off going into 6th form?
- A Across the whole county this has had an impact. But the merger should not exacerbate this. In fact the merger proposal should help as previously there was no entitlement to subsidised transport for 6th form students from Mablethorpe to Louth.

- **Q** If the merger proposal does not go ahead I understand that the school could not continue so do we have a choice?
- A Projections indicate that as a standalone school Tennyson would be under severe pressure, but I must emphasise that this is a positive choice to merge.
- **Q** Are we looking at staff reductions?
- A There will be staff reductions if the proposed merger goes ahead although the new staff structure has not been consulted on yet. However, equally, there would have to be staff reductions if the merger does not go ahead.
- **Q** Will the uniform changes be on a rolling programme or would parents be expected to buy the new uniform from day one of the new school?
- A It would unreasonable to insist an immediate change but equally we cannot allow some pupils to continue in the old uniform for 4-5 years. We will be reasonable about this. We are having conversations with LCC about the possibility of support for parents with the new uniform. This is the type of issue that will be discussed by the transition board. This is an opportunity to look at the uniform at both sites and address any issues.
- **Q** What will be the impact on staff?
- A Some will be assimilated into their posts some may have to go through a selection process. If so this will be open and fair and based on skills and knowledge.
- **Q** Will staff keep their pensions?
- A Yes.
- Q Will staff pay be affected?
- A Some may be affected but this would happen without the merger too as the school would have to re-organise due to falling rolls and financial pressures.
- Q What will happen where two different examination boards are being used for same subjects?
- A Every pupil will be able to complete the course of study with their existing examination board. Choice of examination boards will eventually be brought into line across both sites as they will comprise one school (and this is happening anyway). This is only a temporary issue and will present no significant long term issues.

- **Q** Will the type of courses offered be affected by the merger eg BTECs or GCSEs?
- A We will do as we have always done ie offer the courses that are right for the children. The proposed merger will benefit the children as it will enable the offer of a wider curriculum across both sites.

He introduced the members of the panel and confirmed that there were also officers from LCC and CfBT present to assist in answering any issues raised. The purpose of this meeting is to give members of the public opportunity to find out more about the proposal and express their views and Paul also stressed the importance of returning a response form to enable all issues raised to be taken into consideration in the decision making process.

Approximately 20 people in total attended the meeting including Local Authority officers, parents and other members of the public.

The following is a record of the questions and answers at the meeting.

- **Q** With regard to travelling between the two sites, did you say that pupils would stay at one site for the whole day but staff might travel backwards and forwards? This would be very disruptive for staff and pupils.
- A We would do everything to minimise travel between the two sites to avoid extra travel and stress. Staff must be prepared to work at either site but we would not expect this to be backwards and forwards for one or two lessons only for reasonable periods of time.
- **Q** I understand that you wish to provide education in both towns and provide equal opportunities for young people and you have the support of the LA in this. There has been much talk of Academy status in the area does this figure in your plans?
- A No.
- **Q** But what about the foreseeable future?
- A It will take at least a year to establish the newly merged school. We cannot tell what will happen in the future. Our aim is to make this proposal work and have a successful school. If there is a proposal for an Academy at a later stage this will be a completely separate issue the governing body in place at that time would have to make that decision.

- **Q** The governing body has been looking at the issue facing provision of education in Louth and Mablethorpe for several years with support of LA and C*f*BT. The issue of an Academy has been raised by the Save Our Schools Group and brought into public domain by the media leading to some public in Louth being confused over the issue.
- A Noted. However as the government has promoted Academies then all governing bodies must consider this option and make their own decision.
- **Q** If a lot of other schools in the county transfer to Academies will the loss of money to the LA mean less funds are available for home to school transport?
- A The LA pays for home to school transport (subject to the transport policy) both to maintained schools and Academies this is a statutory duty. The policy is to provide transport to the nearest appropriate school if this is over 3 miles, or less than 3 miles if not a safe walking distance. The funding used is separate to normal school/academy funding.
- **Q** Will there be problems for children if the 2 schools are offering subjects with different examination boards?
- A Any pupil who has commenced a course of study with one examination board will be able to complete it. Since the hard federation the governing body has been looking at bringing examination boards into line. This will be a minor issue in the short term only and will not present any difficulties in the long term.
- **Q** Please do not put letters into school bags as parents may not receive them.
- A We will make every effort and use all appropriate means to communicate with parents and other interested parties. In addition if this proposal continues to the Representation period then the statutory notice will be published in the local press, at the school gate and within the community.
- **Q** I can only assume that the very low turnout at this meeting indicates that parents are happy with this proposal.
- A Agreed. Many of the issues that might arise have already been resolved through the existing hard federation.

Consultation regarding the proposed merger of Monks' Dyke Technology College, Louth and Tennyson High School, Mablethorpe.

The governing body of Monks' Dyke Technology College and Tennyson High School have asked the Local Authority (LA) to consider the proposal to merge the above schools. The LA has agreed to facilitate the governing body in consulting on this proposal.

The proposal is to merge the two schools to create one LA maintained school across the two existing sites, therefore retaining secondary education in both Louth and Mablethorpe. It is proposed that this change would take effect from September 2012. In order to achieve this merger the process involved requires Tennyson High School to close on 31st August 2012 and reopen on 1st September 2012 as an expansion of Monk's Dyke Technology College onto the Tennyson site (therefore occupying two sites).

The consultation period regarding this proposal will run for six school weeks from Thursday 1st December to Thursday 26th of January 2012. There will be consultation meetings at Tennyson High School on 12th December at 6pm and Monks' Dyke Technology College on 12th December at 7.30pm. This will be an opportunity to raise questions and issues in response to the proposal. For those unable to attend the meetings a question and answers document will be published on the website and made available in hard copy on request.

This consultation period is the first stage of the process leading up to a final decision in June 2012. Any feedback received will be carefully considered when making any decisions on whether the proposal should proceed.
