26. SUBMISSION AND DEBATE OF PETITION

A report by the Chief Executive had been circulated.

The report informed the Council that a petition had been received, which exceeded the total number of signatures required to hold a debate at a meeting of the County Council.

In accordance with the Council's Petitions Scheme, Debbie Gutsell spoke in explanation of the contents of the petition concerning the proposed closure of Queen's Park School in Lincoln and then presented the petition.

The Chairman reminded the Council that the final decision on the proposed closure of Queen's Park School in Lincoln would be made by the Executive. Councillors were subsequently invited to debate the issues raised as part of the petition.

It was moved and seconded: -

"That the petition be received."

An amendment was moved and seconded as follows: -

"That the Council recommends to the Executive that Queens Park School, a very special school in Lincoln, remains open and that all options be considered and actions undertaken to ensure the sustainable future of this establishment."

The amendment, upon being put to the vote, was lost.

27. CHAIRMAN'S ANNOUNCEMENTS

The Chairman reported that his civic engagements since the last Council meeting had been varied and gave him the opportunity to continue visiting places within Lincolnshire, as well as some further afield.

He thanked his wife, Pauline, for supporting him on these engagements and also Councillor Robert and Mrs Maureen Palmer, Vice-Chairman and Lady, for representing them at civic functions when, due to other commitments, they had been unable to attend.

The Chairman was delighted to see that Lincolnshire had been named Britain's Favourite Food Spot this week. Voting took place through the summer with the public casting their votes between the various English counties and in Scotland, Wales and Northern Ireland. Over 22,000 people cast their vote and the Chairman stated that it was fantastic to be recognised nationally as the number one county for food.

On a sadder note, the Chairman reported the death of Councillor Barry Singleton, Deputy Leader of the County Council, who passed away after a long illness. Councillor Singleton represented the Sleaford West and Leasingham Division since his election to the Council in June 2001. The Chairman also reported that the Council suffered a further loss with the death of Mrs Sue Edmunds, a valued member of staff who worked for the County Council for 17 years. Mrs Edmunds died tragically in a car accident.

Councillors stood in silent memory of Councillor Barry Singleton and Mrs Sue Edmunds and then paid tribute to their memory.
