35. <u>SCHOOL NURSING – INFORMATION FOR SCHOOLS AND PARENTS</u> - <u>DVD</u>	
Consideration was given to a report and presentation by Joy Wood, Clinical Team Leader for Universal Provision, NHS Lincolnshire, which provided the Partnership with further information in relation to the services of school nurses.	
A DVD was shown to the Partnership, which was aimed at secondary school	

<ul> <li>pupils. It was highlighted that young people had acted within the DVD, and this would be broadcasted on Youtube to ensure that this reached the target audience. The actors and their parents consented to their participation within the DVD and they were all aware that this would be broadcasted on Youtube.</li> <li>The Partnership was provided with an opportunity to ask questions, where the following points were noted: -</li> <li>The DVD was available to all schools and Governors within the county;</li> <li>As the first point of contact was with the Head Teacher within each school, it was suggested to also write a letter to the Governors to provide them with information of this service within schools;</li> <li>40 schools had signed up to the service since September 2009;</li> <li>Certain schools within Lincolnshire employed their own school nurse but this service provided each school with a drop in session once a week with their designated school nurse;</li> <li>It was suggested that a list detailing which schools had and had not signed up to the sexual health element of this service should be sent to Andy Breckon, for information;</li> <li>There had also been a DVD created which was aimed at parent evenings at primary schools, providing parents with information on what services were provided by school nurses. The Head Teacher of a primary school could contact its nominated school nurse at any time to arrange a drop in centre;</li> <li>It was suggested that this DVD should be shown to the Learner Provider Group, for information.</li> </ul>	Rob Mayall

#### 36. QUARTER TWO PERFORMANCE REPORTS – OUTCOME LEADS

Consideration was given to reports on performance information relating to each of the five Every Child Matters Outcomes as part of the Children and Young People's Plan. Specific issues for each Outcome were highlighted, as follows:-

i) <u>Achieve Economic Well-Being</u>

took the Chair.

The overall position for Achieve Economic Well-Being was that performance remained strong across the range of partners contributing to this outcome.

An exercise with ten other counties was completed to compare the performance of young people Not in Education, Employment or Training (NEET). Lincolnshire performed considerably higher than the average within that group and it was the second highest performer within the group. Nottingham performed the highest and work was being completed to establish what work Nottingham was undertaking. It was also reported that work was being completed to establish how each Local Children's Partnership was performing against one another, where it was highlighted that East Lindsey was performing significantly high in terms of NEET.

Work was being undertaken to raise the awareness of what benefits were available for families with children. Job Centre Plus and Children's Centres were contributing to this piece of work to raise awareness within Lincolnshire.

A discussion took place regarding the take up of school meals within schools, where it was agreed that a report should be presented to the Partnership at its meeting scheduled to be held on 13 January 2010, for information.

#### ii) <u>Be Healthy</u>

The annual nature of the majority of Be Healthy Indicators made quarterly forecasts impossible, but it was highlighted that this would be addressed next year.

There had been a drop-off point identified for breastfeeding and this was within the first seven days. It was highlighted that mothers responded better to peer supporters rather than health professionals. The recruitment of volunteers had been taking place and the overall numbers were increasing. Volunteers would work on a rota system to ensure that there was a volunteer at hand to provide guidance and support to mothers breastfeeding.

Concerns were raised by the Partnership, as the majority of indicators were reported on an annual basis so the performance throughout the year could not be monitored. It was highlighted that work was being undertaken to ensure that the performance could be monitored on a monthly basis from next year.

The Partnership requested that it received a report at its meeting scheduled to be held on 13 January 2010, to consider information relating to obesity. It was highlighted that there was issues on a national scale in relation to the reporting of obesity figures but work was being completed to address this.

iii) Enjoy and Achieve

The take up by children and young people in the areas of arts, music and

school sport had been very encouraging and work would be undertaken around the Olympics to encourage further participation within Lincolnshire. It was highlighted that a number of children and young people had signed up to Lincolnshire's Athletics Programme.	
The indicators for exclusions continued to cause a concern however, the work of support services would continue to be directed at the schools facing the greatest challenge.	
A concern was raised around the changes in guidance to the School Improvement Plans. These changes made by Ofsted caused confusion for the Head Teachers and Governors within schools.	
iv) <u>Making a Positive Contribution</u>	
A number of issues had affected the availability of data for performance indicators within Positive Contribution: -	
<ul> <li>The Tell Us 4 Survey and sports survey were being completed in October/November so information was not available for quarter 2;</li> <li>The need to verify the recorded and accredited outcomes for youth work following the summary programmes.</li> </ul>	
The Tell Us Survey was an online tool which asked children and young people a number of questions around the five Outcomes. It was agreed that a report should be presented to the Partnership in relation to this for information.	Debbie Barnes
The indicator for the percentage of Children's Centre Partnership Boards with 50% or more parent representation was not performing well. Children's Centres continued to build their relationships with parents accessing services from their centres. Progress to this target was being monitored by Children's Services Team Managers and Principal Practitioners.	
v) <u>Stay Safe</u>	
Owing to the increase in the number of referrals to Social Care, there were some indicators that were underperforming. Between April and July 2008, 10,931 referrals were received. Between April and July 2009, 1,588 referrals were received. Children subject to a Child Protection Plan seemed to be stabilising and there had been a reduction of 20 to 519 children in public care.	
A suggestion was made, in relation to the indicator for the rolling average number of children killed or seriously injured in a road traffic accident for this year, to contact Lincolnshire Road Safety Partnership for most recent and accurate data.	
It was highlighted that the Terms of Reference for domestic violence had been signed off. There was a need for a clear process for referrals from the police	

to social care. Work would be completed in this area to address this.

#### vi) <u>Service Management</u>

The appointment of Deputy Outcome Leads within the Children and Young People's Strategic Partnership provided additional capacity, strengthened the role of all agencies and provided development opportunities for Members of the Partnership. Guardians had also been appointed to each of the seven subgroups of the Partnership. The Guardians provided leadership to the groups and confirmed the work plan and reported by exception to the Partnership on the progress made towards the Group's objectives.

Ahead of the new Children's Trust Statutory guidance and the Every Child Matters Plan Regulations being laid in April 2010, the decision to proceed with an additional one year refresh of the Lincolnshire Children's Plan would allow for an extended period of consultation to inform the three year re-write of the Lincolnshire Children's Plan 2011/14, aligning the plan to the Local Area Agreement and 14-19 Strategy.

#### 37. "<u>ONE FRIDAY NIGHT" – LINCOLNSHIRE ALCOHOL HARM</u> EDUCATION DVD PROJECT

Consideration was given to a report by Chris Avis, Lincolnshire County Council, and John Bustin, Lincolnshire County Council, which provided the Partnership with an opportunity to discuss the development of the recent Lincolnshire Alcohol Harm Education DVD Project.

Educational packs which were aimed at children and young people were provided to Members, for information. A DVD which was produced by children and young people, based on a television series called Skins, was also created. It was suggested that this should be shown 30 minutes prior to the Partnership's meeting scheduled to be held on 13 January 2010. It was also suggested that this should be raised at the Learner Provider Group, for information.
