Composition of the Schools' Forum Groups

- (a) School Members* (voting) (*Note:- the numbers of school members will vary as more Academies come on stream)
 - 1 guaranteed place for representative of maintained Nursery Schools;
 - 3 guaranteed places for maintained Primary school Governors being those with the highest number of votes in this category, and similarly;
 - 3 guaranteed places for maintained Primary school Headteachers;
 - 3 guaranteed places for maintained Secondary school Governors;
 - 3 guaranteed places for maintained Secondary school Headteachers, with the balance (i.e. 8 places) being filled by those governors or Headteachers with the next highest votes so that the final ratio of primary to secondary school to academy members is in the nearest integer ratio of the number of pupils in the two sectors;
 - 2 guaranteed places for Special schools, (one Governor and one Headteacher);
 - 1 guaranteed place for an Academy (this number will increase)
