Subject: **Appeal against the prioritisation of DMMO 377 –Long Bennington / Westborough & Dry Doddington – Claimed Public Footpath on the East Bank of River Witham.**

**Summary:**

An appeal against the prioritisation of DMMO 377 – Long Bennington / Westborough & Dry Doddington – Claimed Public Footpath on the East Bank of River Witham.

**Recommendation(s):**

That consideration is given to the appeal to upgrade the priority of the modification order cases.

## **1. Background**

As Surveying Authority the County Council has a statutory duty to keep under continuous review the Definitive Rights of Way Map and Statement for Lincolnshire and to make orders to take account of events requiring the map to be modified. This is carried out by the processing of Definitive Map Modification Orders (DMMOs) which are either applied for by the public or initiated by the Authority on the discovery of evidence.

Highways & Traffic Guidance Note HAT33/3/11 sets out that such cases will be dealt with in order of receipt/initiation unless one or more of the eight “exception criteria” apply.

The criteria are as follows:

1. Where there is sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce.
2. Where there is a significant threat to the route, likely to cause a permanent obstruction (e.g. a building, but not, for example, a locked gate or residential fencing).

3. Where there is, or has been, a finding of maladministration by the Local Government Ombudsman on a particular case and that in processing the case the County Council will discharge its duty to the Ombudsman's decision.
4. Where legal proceedings against the County Council are instigated or are likely to be instigated and it is possible that the Authority has a liability.
5. Where there is a risk to children on County Council owned property and land or where the claimed route would provide for a safer alternative route to a school, play area or other amenity for children.
6. Where there is a significant financial saving to the County Council (and therefore taxpayers) through the processing of an Order.
7. Where a new application is received that relies on evidence of a case already received or, if the new application forms part of or is adjoining to an existing claim, the new claim will be dealt with at the same time as the older application.
8. Where the route will significantly assist in achieving a Countryside and Rights of Way Improvement Plan Objective or Statement of Action.

A member of the public has appealed against the current priority of DMMO 377 being an application to add a footpath along the east bank of the River Witham in the parishes of Long Bennington and Westborough & Dry Doddington.

Appendix A is a brief case synopsis including the reasons for the appeal.

**Wildlife & Countryside Act 1981, Section 53  
Definitive Map Modification Order**

**LONG BENNINGTON / WESTBOROUGH & DRY DODDINGTON – CLAIMED  
PUBLIC FOOTPATH ON THE EAST BANK OF RIVER WITHAM.**

**1. Application**

A valid application under the Wildlife & Countryside Act 1981, section 53(5) from Mr I Angus has been received by Lincolnshire County Council and is dated 8<sup>th</sup> September 2014

**2. Location Plan of Route**

See *figs 1* of this Appendix

**3. Evidence in support of the application**

Accompanying the application for addition of a bridleway to the Definitive Map & Statement were 11 user evidence testimonies with a further 12 subsequent to the application indicating usage over a period between 1970 and 2014.

**4. Background**

The usage of the route was brought into question when the occupier erected notice under the Highways Act 1980 s.31(6) procedure concerning declarations as to what public rights of way exist on their land. The public noted that the route they had used was not include and wished to claim that it was a public right of way based on long usage.

Subsequent to the claim the occupier has closed the linking Winters Lane Bridge as it is in poor repair and the occupier does not wish to risk personal injury claims. It is fenced with 6' high metal palisade fencing.

**5. Current Priority & Original Officer Assessment**

Following receipt of the applications officer opinion was that none of the exception criteria applied to the application. The case is currently ordered at number 152 of 157 outstanding cases.

**6. Appeal**

An appeal has been received from the applicant, Mr I Angus (see Appendix B) wishing to pursue a change of priority relying on Criteria 1 and 8 of the above policy

*1) Where there is sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce.*

Mr Angus contends that the significant amount of usage is sufficient to demonstrate the depth of feeling within the community which was exacerbated when the occupier took steps to close off usage of the Winters Lane Bridge. The route had been regularly walked and local people have threatened to remove fencing to enable passage.

*8) Where the route will significantly assist in achieving a Countryside and Rights of Way Improvement Plan Objective or Statement of Action.*

Mr Angus contends that the route will form a natural circular walk benefitting the locals of Long Bennington as well as the economic centre. As the village is separated from the wider countryside to the west by the A1, opportunities for circular walks to the west are not available and to the east they are currently limited.

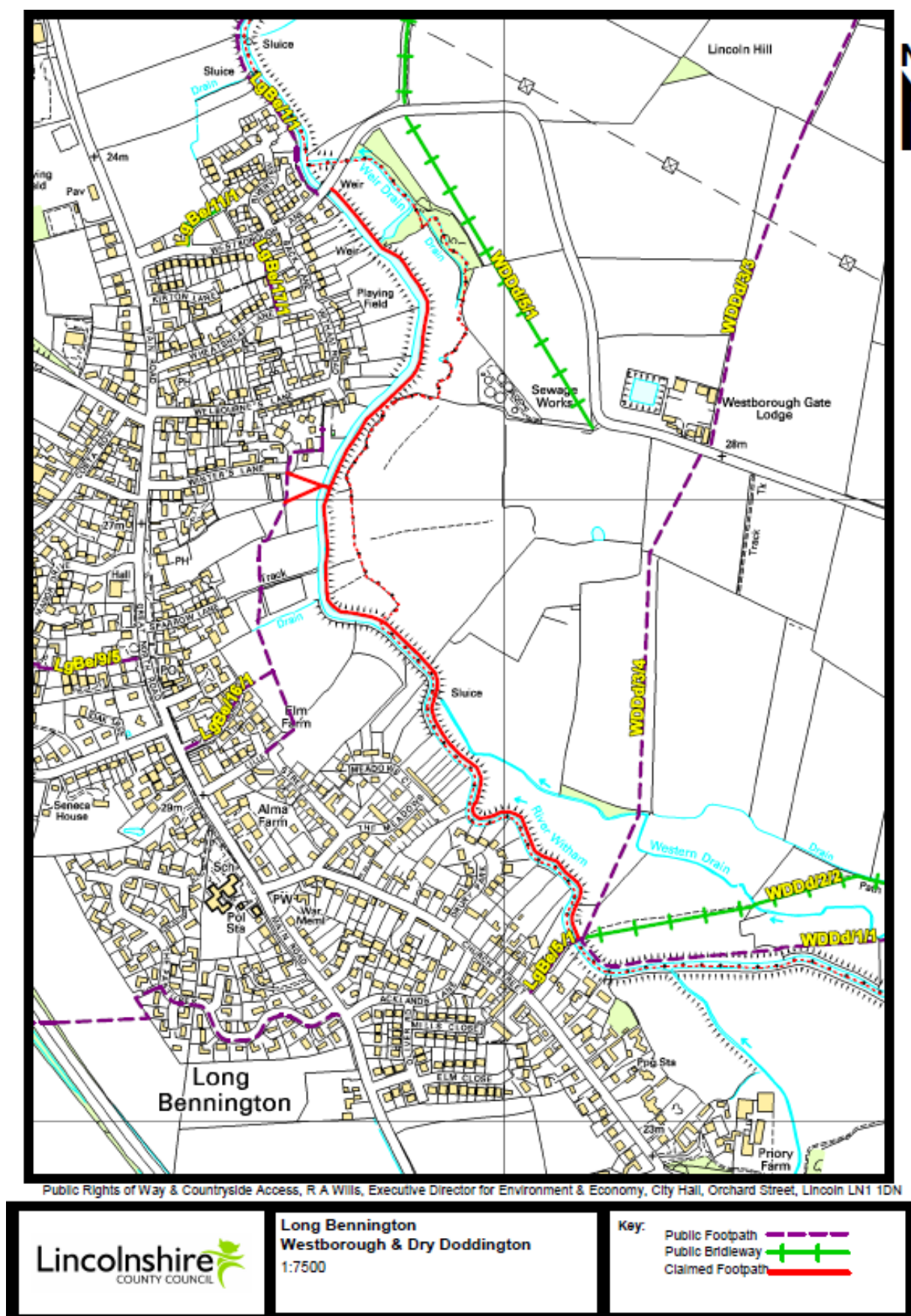
## **7. Site Visit**

The Countryside Access Manager, Chris Miller, will provide a verbal report with slides at the meeting.

The route generally follows the eastern bank top of the River Witham to the east of Long Bennington. Towards the northern end the claimed route is obstructed by a weir which on the time of inspection was unavailable to cross.

The section crossing the River Witham by way of the Winters Lane Bridge is obstructed by metal palisade fencing. Beyond this the path bifurcates to two routes each crossing the grass paddock to the west before meeting with Long Bennington Public footpath No.2

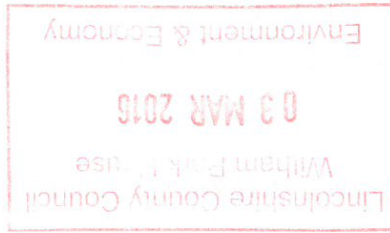

**Definitive Map Modification Order**

**Priority Application.**

Your ref: **DMMO 377**

River Witham riverside walk, Long Bennington.

It is requested that this application is advanced in the priority system.

The reasons for this are that, this walk has been used by the villagers, fishermen, walkers, runners and dog walkers since the 1960s when the bridge at Winters Lane was constructed.

The current owner Mr Geoffrey Fearn, has for some reason stated that "this walk is not used and therefore should not be granted" He has also stated that he will not take responsibility for the maintenance of the Winters Lane bridge, this has resulted in this bridge becoming risky to cross and has deterred a number of people from now using it. There has been no maintenance done on the bridge for over 20 years and as it is of wooden sleepers construction has gradually splintered and broken.

This bridge is an integral part of the walk as it makes the walk an accessible circuitous route for people of all ages.

On the 16th February 2016. The bridge was blocked off with no notification. This caused a number of users who had started their walk from Church Street to have to return to Church Street.

This has subsequently caused quite a bit of animosity with villagers and the Grantham Angling Association (GAA), they have a contract for the fishing rights on the stretch of water owned by Mr Fearn. There is an express or implied right of



access for the GAA which is only available across this bridge. Our understanding is that Mr Fearn has been happy to take the money for these rights but has not accepted his liability to provide safe access, by refusing to maintain the bridge.

As previously stated the general consensus from the villagers is one of disbelief that a well used and beautiful walk has now been denied them after decades of continued use. Whilst not condoning such proposals, some villagers have even discussed removing the blockade, such is the level of discontent.

With denied access to the Winters Lane Bridge this will significantly affect the route of this proposed application. Due to the north end of the walk having to cross the weir, this is entirely beholden on the level of the river. So there is no alternative route.

**Countryside Rights of Way Improvement Plan**

This application will also assist quite significantly in the Countryside Rights of Way Improvement Plan, as it is used by all ages for walking, bird watching, fishing, canoeing, cycling, running/ jogging and messing about in the river with the resulting health improvements associated with these activities.

The local economy is assisted as on the circuitous route two shops, a coffee shop and three public houses/ restaurants are available.

In conclusion should this application be advanced for approval it will alleviate the animosity currently being generated and give clarity to all parties. The matter of the bridge and its lack of maintenance is being referred to the Health and Safety Executive in order for them to assess the situation and the best way forward.
