

### **Action required**

- ICBs and their partner trusts have a duty to prepare a first JFP before the start of the financial year 2023/24 i.e.by 1 April.
- For this first year, however, NHS England is to specify that the date for publishing and sharing the final plan with NHS England, their integrated care partnerships (ICPs) and Health and Well-being Boards (HWBs), is 30 June 2023.
  - Systems have significant flexibility to determine their scope as well as how it is developed and structured. Legal responsibility for developing the JFP lies with the ICB and its partner trusts.
  - The approach should be determined by the ICB and its partner trusts but could involve
    working with people to understand how services can better meet local needs, developing
    priorities and gathering feedback on draft JFPs


