Appeal against the prioritisation of DMMO 379 – North

Subject: Ormsby - Claimed footpath between north end of PF 357 and

Summary:

An appeal against the prioritisation of DMMO 379 – North Ormsby – Claimed footpath between north end of PF 357 and metalled highway in the centre of North Ormsby

Recommendation(s):

That consideration is given to the appeal to upgrade the priority of the modification order cases.

1. Background

As Surveying Authority the County Council has a statutory duty to keep under continuous review the Definitive Rights of Way Map and Statement for Lincolnshire and to make orders to take account of events requiring the map to be modified. This is carried out by the processing of Definitive Map Modification Orders (DMMOs) which are either applied for by the public or initiated by the Authority on the discovery of evidence.

Highways & Traffic Guidance Note HAT33/3/11 sets out that such cases will be dealt with in order of receipt/initiation unless one or more of the eight "exception criteria" apply.

The criteria are as follows:

- Where there is sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce.
- 2. Where there is a significant threat to the route, likely to cause a permanent obstruction (e.g. a building, but not, for example, a locked gate or residential fencing).

- 3. Where there is, or has been, a finding of maladministration by the Local Government Ombudsman on a particular case and that in processing the case the County Council will discharge its duty to the Ombudsman's decision.
- 4. Where legal proceedings against the County Council are instigated or are likely to be instigated <u>and</u> it is possible that the Authority has a liability.
- 5. Where there is a risk to children on County Council owned property and land or where the claimed route would provide for a safer alternative route to a school, play area or other amenity for children.
- 6. Where there is a significant financial saving to the County Council (and therefore taxpayers) through the processing of an Order.
- 7. Where a new application is received that relies on evidence of a case already received or, if the new application forms part of or is adjoining to an existing claim, the new claim will be dealt with at the same time as the older application.
- 8. Where the route will <u>significantly</u> assist in achieving a Countryside and Rights of Way Improvement Plan Objective or Statement of Action.

The applicant for the modification order and others have appealed against the current priority of DMMO 379 being an application to add a footpath between north end of PF 357 and metalled highway in the centre of North Ormsby.

Appendix A is a brief case synopsis including the reasons for the appeal.

Wildlife & Countryside Act 1981, Section 53 Definitive Map Modification Order

NORTH ORMSBY – CLAIMED FOOTPATH BETWEEN NORTH END OF PF 357 AND METALLED HIGHWAY IN THE CENTRE OF NORTH ORMSBY

1. Application

A valid application under the Wildlife & Countryside Act 1981, section 53(5) from Mr & Mrs Cassen has been received by Lincolnshire County Council and is dated 12th November 2014.

2. Location Plan of Route




Fig.1. - Modern Electronic OS mapping




Fig. 2. – Extract from 1906 Ordnance Survey




Fig 3. – Location Map

See figs 1, 2 & 3 on pg. 2, 3 & 4 of this Appendix

3. Evidence in support of the application

Accompanying the application for addition of a footpath to the Definitive Map & Statement were 29 user evidence testimonies indicating usage over a period between 1936 and 2014. 13 of these users covered the statutory period of 20 years with a number of the other users contributing to usage within this timeframe.

Some documentary evidence including 1960s aerial photography, 1965 sale particulars and the original survey notes for the public rights of way in North Ormsby dated 22 November 1951

4. Background

Usage of the route was brought into question in 2014 when the Manor House was sold and new occupiers erected notices to the effect that the driveway was private land and that there was no right of way across or along it.

5. Current Priority & Original Officer Assessment

Following receipt of the applications officer opinion was that none of the exception criteria applied to the application. The case is currently ordered at number 151 of 154 outstanding cases.

6. Appeal

An appeal has been received from the applicants and other interested parties as well as 27 signatories to an accompanying petition to support the appeal, (see Appendix B with petition redacted) wishing to pursue a change of priority relying on Criteria 1 & 8

Appendix A – Case Synopsis – North Ormsby – Claimed footpath between north end of PF 357 and metalled highway in the centre of North Ormsby

- 1) Where there is sustained aggression, hostility and ill feeling within a community that is causing severe disruption to the life of that community, and that in processing the case early there is a strong likelihood that this will reduce.
- 8) Where the route will significantly assist in achieving a Countryside and Rights of Way Improvement Plan Objective or Statement of Action.

The appeal outlines that the matter has become a divisive issue within a very small community leading to threatening behaviour and the issuing of solicitors letters for the suing of trespass and that the actions of the landowners have limited opportunities for countryside access by segregating the hamlet from the rights of way network.

It is argued in the application that as PF357 stops short of the centre of the hamlet, the surveyors must have considered that the remainder of the through route was already maintainable public highway.

The appellants also note that the route is used by those from outside of the village undertaking longer circular walks in the belief that there is a continuation of PF 357 beyond its mapped limits. This is highlighted by the inclusion of the route in the published walk "The Lindsey Loop" devised by the Ramblers Association in 1983 and republished in 2004.

33 At North Ormsby, turn LEFT by the abandoned quarry buildings on your right to drop down the slope and then up again with the church (now a private residence) and soon, the Hall on the right. Where the good track swings right go STRAIGHT ON, up the slope on the finger posted path (FP357) with a fence and then a thicket on the right. Continue over the brow of the hill and drop down, between the legs of a double power pylon to the track crossing in front (BW105). Turn RIGHT along this track for 120 yards.

Go LEFT off the track, down the steps then DIAGONALLY right up the slope aiming for Wood Barn which is now reduced to rubble. Immediately beyond the barn, go LEFT uphill and, as you come to the crest, aim towards the tree tops in the distance. When you start to crest the rise, aim for a gap between a line of stunted bushes, that come in from the right, and a thicket where a finger post stands out quite clearly against the skyline.

Other links to the key concepts of the Rights of Way Improvement Plan include the linkages between the hamlet and sustainable transport modes on the A16 and for the ability of the local population and especially children to undertake walking contributing to the health and well being agenda.

WILDLIFE & COUNTRYSIDE ACT 1981 SECTION 53 DEFINITIVE MAP MODIFICATION ORDER APPLICATION NORTH ORMSBY, CLAIMED FOOTPATH BETWEEN THE NORTH END OF PUBLIC FOOTPATH 357 & METALLED HIGHWAY IN CENTRE OF NORTH ORMSBY.

We are approaching the third summer of deprivation of North Ormsby's Children: they are deprived of their safe access to the surrounding countryside, which offers the simple, healthy activities we would wish for any child.

Until May 2014 North Ormsby's children enjoyed these benefits, but the new owner & occupants of North Ormsby Manor claimed that there was no public right of way on the track past their garden.

In July 2014 North Ormsby village children, on the marked footpath to the south of the village, were chased & verbally abused, One was forced to return to his home (visible 100 metres away) via a circuitous & dangerous route on public roads. (see Evidence form).

Two families left the village in the months which followed, because the country life which they had hoped to give their children was denied to them, with threats of prosecution for trespass & physical obstruction. One family suffered severe financial loss, having to leave behind facilities which they had provided for their horse.

Tenants of the North Ormsby Estate had hoped for the owners' sympathetic approval of their efforts to keep walking with their children: the opposite was offered. In 2015 two families moved into the village with active & energetic children. The parents hopes of safe & healthy walks for their children never materialised:their status as tenants of the North Ormsby Estate made it impossible for them to use the footpath link to the designated footpath. Villagers are fully aware of the benefits of regular exercise. The objective of Natural England that accessible natural spaces should be available "within 300 metres of every home in England for exercise, relaxation & well-being" was enjoyed by the households in North Ormsby, until May 2014.

From the end of the public highway, in the centre of the village, an easily walked track took us out in to the "Area of Outstanding Natural Beauty" in which North Ormsby is situated. Healthy exercise, calming experiences, shared walks, with or without a dog, were available to young & old. (see Evidence form).

The distance & gradient of the path to the first hill top, south of North Ormsby ("Comcroft") are sufficiently gentle to allow families with children of all ages, even those in "buggies", to enjoy fine views of the Wolds, & the sea.

The environment has proved ideal for those children regularly offered foster care by one of the village families. With walks organised by the Duke of Edinburgh Award scheme, & charities, which have been routed into & out of North Ormsby, it could not have been easier to enjoy healthy & companionable exercise.

Family visitors will continue to come to North Ormsby, but find it hard to believe that familiar walks are denied them (see Evidence form). Walkers exploring the area are horrified at the "PRIVATE PROPERY NO PUBLIC RIGHT OF WAY" signs along such a short stretch of track, linking the village to the Public Right of Way network to the south. It has been described as "An invisible Berlin Wall, it's not very welcoming is it?". The "Silver Lincs Way" ought to be a pleasing attraction for the keen walkers visiting the area, but it is marred by the un-designated status on the Definitive Map of the short stretch of footpath into & out of North Ormsby.

The route out of North Ormsby to Louth provides links to the villages on the way, & the bus routes on the A16. (see Evidence form). As well as being attractive to tourists who might not want to walk too far, these links offer pleasant walks, predominantly off public roads, for villagers with practical needs: collecting or delivering their vehicles from local garages, walking to visit local friends, walking to the bus stop in Utterby, or to the polling station. The attempt in May 2014 to close the footpath into North Ormsby threatens the circular & linear routes which had previously been used.

The verbal threats of prosecution for trespass which have been directed at so many people were expressed in solicitors' letters to the signatories of the DMMO application (see appended letter) no further legal action has so far been taken by the owner of the Manor, while though she subsequently repeated the threats verbally to whilst attempting to block way with a large 4x4 vehicle on Monday 2nd March 2015.

The social fabric of our very small village, nineteen households in all, is being destroyed. Many of the safe & healthy activities of our children have been brought to an end since 2014. The casual meetings of neighbours out for a stroll have ended: spirits are low. The efforts of enthusiastic walkers, into & out of the village, to reach the footpaths & bridleways into the Wolds, to Louth & to the coast, are thwarted. Friends & family in neighbouring villages, & longer distance walkers, cannot walk into North Ormsby without anxiety: some no longer even try.

Please raise the priority of our D.M.M.O application made in November 2014. Little needs to be done "on the ground": there are no stiles or gates to be moved, no barriers to be lifted, the surface of the path is passable.
