# **Summary**

The Care Quality Commission (CQC) inspected Lincolnshire Partnership NHS Foundation Trust (LPFT) between 30 November and 4 December 2015. On 21 April 2016, the CQC published its summary report on LPFT, as well as a detailed report on each of the eleven service areas. The CQC's report on LPFT is attached at Appendix A. # 1. Background

#### Introduction

On 21 April 2016, the Care Quality Commission (CQC) published its reports following the comprehensive inspection of Lincolnshire Partnership NHS Foundation Trust (LPFT), which took place between 30 November and 4 December 2015.

The CQC rates services in five domains, which are referred to as Key Lines of Enquiry, which are safe, effective, caring, responsive and well led. There are four possible ratings: 'inadequate', 'requires improvement', 'good' and 'outstanding'. In addition there is also a single overall rating for the Trust. The findings for the Trust overall for each key line of enquiry are set out in the table below:

Overall, LPFT was rated as 'Requires Improvement'.
