The budget for the Coroners Service is demand led, and needs to have the flexibility to respond to the requirement to investigate deaths as appropriate. This may involve additional pathology tests and post mortems which are difficult to predict. During 2015/16 a full review of the mortuary contract was undertaken to ensure that best value was obtained from these arrangements, with a new contract implemented in September 2015 for post mortem and mortuary facilities. In 2012/13 a review of body removals was conducted with a new contract implemented 1 April 2013, this was reviewed with a new contract re-tendered in December 2016 for implementation in April 2017. However additional expenditure has occurred through complex and detailed Inquests, the number of post mortems, increased caseload and Deprivation of Liberty Safeguarding cases, although the latter have now reduced due to a change in the legislation.
