# Proposed changes to reporting performance against the Council Business Plan 2018/19

Discussion with the Executive Councillor is planned and an alternative measure will be proposed to replace Alcohol related violent crimes.

There were 907 incidents in Q1 against a target of 382, which is an increase in alcohol related violence of 125% compared withQ1 2017/2018 when 403 incidents were reported. The service has stated that this is likely due to a change in recording practices within the police. The change has seen more violent crime incidents

recorded and an increase in flagging of incidents where alcohol is a factor. As a result, the data is no longer comparable to previous quarters and the service recommends that this measure is removed from the Council Business Plan.


