Summary:

Approval is sought to award a contract for the main works for resurfacing works on the B1191 at South Drove, Martin.

Recommendation(s):

That the Leader of the Council approves the award of a main contract for the B1191 Martin, South Drove Primary Route Network (PRN) resurfacing scheme.

Reasons for Recommendation:

To allow the works to proceed and provide a serviceable, and safe, running surface for the travelling public.

1. Background

- 1.1 The B1191 at Martin has been assessed by Lincs Laboratory using a number of different techniques, including dynamic cone penetration tests for bearing capacity, surface coring and deflectograph to inform the treatment schedule that has been tendered. The results of the testing placed this particular site on this year's list of resurfacing priorities.

- 1.2 The condition and profile of the carriageway has deteriorated rapidly such that an emergency 40mph speed limit has been imposed to protect the safety of the road user.
- 1.3 The defects identified at this location are extensive material failures in the surfacing, coupled with surface deformation. The treatments derived from these defects will be from 110mm to 390mm of new surfacing. The deformation will be re-profiled to provide a level running surface. To help increase its strength and longevity, steel grid will be laid throughout supplemented by an additional layer of geo-synthetic grid laid deeper.
- 1.4 The proposals are to resurface a total of 960m of the B1191 by planing out the existing surface and replacing it with hot rolled asphalt.
- 1.5 Work will take place during daytime working hours from Monday to Friday. The option to work weekends exists if the contractor chooses. The road will remain closed all day every day until the work is complete. Access to properties will be maintained.
- 1.6 Traffic will be managed by road closures with signed suitable alternative routes which will be provided and maintained in serviceable condition.
- 1.7 The works are currently being tendered via Lincolnshire County Council's Select List Framework. The estimated cost of the works is £851,000.

- 1.8 The whole scheme costs are:

Costs incurred thus far

- Design fees - £23,500

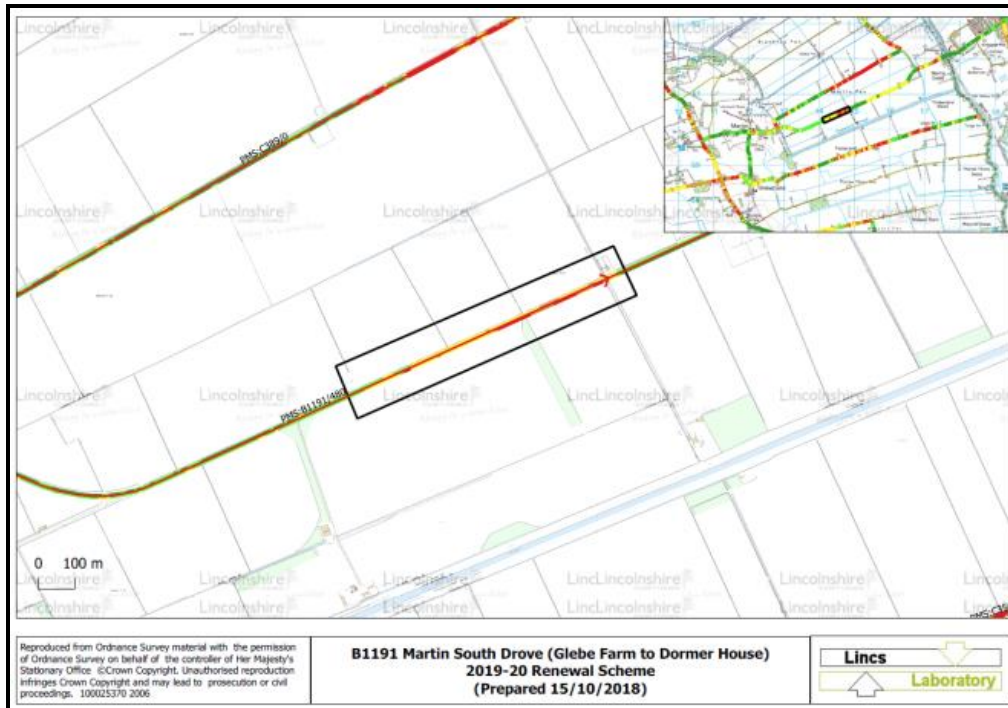
Projected additional costs

- Resurfacing contract - £851,000
- Supervision fees - £23,500
- Laboratory / final product testing costs - £19,000

TOTAL SCHEME COST - £917,000

- 1.9 The scheme will be funded from the 2020/21 Highways Asset Protection PRN Budgets.

2. Legal Issues:

Equality Act 2010

Under section 149 of the Equality Act 2010, the Council must, in the exercise of its functions, have due regard to the need to:

- * Eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under the Act.
- * Advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it.
- * Foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

The relevant protected characteristics are age; disability; gender reassignment; pregnancy and maternity; race; religion or belief; sex; and sexual orientation.

Having due regard to the need to advance equality of opportunity involves having due regard, in particular, to the need to:

- * Remove or minimise disadvantages suffered by persons who share a relevant protected characteristic that are connected to that characteristic.
- * Take steps to meet the needs of persons who share a relevant protected characteristic that are different from the needs of persons who do not share it.

The duty cannot be delegated and must be discharged by the decision-maker. To discharge the statutory duty the decision-maker must analyse all the relevant material with the specific statutory obligations in mind. If a risk of adverse impact is identified consideration must be given to measures to avoid that impact as part of the decision making process.

An Equality Impact Assessment has not been undertaken. This work is considered neutral in its impact on protected characteristics groups.

Joint Strategic Needs Analysis (JSNA and the Joint Health and Wellbeing Strategy (JHWS))

The Council must have regard to the Joint Strategic Needs Assessment (JSNA) and the Joint Health & Well Being Strategy (JHWS) in coming to a decision.

Consideration has been given to the JSNA and the JHWS and there are not considered to be any significant impacts on the health and wellbeing of the people of Lincolnshire.

Crime and Disorder

Under section 17 of the Crime and Disorder Act 1998, the Council must exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent crime and disorder in its area (including anti-social and other behaviour adversely affecting the local environment), the misuse of drugs, alcohol and other substances in its area and re-offending in its area.

The works outlined above are not considered to have an impact on Section 17 of the Crime and Disorder Act 1998 matters.

3. Conclusion

The results of Lincs Laboratory testing have placed the B1191 at Martin on this year's list of resurfacing priorities. This report seeks approval for the award of a contract for the carrying out of the necessary works.

4. Legal Comments:

The Council has the power to enter into the contract proposed.

The decision is consistent with the Policy Framework and within the remit of the Leader of the Council.

The works proposed in this paper are included in the programme of works funded by the Department for Transport Highways Asset Protection Grant and budgeted for in the Council's approved Capital Programme.
