3. Scrutiny Review Topics

At the Committee's last meeting following a discussion on potential scrutiny review topics, four subject areas were logged as potential areas, which might be developed into a scrutiny review at a later date. Set out below are the four items suggested. Most of these items are due for further consideration at forthcoming meetings, as set out below. As more information is reported, the Committee will be able to evaluate whether any of the topics would meet the guidelines for a scrutiny review:

Reducing Alcohol Harm Services

As set out in the performance report for quarter one of 2021/22 on this agenda, alcohol harm reduction services are provided by *We Are With You - Lincolnshire*, who also provide other substance misuse services.

<u>Performance Indicators for Carers</u>

The performance report for quarter four of 2020/21, which was considered at the Committee's last meeting on 14 July 2021, stated that owing to the Covid-19 pandemic data for the three performance indicators relating to carers could not be gathered during 2020/21. The three indicators were:

- Carers supported in the last twelve months
- Carers who said they had as much social contact as they would like
- Carers who have received a review of their needs

Elsewhere on this agenda is the performance report for quarter 1 of 2021/22, which includes measures for the above three indicators. In addition, the Committee is due to receive a report at its next meeting on 20 October 2021 on the procurement of services to support carers.

Safeguarding Adults

The County Council's responsibilities for safeguarding adults are set out in the Care Act 2014. These duties apply to any adult who:

- (a) has needs for care and support (whether or not the authority is meeting any of those needs).
- (b) is experiencing, or is at risk of, abuse or neglect, and
- (c) as a result of those needs is unable to protect himself or herself against the abuse or neglect or the risk of it.

At the Committee's last meeting there was presentation from the Lincolnshire Safeguarding Adults Board, with a further update scheduled for January 2022. Also, elsewhere on this agenda is the

Mental Health

Aside from the NHS which provides many mental health services, local authorities have a duty under the Care Act 2014 to assess the needs of any person whose needs are related to mental health services. In Lincolnshire this duty has been delegated to the Lincolnshire Partnership NHS Foundation Trust (LPFT) under an agreement in line with section 75 of the National Health Service Act 2006. The Committee is due to receive an item on mental health services at its December meeting.
