2. Rescheduling Agenda Items from 14 September 2022

Of the five substantive items on the agenda for 14 September 2022, two are being considered on this meeting's agenda:

- Ashley House Service Change (Item 5)
- Lincoln Medical School (Item 8)

One item, the update from North West Anglia NHS Foundation Trust, has been rescheduled to 18 January 2023. No earlier date can be programmed, because of the availability of the Trust's Chief Executive. The remaining two items, the Spalding GP Surgery Managed List Dispersal and the Lincolnshire Pharmaceutical Needs Assessment, were time critical, in the sense that they needed to be considered at the September meeting.

Spalding GP Surgery Managed List Dispersal

NHS Lincolnshire Integrated Care Board's public consultation closed on 9 September 2022, with the Committee previously given a dispensation to make its response after its planned meeting on 14 September. An informal response was prepared on behalf of members of the Committee, and submitted to NHS Lincolnshire Integrated Care Board on 23 September 2022.

The Committee is due to receive a report from NHS Lincolnshire Integrated Care Board at its next meeting on 9 November 2022, and as part of this item, the Committee will be able to consider some of the general issues raised as part of the consultation, such as the impact of increased housing development on GP practices; as well as ensuring overall pressures are handled.

<u>Lincolnshire Pharmaceutical Needs Assessment</u>

The Lincolnshire Pharmaceutical Needs Assessment (PNA) was approved by the Lincolnshire Health and Wellbeing Board on 27 September 2022. The consultation draft of this document had been considered by a working group of the Committee in May 2022, with the Committee's response to the draft approved on 15 June 2022. In view of this, it is proposed that no further consideration is required at this stage. 3. Membership – Healthwatch Lincolnshire

I confirm that Healthwatch Lincolnshire has advised that Mrs Liz Ball will be its representative on the Health Scrutiny Committee. This followed Dr Brian Wookey announcing that he would be standing down as Healthwatch's representative at the Committee's from 15 June 2022.

4. Care Quality Commission Inspection Report – Hawthorn Medical Practice Skegness

On 30 September 2022, the Care Quality Commission (CQC) published its inspection report on the Hawthorn Medical Practice, Skegness, following an inspection on 23 August 2022. Hawthorn has been rated as 'inadequate' overall and thus placed in special measures. The practice was rated as 'inadequate' for three of the five CQC's domains (safe; responsive to people's needs; and well-led). For the other two domains (effective and caring) the practice was rated as 'requires improvement'. The CQC has stated in its report that its main findings were:

- The practice did not always provide care in a way that kept patients safe and protected them from avoidable harm.
- There was no effective oversight of dispensary services that provided assurance as to its safety.
- Patients did not always receive effective care and treatment that met their needs.
- The practice had not taken reasonable steps to protect patients and others from the risks posed by healthcare associated infections.
- Staff dealt with patients with kindness and respect and involved them in decisions about their care.
- Patients could not access care and treatment in a timely way.
- The provider did not have effective oversight of the systems and processes designed to deliver safe and effective care.
- Governance systems were ineffective.
- Staff did not always have the training, supervision or appraisal required.

In accordance with the usual CQC approach, services placed in special measures will be inspected again within six months. If insufficient improvements have been made, the CQC states it will take action in line with its enforcement procedures to begin the process of preventing the provider from operating the service, leading the cancellation of their registration or variation of the terms of their registration.

As stated in the CQC's report the Hawthorn Medical Practice (operating in Skegness and Burgh Le Marsh) delivers services to a patient population of about 17,777, which is strikingly different from the Lincolnshire and England averages: it has a higher number of patients aged 65 and over; a higher deprivation score; higher numbers of patients with long-term conditions; and lower numbers aged 18 and under. Because of this, the practice population is weighted to 22,958 to reflect these patient demographic needs.

The plan is that the ICB's response to this report, including its support for the practice, will be considered by the Committee on 9 November 2022.

5. Humber and Lincolnshire Joint Health Overview and Scrutiny Committee

On 16 May 2022, the Humber and North Yorkshire Health and Care Partnership (on behalf of the Humber Acute Services Programme Team) wrote to the chief executives of five local authorities, including the Chief Executive of Lincolnshire County Council, seeking the establishment of a joint health overview and scrutiny committee to consider hospital reconfiguration proposals in the Humber area. The other four local authorities in receipt of the letter were the East Riding of Yorkshire, Hull City, North Lincolnshire and North East Lincolnshire.

In response to the letter, the meeting of Lincolnshire County Council on 27 September 2022 approved its participation in the Humber and Lincolnshire Joint Health Scrutiny Committee, for the purposes of formally responding to any substantial reconfiguration proposals arising from the Humber Acute Services Programme. The County Council appointed three members to the new Joint Committee: Councillors Carl Macey, Tom Smith and Stephen Bunney.

A previous arrangement to respond to the Humber Acute Services programme, using the Humber and North Yorkshire Joint Health Overview and Scrutiny Committee, which was report to this Committee in May, has been superseded.

6. Lincolnshire Integrated Care Partnership

The first meeting of the Lincolnshire Integrated Care Partnership (ICP), which is a joint committee of the NHS Lincolnshire Integrated Care Board (ICB) and Lincolnshire County Council, took place on 27 September 2022. As well as representatives from the ICB and the County Council, ICP has one representative each from NHS England, Healthwatch Lincolnshire, the Office of the Lincolnshire Police and Crime Commissioner; Lincolnshire Police; Lincolnshire district councils; the three Lincolnshire-based NHS providers; the Lincolnshire Primary Care Network Alliance; the Greater Lincolnshire Local Enterprise Partnership; the higher education sector; and the voluntary and community sector.

On 27 September ICP appointed Councillor Sue Woolley as its chair; and John Turner as its vice chair. The ICP's business also included approval of its approach on the development of Lincolnshire's interim Integrated Care Strategy, which is due to be considered by this Committee on 14 December 2022. The ICP will be meeting quarterly, with its next two meetings on 6 December 2022 and 28 March 2023.

7. Secretary of State and Ministerial Appointments

8. Policy Paper – Our Plan for Patients

On 22 September 2022, the Secretary of State for Health and Social Care launched a policy paper entitled: *Our Plan for Patients*. The policy paper, which is available at <u>Our plan for patients - GOV.UK (www.gov.uk)</u>, includes commitments on:

- providing transparent data on local NHS performance, which is clear to patients;
- moving prevention services, such as mobile breast screening, closer to patients;
- expanding mental health support for children at school;
- setting an expectation that everyone should get an appointment at their GP practice within two weeks;
- prioritising patients with urgent needs so that they get a same day appointment with their GP;
- requiring integrated care boards to hold their GP practices to account;
- publishing data on appointments provided by each GP practice;
- improving ambulance response times, by reducing hospital handover delays;
- supporting patients to be directed to the most appropriate service, such as an urgent care centre;
- supporting local falls prevention services;
- accelerating the hospital building programme;
- recruiting 50,000 more nurses by 2024;
- further expanding the network of community diagnostic centres;
- launching a new community pharmacy offer;
- integrated care boards will be held to account for the provision of dental services in their area; and
- reviewing the pension rules affecting NHS staff.

9. Annual Public Meetings of Local NHS Bodies 2022

NHS organisations (including the newly established NHS Lincolnshire Integrated Care Board) are required to hold an annual public meeting, at which the achievements from the previous year and plans for the coming year are highlighted.
