Summary:

Thunderstorms and heavy rainfall moved across England during 16 and 17 August 2022 with torrential downpours causing widespread flooding and problems in many areas, with some places experiencing twice the month's average rainfall in this short period. This led to commissioning of seven S19 Investigations. An update on the Greater Lincolnshire Groundwater Project was shared. The completion of flood alleviation works at Scothern was reported ahead of schedule, with roads opened up on 2 September 2022.
