Summary:

	Item	Summary of Outcomes		
1	Day Opportunities Update	This item included the <i>Living Life to the Full</i> plan, and the Committee was supportive of the new service structures and innovative ways of working in the plan, such as links between day services and local drama groups. A series of visits by local members of the Committee to their nearest centre would be planned and there would be a further update in September 2023.		
2	Better Care Fund (BCF)	The Lincolnshire BCF Plan for 2021/22 covered total funding of £279 million. This included funding from the NHS Lincolnshire Integrated Care Board, the County Council, the improved Better Care Fund and Disabled Facilities Grant funding. The Committee welcomed the impact and planned outcomes of the Better Care Fund in supporting the partnership working of health and social care services.		
3	Procurement of Active Recovery Beds – Winter 2022/2023	ry 31 March 2023, which would support the discharge arrangements		
4	Performance Report Quarter 2: 2022/23	The Committee noted that fourteen out of the eighteen measures reported for quarter two had either met or exceeded their target. The rationale for the other four measures not meeting their target was reported and accepted by the Committee. In one measure, it was reported that an increase in contacts to the customer service centre had reflected a national trend, where people were seeking advice from their councils on adult social care.

1	Adult Care and Community Wellbeing Budget Proposals 2023/24	The Committee supported the budget proposals and acknowledged the pressures on the budget such as inflation and increases in demand for services, as well as the risks. As part of its comments to the Executive, the Committee welcomed the continuing emphasis on preventative services, which had the potential to reduce demand for other services and in turn leads to savings across the public sector.		
2	The Director of Public Health's Report 2022: The Diverse Communities of Greater Lincolnshire	As part of the Committee's consideration of this item, topics such as different levels of service provision for different communities across Greater Lincolnshire; the impact of a concentration of fast food outlets in certain areas; the negative health impact of social isolation; and the importance of access to local NHS primary care services throughout the county were explored.		
3	Substance Misuse Treatment Performance	Following a previous request, details on the performance of the substance misuse treatment service, currently provided by <i>We Are With You</i> , were presented. The Committee's views were recorded on the importance of educating young people on the risks of drugs and excessive alcohol as part of a preventative approach; the level or successful 'completions' from the treatment; and the recruitment and training of staff working in the service.		
4	De Wint Court, Lincoln, Extra Care Housing Scheme Update	As well as a focus on the success of De Wint Court, Lincoln, which had opened in February 2022, this item included an overview of the Extra Care Housing and Supported Living Programme, including its live projects; and future opportunities for the programme. The Committee commended both the Executive Councillor – Adult Care and Public Health and the Senior Project Manager – Corporate Property for their work on the programme.

Reducing Suicide and Mental Health Working Group

The Reducing Suicide and Mental Health Working Group, which comprises Councillors Carl Macey, Sarah Parkin, Tom Smith, Mark Whittington and Angela White (West Lindsey District Council) has met on three occasions and received information from the County Council's Public Health team on Lincolnshire's Suicide Prevention Strategy, and Lincolnshire Partnership NHS Foundation Trust (LPFT) on a range of mental health services.

A report from the working group will be submitted to the Committee on 15 March 2023, in which items for consideration by the full Committee will be suggested, such as exploring support for people (of all ages) with mental health issues in primary care; access to core services such as *Steps2Change*; and managing the transitions from one LPFT service to another.

Humber and Yorkshire Joint Health Overview and Scrutiny Committee

Lincolnshire County Council agreed to participate in the Humber and Yorkshire Joint Health Overview and Scrutiny Committee on 16 September 2022, and appointed Councillors Carl Macey, Tom Smith and Stephen Bunney as its three representatives. The other four councils, (each appointing three representatives) are the East Riding of Yorkshire, North Lincolnshire, North East Lincolnshire and the City of Hull.

The focus of the Joint Committee will be responding to the consultation on the Humber Acute Services Programme, which will include options for the future configuration of NHS services at Diana Princess of Wales Hospital in Grimsby, and Scunthorpe General Hospital. Several options are being developed, which in each case would see a loss of NHS services in either Grimsby or Scunthorpe: with one of these hospitals becoming a 'local emergency hospital' rather than remaining as an 'acute hospital'. Not only would such proposals impact on Lincolnshire residents, it would also put pressure on United Lincolnshire Hospitals NHS Trust.

The consultation will not be launched prior to the local government elections on 4 May 2023, which affect the other four local authorities represented on the Joint Committee. In advance of this, there has been a suggestion from the NHS for a meeting of the Joint Committee prior to the election period to discuss the NHS's arrangements for the consultation plan. This offer is under consideration. It should be noted that there is an argument for the Joint Committee not to meet prior to the launch of the formal consultation period, so that its views would not be prejudiced by any earlier consideration. Irrespective of the activities of the Joint Committee as the statutory consultee with the NHS, the Health Scrutiny Committee will be planning to consider and make its own response to the consultation.
