Summary:

	Item	Summary of Outcomes	
1	Acute Hospitals – Admission to Discharge Care Pathway	The Committee considered an overview of the acute hospital discharge processes, which focused on three pathways: (i) active recovery beds, which are temporary specialist beds in care homes; (ii) the discharge to assess pathway, which includes home-based assessment; and (ii) the discharge re-ablement service, which provides an enhanced level of support to patients discharged from A&E. Schemes (i) and (ii) facilitated the timely discharge of 'medically fit' patients, while (iii) aimed to prevent to admission. All schemes released acute hospital beds for those who needed NHS treatment.	
		The Committee welcomed the extension of the active recovery bed scheme - launched as a temporary measure in December 2022 - for a further year and was pleased that all the schemes were contributing to better outcomes for patients.	
	Sexual Health	Following a review of the existing service arrangements, the service model for sexual health would be refined to reflect the latest national requirements; with the contract including pharmacy-based emergency hormonal contraception; an increased focus prevention and health promotion, as well as a digital offer.	
2	Services Re-Commissioning – (Decision by Executive on 3 May 2023)	The Committee supported the seven recommendations to the Executive on the recommissioning of this statutory service, which is the responsibility of the County Council. The Committee highlighted several considerations, for example, the negotiations with NHS England on a section 75 agreement not representing a financial risk. The Committee welcomed the proposed new structure whereby the integrated sexual health services provider becomes responsible for managing pharmacy sexual health provision.

3	Community Supported Living for Working Age Adults at Grange Farm, Market Rasen (Decision by Leader of the Council and the Executive Councillor for Adult Care and Public Health on 14 April 2023)	The Committee strongly supported the development of a community supported living scheme at Grange Farm in Market Rasen. This scheme will involve a capital contribution of £800,000 by Lincolnshire County Council to ACIS, a registered charity and specialist housing provider, to support the development of Grange Farm, which is a large grade II listed building and a short walk from Market Rasen town centre. In return, the Council will receive nomination rights for thirty years on ten units, through a process of first refusal with no void risk. This would provide accommodation for working age adults with learning disabilities, mental health illness or physical disabilities. Depending on planning approvals, the scheme would be completed by the summer of 2024.

	Item Summary of Outcomes		
1	Urgent and Emergency Care	The Committee reviewed NHS winter planning; co-ordination between partners; pre-hospital care; ambulance handovers; discharge and flow in hospitals; and urgent treatment centres. The Committee welcomed all the initiatives improving urgent and emergency care for patients, including the new resuscitation unit at Lincoln County Hospital; and improvements in the discharge and flow of patients.	
	Update	The Committee also considered the minor injuries unit at Stamford and Rutland Hospital. As 'minor injuries unit' is no longer an accepted NHS service designation, the local NHS is looking at the future of the unit. The Committee has put on record that it would wish to see public consultation on this issue.	
2	Lincolnshire NHS People Strategy for Recruiting and Retaining Talent The Lincolnshire NHS's People Board oversees initiatives aimed at promoting the recruitment and retention of NHS staff. The Committee recognised the progress that had been made and looked forward to further progress in the coming year, with ar update in one year's time.		
3	Quality Accounts	The Committee established a working group to review the draft quality accounts (annual reports on the quality of care and treatment) of four NHS providers: (i) the East Midlands Ambulance Service NHS Trust; (ii) Lincolnshire Community Health Services NHS Trust; (iii) Northern Lincolnshire and Goole NHS Foundation Trust; and (iv) United Lincolnshire Hospitals NHS Trust.

1	Joint Strategic Needs Assessment for Lincolnshire	The Committee received a presentation on the new joint strategic needs assessment (JSNA) for Lincolnshire, which is available on the Lincolnshire Health Intelligence Hub. The JSNA is now based on a life course approach, as opposed to the previous topic-based structure. The new approach is based around three chapters: <i>Start Well; Live Well;</i> and <i>Age Well.</i> The Committee noted the publication of the Lincolnshire JSNA, and looked forward to using it to support future scrutiny activity.	
2	Joint Engagement Approach – Joint Health and Wellbeing Strategy and Integrated Care Strategy The Committee supported the Health and Wellbeing Board's and Integrated Care Partnership's joint engagement approach for the review of Lincolnshire's joint health and wellbeing strategy and Lincolnshire's integrated care strategy. The Committee also supported the methodology for identifying priorities for the strategies from the new joint strategic needs assessment. The Committee will be considering the strategies in November 2023, prior to their approval in December 2023.		
3	Report of the Suicide Prevention and Mental Health Working Group	The Committee approved the recommendations from its suicide prevention and mental health working group. Firstly, the Committee has requested that Lincolnshire's suicide prevention strategy, due for review during 2023, should include more support for people (and their families) who have attempted suicide. Secondly, the Committee is programming future agenda items on: (a) mental health support for patients in GP practices, including dedicated mental health roles in primary care; and (b) developments in secondary care mental health services, including progress in the reduction of waiting times.
