#### **Summary:**

Business Lincolnshire Growth Hub Annual Performance and Future Business Landscape	Six of the ten local authorities in the Greater Lincolnshire Local Enterprise Partnership (LEP) had opted into a new model of business support. Boston Borough, East Lindsey and South Holland had decided to deliver a local advisory service. The Committee stressed the importance of information sharing between the local authorities; and was assured the Growth Hub would continue to support all local authorities to ensure support for Lincolnshire businesses. The Committee recorded its satisfaction with the Growth Hub's performance.	
Broadband Programme – Interim Update	The update to the Committee included reference to the delivery of ultrafast broadband to 4,900 rural premises between December 2023 and 31 March 2024, as part of project gigabit. In addition, project GigaHub would deliver full fibre connectivity to 62 publicly owned rural buildings such as schools, GP surgeries and emergency services facilities. In response to questions, the Committee was assured that the east of the county was a strong focus for the broadband improvements. The Committee noted the information presented and the comments made would be drawn to the attention of the relevant executive councillors.

Members pointed that recycling at HWRCs was at 73% and therefore below target and emphasised on the need to reinforce the message around what items can and which cannot be recycled to save residents time and costs traveling to HWRC with items that cannot be disposed appropriately. Members also called for greater level of detail in reports around recycling rates (e.g., categories such as paper, plastic, green waste etc.) and more detail in terms of rates by district.
