| Subject: | Academies and Trust Update |

Summary:

The purpose of this report is to provide information on the latest number of academies and pupils in academies, and academy trusts.

Recommendation(s):

The Schools' Forum is asked to note the contents of this report.

1. Background

The Schools' Forum asked for an update to be provided to each meeting on the number of academy conversions.

This is the position as at the 1 January 2024. The pupil figures are based on the October 2023 census data (i.e. the latest published). The national academy trust data is the latest available from "Get Information About Schools".

Since the effective date of the last report (1 June 2023) one school has converted to academy status. Spalding Monkshouse Primary Academy is a converter academy and joined the University of Lincoln Academy Trust on 1 January 2024. This means that 42.7% of primary schools in Lincolnshire are now academies and that 53.7% of primary aged pupils attend academies.

Since the last report, the date for Wrangle Primary School to become an academy and join University of Lincoln Academy Trust has been postponed until 1 February 2024. Digby Church of England School, Willoughby St Helena's Church of England Primary School, and Cowbit St Mary's (Endowed) Church of England Primary School have still not yet had trusts appointed. Skegness The Richmond School is to join the David Ross Education Trust.

Infinity Academies Trust now has ten academies with Long Bennington Church of England Academy joining the trust on 1 October 2023. The University of Lincoln Academy Trust now has six academies, with the addition of Spalding Monkshouse Primary Academy.

There are now thirty-six active multi-academy trusts operating within Lincolnshire and a total of 154 Lincolnshire academies that are members of multi-academy trusts. This represents 81.1% of all Lincolnshire Academies. Thirty-six (18.9%) of Lincolnshire academies are single-academy trusts and are not members of multi-academy trusts. Nine multi-academy trusts have just one Lincolnshire academy as a member; three of these are single Lincolnshire academy multi-academy trusts. The other five also have academies that are not within Lincolnshire. Six multi-academy trusts have two academies; three of these trusts are currently based entirely within Lincolnshire. There are forty-six academy trusts in Lincolnshire that have less than four schools, including single academy trusts.

Delta Academies Trust has become the second largest national trust operating in Lincolnshire, through the addition of Lincoln Castle Academy on 1 December 2023. The other largest academy trusts nationally that operate within Lincolnshire are Academies Enterprise Trust (fifty-seven Academies, two in Lincolnshire), Greenwood Academies Trust has thirty-seven academies, seven in Lincolnshire, The David Ross Education Trust has thirty-four, eight within Lincolnshire and Our Lady Of Lourdes Catholic Multi-Academy Trust has four Lincolnshire Schools and has 32 academies nationally

3. Consultation

a) Risks and Impact Analysis

The academy conversion process is fully understood and has been in place for a number of years. There are services funded by the number of maintained school pupils (e.g. de-delegation services). Future anticipated funding levels are considered through the annual detailed budget setting exercise.

The actual split between Local Authority maintained and academies has no financial risk to the Council from the Dedicated Schools Grant schools delegation budget perspective.
