Subject:	Clinical Commissioning Group – Annual Reports and Accounts 2013-2014

Summary:

This paper provides information to the Health Scrutiny Committee on the four Annual Reports and Accounts of the Clinical Commissioning Groups in Lincolnshire. Members of the Committee may wish to focus on the patient-focused elements of the Annual Reports and Accounts, in particular the Annual Report or Reports relevant to their own particular areas. The patient-focused elements of the Annual Reports could be used to inform the Committee's work programme.

1. Background

Annual Reports 2013-2014

Each Clinical Commissioning Group (CCG) is required to prepare an Annual Report and Accounts. The content of a CCG's Annual Report and Accounts is determined by the Health and Social Care Act 2012 and detailed guidance from NHS England, which includes a requirement to publish the document no later than 13 June 2014.
